MICHIGAN

Michigan has a fairly straightforward jurisdictional history. When the Michigan Territory won statehood in 1837,¹ it was organized as a single district with full federal jurisdiction.² In 1863, it was divided into the Eastern and Western Districts, each with one judge.³

MI.ED.01 is the original judgeship (see Judge Wilkins' succession line), and served the entire state until the 1863 reorganization. MI.ED.02 was authorized as a temporary position in 1922, and converted to permanent in 1935.⁴ MI.WD.02 also was created as a temporary slot, with the proviso that the next vacancy on the court would not be filled. When Judge Sessions (MI.WD.01.06) died in office in 1931, his line ended and MI.WD.02 effectively became the permanent one. MI.WD.06 similarly was authorized as a temporary position in 1990, with the stipulation that the first vacancy to occur five years after the date of the statute would go unfilled.⁵ This happened in 1996 with the retirement of Judge Gibson, at which point his line (MI.WD.05.01) ended.

Michigan is in the Sixth Circuit and has nineteen judgeships: fifteen in the Eastern District and four in the Western.
