Judicial Officer Comments

When the Receiver makes a request for permission to pay out assets under the Receiver's control, the order granting permission is an interim order, not a final judgment. See Johnson v. Superior Court, 68 Ariz. 72, 199 P.2d 827, 830 (1948). Rule 60 therefore does not limit the Court's authority to vacate the order approving Petition No. 142.

The Court's view is that the the question whether, and to what extent, it is prudent to distribute receivership assets to the victim creditors, at any given time, is primarily a matter for the Receiver's judgment. The Receiver avers that, in his judgment, the appropriate course of action at this time in light of the possible fee award is to refrain from making the distribution requested in Petition No. 142. The Court has no good reason to second-guess that decision.

The Court has intentionally delayed entering this order to allow time for objections. No response or objection to the Motion has been filed.

The Motion to Vacate Order Re: Petition No. 142 is granted for these reasons.
