- 12/2/21 Continental Paving addressed some water infiltration issues at 107, 121 and 129 Perimeter Road.
- 12/3/21 A request for an IFE was sent to Montgomery Consulting for the upcoming project, Rehabilitate Golf Ramp and Foxtrot Ramp, SBG-12-26-2022 and was received today, 12/15/2021.
- 12/3/21 Chairman Woods and I met with representatives from the FAA, NHDOT BoA and Gale Associates to discuss the plan to relocate Taxiway 'A'. This project was previously denied and subsequently replaced by a Rehabilitate Taxiway 'A' in place project.
- The NH DOT BoA completed our annual 5010 Airport Safety Inspection.
- There are two T-Hangars for sale at ASH; 109-24 Perimeter Road and 17-1 Perimeter Road. Also, community hangar rental is available from Nashua Jet Aviation and Infinity Aviation.

AIRPORT ENGINEER'S REPORT

Nik Ippolito appeared on behalf of the airport's engineering consultant, Gale Associates, Inc.

CONSTRUCT ONLY - Pavement Maintenance Phase II (NHDOT No. SBG 12-21-2020)

This Project is to reconstruct taxilanes between hangars located on the north-west side of the Airfield (Runway 14 end.)

Project Status:

- Gale has not received the approved Change Order No. 2 from NHDOT/BA. Until this is received, we are unable to close out this grant.
- Gale has submitted an additional Reimbursement Request for the outstanding AR related to this Project. The reason for this additional reimbursement is to collect outstanding fees without needing to wait for the final closeout.
- Gale will be issuing the credit to the NAA and NHDOT/BA in January of 2022.

Recommended Actions:

Please sign the final RR and closeout documents upon receipt.

REHABILITATE TAXIWAY 'A' AND ASSOCIATED TAXIWAYS

This Project is for the design and construction phases necessary to rehabilitate Taxiway 'A', install new taxiway edge lighting (MITLs), and to address the grading issues at the intersection of Taxiway 'A' and Taxiway 'D'.

Project Status:

- Gale and the NAA received notification from NHDOT/BA that FAA does not have enough
 discretionary funding to support the rehabilitation of Taxiway 'A' as a FY2021 grant. NHDOT/BA
 offered a FY2021 grant to fund the design portion of this Project, with the suggestion that FAA
 would support a "Construct-Only" grant in FY2022.
- Gale's recommendation is to apply for the "Design-Only" grant immediately to recover the design fees associated with this project.
- Gale has provided language to the NAA for the release of Sargent Corp. from their Contract. This
 letter will need to be put on NAA letterhead and sent to the Contractor signed by the NAA
 Commission Chairman. Once this is complete and depending on the final decision from the
 FAA/DOT on relocation of Taxiway 'A', we can move forward with the appropriate preparations.

REHABILITATE GOLF RAMP AND FOXTROT RAMP

This project is for the design, and construction necessary to rehabilitate Golf and Foxtrot Ramps at the Airport.

Project Status:

- Final IFE documents have been provided to the NAA. Once the independent fee estimate is
 received, it can be compared to Gale's fee proposal. If the IFE and Gale's fee are within 10% of
 each other, this is generally considered acceptable to the agencies.
- 95% design is progressing, we anticipate an early February bidding of this Project.

Recommended Actions:

Once received, please review the IFE and compare it to Gale's fee proposal.

NEW BUSINESS

E1442 - 7 Perimeter Road — Discussion regarding renegotiating lease terms and conditions for lease extension. A previous NAA Board approved the lease extension in March of 2016 with the terms to be negotiated. At that time, the approved lease extension was not recorded with the Hillsborough Registry of Deeds.

MOTION BY Director Joe Duquette to do an administrative clean up to record the lease extension for E1442 (7 Perimeter Road) previously granted in March 2016 with the terms and conditions to remain the same. **SECONDED BY** Secretary Holland

E1443 Nashua Aviation Associates II – Discussion to exercise option to extend lease granted to the Nashua Aviation Associates II in 2004. Mr. Houde would also like the option to extend the lease for an additional twenty years with terms and conditions subject to renegotiations.

MOTION BY Chairman Woods to extend the lease for E1443 - Nashua Aviation Associates II for an additional 20 years under current term and conditions to expire on the 31st day of December, 2041 and also offer them the option to extend the lease for another twenty years with terms and conditions to be subject to renegotiations.

E1444 Nashua Aviation Associates III – Discussion to exercise option to extend lease granted to the Nashua Aviation Associates III in 2004. Mr. Santana would also like the option to extend the lease for an additional twenty years with terms and conditions subject to renegotiations.

MOTION BY Director Duquette to approve the request for the final lease extension for E1444 Nashua Aviation Associates III for an additional 20 years commencing January 1, 2022 to expire on December 31, 2041 and also approve the option for an additional twenty years lease extension with terms and conditions to be subject to negotiations.

E1483 Associates, LLC – Atty. Shane McLaughlin discussed his option to extend the current lease which expires on October 1, 2023. Atty. McLaughlin would also like to have the option to extend this lease for an additional twenty years which would expire on September 30, 2063.

Atty. McLaughlin also mentioned the following during a discussion regarding the "20 year lease extensions subject to renegotiation of terms and conditions". The land lease for 19 Perimeter Road lease is essentially a "Drop Dead" lease in 2023; therefore, the statement "subject to renegotiations of terms and conditions" is ambiguous because the parties may not agree on terms and conditions. This can make it difficult for potential buyers to obtain financing, financial underwriters require a "marketable title" and financial underwriters cannot rely on future NAA boards. He requested the board give this statement some thought.

MOTION BY Director Duquette to approve the request to extend the lease which expires September 30, 2023 for E1483 - 19 Perimeter Road for 20 years with the option for an additional twenty year extension commencing on October 1, 2043 with the terms and conditions to be subject to negotiation and would expire on September 30, 2063.

E1486 Lease - Charron Ave Car Wash. A new land lease for the parcel E1486 located at the back side of the car wash on Charron Ave has been created. There was an avigation easement given in perpetuity; however, this lease has expired June 4, 2021. The tenants have reviewed and agreed to the new lease.
