

Fountain history: From lackluster to showpiece

The beautiful fountain entrance that currently welcomes residents and their guests to Villa Monterey wasn't always so, recalls Kate Evans, whose family has owned their home on Hazelwood since 1963. In the early years, then-residents saw only a roundabout of grass and a large square structure with a blue-tiled border and empty saucer in the middle.

"Many residents found it most unattractive and thought it was unfinished by the developer," Kate wrote. "It became an ongoing topic of discussion and concern of various Board members for many vears."

In the 1980s, Board members had heard enough! Larry Landsman, Ernie Morrison, and Kate – with photo in hand—went to a Phoenix stone company on a mission to solve the entry problem. With help, they selected 4 separate stone pieces that when assembled and installed would become the working water fountain we admire today.
