1. RECORDED SEPARATE DEED & MEET ALL OTHER APPLICABLE LAND DEVELOPMENT REGULATIONS.
2. LOT SHALL BE AT LEAST ONE HALF (1/2) ACRE IN SIZE.
3. PROVISIONS SHALL APPLY ONLY ONCE TO ANY INDIVIDUAL.
4. COMPLIES WITH ALL OTHER CONDITIONS FOR PERMITTING DEVELOPMENT AS SET FORTH IN THESE LDR'S.
