- You may pay the amount due to the Clerk's office in person between 9:00 a.m. and 4:00 p.m. Monday through Friday, except holidays, at any of the court locations listed on the back of this form. You may mail a cashier's check or money order, made payable to Clerk of County Court, to Parking Violations Bureau at 22 N.W. 1st Street, 4th Floor, Miami, Florida 33128-1847. Do not mail cash. You can pay with Visa or MasterCard by calling (305) 275-1133 or at www.miami-dadeclerk.com. Bring this notice with you or mail a copy with your payment to receive proper credit. If you need a release of your registration, add \$7.00 to the amount due and provide a self-addressed stamped envelope. If paid in person request the certificate from the clerk.

- You may request administrative review by appearing in person on or before the due date at the Parking Violations Bureau, 22 N.W. 1st Street, 4th Floor, Miami, FL, between the hours of 9:00 a.m. and 4:00 p.m. Monday through Friday, except holidays; however, you will be required to post a cash bond to prevent issuance of the impoundment and immobilization order and referral to a collection/credit reporting agency.
