### Members Meeting Cancelled; Annual Report, Ballot Enclosed

Dear Friends,

A month ago the Schuyler County Historical Society was well underway with plans for several upcoming programs, including our SCHS Annual Meeting in April and celebration of our 60th anniversary. As you might expect, we were looking forward to sharing our programs and our accomplishments from the past year with you, our members and supporters.

Then something happened, an unimaginable global pandemic arose as if pulled straight from the history books. The Spanish Influenza of 1918-19 resonates closely with what our global community is now coping with on a day-to-day and month-by-month basis. As with the Spanish Influenza, this current pandemic shall pass. The outcome is hinged on our ability to work in concert with each other to ensure a healthy future for all.

What does this mean for us at the Historical Society? We have taken action and shifted our gears into remote mode, working from home via the digital sphere on the same things that occupied our world pre-COVID-19. Glenda Gephart, executive director of our Brick Tavern Museum, is checking phone messages and email inquiries on a daily basis, while maintaining general programming needs.

Currently, the museum is closed to the public until further notice.

Meanwhile, in this newsletter you will find our 2019 annual report and a ballot for our Board of Trustees election. Both would have been presented at our annual meeting, which had been scheduled for April 30 at the Burdett Fire Department. Some of you may have heard through the grapevine that we were in the early development of a capital campaign for a modest addition to the Brick Tavern Museum. We are very sad to say our campaign plan is now on hold until a later date.

Nonetheless, the development of this effort has brought our mission into focus, helping us to understand the future needs and growth areas of the Historical Society and the Brick Tavern Museum.


Ahead of us inevitably is a more pronounced digital capacity from which non-profit organizations like ours will have an expanded sphere for public accessibility and engagement. This does not suggest that our physical collection will lose standing or that our programming will be supplanted by a virtual surrogate. A stronger digital presence will complement our current programming and provide a deeper form of engagement with our historical archive, allowing visitors virtual access to Schuyler County history.

# Happy Birthday, Susan B. Anthony!

On Saturday, Feb. 15, Anita Gaston of Penn Yan portrayed Susan B. Anthony for an audience of 30 at Fiddlesticks Tea Shop in Odessa. Gaston's enthralling presentation came appropriately on the 200th anniversary of Anthony's birth. The suffragette leader was born on Feb. 15, 1820, in Adams, Mass. She died in Rochester on March 13, 1906,14 years before the 19th Amendment to the Constitution gave women the right to vote. The Amendment was ratified on Aug. 18, 1920.


