### **THOMAS BRIDGE WATER CORPORATION 2018 WATER SYSTEM IMPROVEMENTS PROJECT**

Separate sealed Bids for the construction of the **2018 Water System Improvements Project** will be received by Mr. F. Joseph Copenhaver, Jr. Administrator, at the Thomas Bridge Water Corporation Administrative Offices, 586 Thomas Bridge Road, Marion, Virginia 242354 until **2:00 p.m.** local time on **Tuesday, August 20, 2019**, at which time the Bids received will be **publicly opened and read aloud**. The Projects consists of the following:

Contract 1 – Water Line Replacements: Replacement of approximately 10,000 LF of existing water lines with new 6” diameter and smaller water line, service meter reconnections, and related improvements.

Contract 2 – WTP Filter Improvements: Repainting and replacement of existing mixed media at the 2.0 MGD water treatment plant.

Bids will be received for a single prime Contract for each Contract above. Bids shall be on a lump sum and unit price basis. The Project is funded through the **Virginia Department of Health**.
