This agreement made between the Annual World Championship Crawfish Etouffee Cook-off and _____, and independent contractor (“Operator”) has the purpose to set forth the terms and conditions whereby the Operator is authorized by Annual World Championship Crawfish Etouffee Cook-off (“Cook-off”), Eunice, Louisiana, under the following terms and conditions:

TERMS & CONDITIONS

HOURS: Saturday, March 23, 2024 10:00am to 4:00pm

This is a Rain or Shine Event

REPRESENTED PRODUCT: Cook-off reserves the right to terminate the operation of the Operator at any time during the Event for any of the following reasons:

1. A professional manner is not maintained by the Operator and its employees/assistants.
1. Operator or its employees/assistants commit any act detrimental to the purpose of the Cook-off.
2. Operator or its employees/assistants fail to cooperate with the event management staff.
3. Operator or its employees/assistants breach any of the agreements listed herein.
4. Operator or its employees/assistants violate any law or provision of the State of Louisiana
5. Operator is selling any item offensive to any group of people or inappropriate for children.

COST: In exchange for the right to represent the product(s) listed on this form during the Cook-off, the Operator agrees to pay Cook-off \$100 for 10' x 10' space in the festival area. Additional space must be purchased in incremental spaces at 10' x 10' for \$50 per additional space. This price includes standard electrical provision. Arts and Crafts Vendors will be located under the pavilion. Food Vendors will be located in designated booth space provided by the Cook-off one week prior to the Event. Operators must provide their own tents, tables, chairs, electrical cords, lights or any necessary items for serving or displaying product(s).

SIGNAGE: Operator must provide all signage for its Booth. No signage may be greater than the width of the rented space or obstruct the view of the stage or another booth.

PREMISES: Operator warrants that the premises shall be left in as good condition as the Operator found them; this includes picking up trash at and around Operator's premises.

SET-UP & DEPARTURE: Set up may begin as early as you want on Saturday, March 23rd but the booth must be ready for Operation by 9:30 am Saturday morning. Due to Cook-off layout and space requirements, Operator's vehicles cannot be parked alongside Operator's booth, but at designated parking areas no later than 9:30am. Break-down for Booths may commence anytime after 4:00pm, Saturday, March 23, 2024. All booths must be off the premises (completely) Saturday evening, March 23, 2024, at 6:00pm.

INDEMNIFICATION: Operator agrees to indemnify the Cook-off and any activity of the Operator during the Cook-off.

SALES TAX: All fees and sales taxes must be paid to the appropriate governmental entity in a timely manner, and is the responsibility of the Operator.

TERMS: Payment is due with application. If payment is not sent prior to Cook-off, Operator will not be allowed to set up.

Upon signing this contract, the Operator agrees to abide by all Terms and Conditions set forth herein.
