- d.) Engine 41 foam system needed repair. Engine 41 was taken to Circle K for service.
- e.) Rescue 45 had air supply issues. Circle K addressed an emergency maintenance issue and completed maintenance and provided fuse protection.
- f.) Grass Rig 48 is in service at Station 3 after pump replacement.
- g.) For the month of April, firefighter training was conducted online using the NFPA website. The topic was Alternate Fuel Vehicles.
