COURSE OBJECTIVES

At the conclusion of this program the participant will be able to:

Overall Conference Learning Objectives:

1. Discuss the magnitude of the problems faced by women with diabetes related to conception and pregnancy, and attain skills in ways to motivate patients to seek healthy lifestyle options.
2. Train clinicians in strategies for providing patient-centered care that encourage positive lifestyle changes and improve perinatal outcomes across the lifespan.
3. Train clinicians in the benefits of care provided by a multidisciplinary team approach for women with diabetes related to pregnancy.
4. Discover ways new technology can benefit and support the care of women with diabetes during pregnancy.

Specific Learning Objectives:

- Describe the principles for members of the antenatal care team in caring for patients with diabetes with common co-morbidities; and appreciate the impact of stress on the woman regarding management and treatment.
- Explore the essential mechanistic information on how Metformin works which underlie the fetal concerns from its use.
- Review the data supporting a long-term impact of Metformin use in pregnancy on the offspring's metabolic health, and describe the strengths and limitations in its use, and an individualized approach for its use.
- Examine findings from a pilot study involving women with T1D discussing their pregnancy related barriers and support systems for successful management.
- Describe the utility, standards, and preventative use of ultrasound in the management of pregnancies complicated by diabetes.
- Review the effects of BMI, weight gain, and nutritional influences on long-term obesity risk in pregnancies complicated by diabetes, clinical opportunities for intervention, and what this means for patient-centered care.
- Discuss the potential for using fasting and/or postprandial triglyceride, and their relationship with newborn subcutaneous and intrahepatic fat, and as a diagnostic tool in preventing excessive newborn adiposity.
- Discuss the latest on marijuana and opioid use, and describe experiences, beliefs and attitudes of use during pregnancy, including those pregnancies complicated by diabetes.
- Explore the MotherToBaby services for mothers, health care professionals, and the general public about medications and other exposures during pregnancy and while breastfeeding.
- List three factors to consider when making insulin adjustments.
- Explain how to assess each patient with preexisting diabetes for optimal glucose control and for recommending needed maternal/fetal antenatal assessments.
- Identify the need to rebrand the role of the diabetes educator.
- Describe changes for the diabetes educator over the next decade.
- List 3 features of AADE's DANA and the added value to your practice.
- Review the correlation between glucose control and risks for congenital anomalies and spontaneous abortions, and correlate with contraceptive methods to meet individual needs in women with diabetes.
- Identify two PP interventions that can improve the quality of life for women with preexisting diabetes.
- Describe how excess gestational weight gain, obesity, and GDM, as well as probiotic use have impact on the development of the newborn infant microbiome.
- Define the role of a disrupted infant microbiome to future weight gain and development of the inflammatory diseases in offspring that are exposed to antibiotics, c-section, and lack of breast feeding.
- State different vegetarian groups and sources of vegetarian protein as to be able to ease the challenges of a vegetarian diet during pregnancy.
- State benefits of promoting optimal blood glucose control and long-term, healthy life style changes for women with gestational diabetes.
- Discuss factors that impact timing of delivery, in pregnancy with diabetes.
- Identify the predictive value of glycemic control and lipid exposures in pregnancies complicated by diabetes, and obesity without diabetes, and the impact on offspring growth and chronic disease risk factors.
- Discuss IP management for women with diabetes, and describe current guidelines for IP insulin therapy.
- Identify resources available to clinicians and patients from a pharmacist, and their role to help resolve common prescription and supply issues.

New Technologies for Pregnancy Complicated by Diabetes:
Continuous Glucose Monitoring and Insulin Pumps

What are the best practice guidelines for utilizing continuous glucose monitor (CGM) sensors for women with diabetes in pregnancy? What do clinicians need to know to teach and support patients using CGM with multiple injections or with insulin pumps? What are the advantages and disadvantages of different types of CGM? This workshop will help you learn how to use CGM and insulin pumps, and how a hybrid closed loop insulin delivery system functions. Through case studies, you will learn how to develop a plan of care, educate the patient, document and continually reassess the process. Discussion will include the use of U500 insulin.

A Plan for Maternal/Fetal Assessments within
Pregnancies Complicated by Diabetes

Diabetes during pregnancy is a condition that poses significant maternal and fetal risk. There are established guidelines for appropriate diagnostic tests that can improve outcomes for this high-risk group of mothers and their offspring. This workshop will focus on a multidisciplinary approach to managing each patient based on her health needs by providing ante-intrapartum assessments that can decrease morbidity risks for women with diabetes and their offspring. A case study approach will be utilized with the inclusion of necessary check off and timing of testing, but designed to individual circumstances. Optimal care starts with a thorough review of history and knowledge of personal resources as well as systems for team care available.

OBJECTIVES:

- Identify the incidence and scope of diabetes in pregnancy and name 5 risk demographics and potential co-morbidities.
- Define both the standard diagnostic criteria and the newest recommended diagnostic criteria for diabetes in pregnancy.
- Name 2 pregnancy induced changes to diabetes management, define 5 potential complications unique to pregnancy, and the role of auxiliary assessments.
- Name 5 components of management of diabetes in pregnancy including patient self care recommendations, target goals, medication management rules and postpartum plan components for long term follow up.

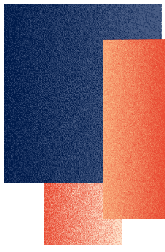
