Minutes of previous meeting:

The minutes of the April 18th meeting were read by Secretary Sal Masiello and approved on a motion by Jayne O'Brien, seconded by Sharon Morris.

Treasurer's Report:

Treasurer Jayne O'Brien noted the following. There was no activity in the Grant Fund or the Scholarship Fund. Beginning and ending balances were Grant Fund, \$3,789.81 and the Scholarship Fund, \$13,918.78. The General Fund had a beginning balance of \$898.85, with deposits of \$15.00 and expenses of \$371.94 (Staples Office Supply), \$10.00 (paypal) leaving a balance of \$531.91. The Athletic Hall of Fame started with a balance of \$4,599.71 with receipts of \$5,040.00, leaving an ending balance of \$9,639.71. The total balance as of May 9, 2023 in the Washington Trust account was \$27,880.21. The report was accepted on a motion by Sal Masiello, seconded by Paul O'Brien.

Scholarship Committee:

Chairman Paul Dolan noted that they had received thirteen completed applications in the required time. The committee has awarded nine of these students scholarships in the amount of \$1,500 each. These scholarships will be awarded during the Awards ceremony on May 25^{th} . Students will be advised of the material that must be forwarded to the association before payment will be made in August. Paul noted that any scholarship recipient not completing these requirements will have their scholarship revoked. The total of any revoked scholarships will then be divided amongst the other recipients.

Hall of Fame Committee Update:

Chairman Steve Bianchi reported the banquet preparations continue and he noted that the plaques will be in during the middle of May. Jayne O'Brien noted to date there are 89 paid tickets. Steve Bianchi noted that the committee will be meeting immediately after the alumni meeting today.
