- 🍏 John T. called meeting to order 7:00 pm:
 - ✂ John T., Rachel B., Paul F., Bob B. and Jennifer W. present.
 - ✂ Pledge of Allegiance recited
- 🍏 Email was sent out with minutes from February 23, 2022 meeting. Jennifer motioned to accept the minutes, Bob 2nd, roll call, passed. Minutes posted to the township web site.
- 🍏 Public Comment:
 - ✂ John spoke for Jackie Thompson, assessor. Rate for salary good, card updates need to be \$20 per card. She will do 20% per year to have budget amount same for each year. Bob motioned to raise the card cost to \$20 per card and salary to remain the same. Rachel 2nd, passed.
- 🍏 Rachel: **Treasurer's report** as of March 23, 2022:
 - ✂ Have \$236,685.68 total.
 - ✂ Payments were \$23,113.25. Treasury payments made (MI 381.75 + US 2,168.86), Equalization postage \$2,349.29, and Big Prairie Fire protection \$12,011.29 were largest bills.
 - ✂ Revenue was \$45,154.69.
 - ✂ Bob motioned to accept report and pay bills, Paul 2nd, roll call, passed.
- 🍏 Bob: **Zoning report**:
 - ✂ Dumpsters for clean up ordered. \$550 per
 - ✂ Power Home Solar for Petzel working to get permit form completed correctly
 - ✂ Baseline resident asking for extension on permit for building not yet built. One 6 mo. extension and then charge for any further extension.
 - ✂ 5 mile bad, will get worse
- 🍏 **Planning report: John**:
 - ✂ Will appoint a chair at next meeting
 - ✂ Next planning meeting is May 10th at 7pm.
- 🍏 Jennifer: **Clerk's Report**
 - ✂ Last month's motion was not for the budget, but for the pay schedules. After completing the change for card updates, Rachel motioned to approve the 22/23 budget. Bob 2nd, roll call, passed.
 - ✂ Login.gov – will ask county what applications require SS, DL, picture ID of employee.

 - ✂ Community service lead by Joni Kauffman will be completed, much done.
- 🍏 New Business:
