APPLICATION FOR ADMISSION**

To be eligible to practice law before the Intertribal Court of Southern California, an attorney must be admitted to the Southern California Tribal Bar Association.

**Eligibility and Application Requirements**

To be eligible for admission to the Southern California Tribal Bar Association, an attorney must:

- Be a member in good standing of any state or tribal bar with no disciplinary proceedings pending
- Conform to the standards of conduct promulgated by the American Bar Association in the performance of his or her professional duties
- Be knowledgeable of applicable federal, state, and tribal law as well as the Intertribal Court of Southern California Code of Civil Procedure and Rules of Court
- Be of high moral character as determined by the Chief Judge of the Intertribal Court of Southern California
- Consent to review of his or her attorney's fees for reasonableness by the Chief Judge of the Intertribal Court of Southern California
- Understand that should he or she be found in contempt of court by a judge of the Intertribal Court of Southern California, the judge may levy a fine of up to \$500.00 per incident and failure to pay the fine within 20 days of issuance will disqualify him or her from membership in the Southern California Tribal Bar Association
- Agree to pay a membership renewal fee of \$200.00 by January 1 of each year (fees not received by February 1 will be increased to \$250.00)

An attorney seeking admission to the Southern California Tribal Bar Association must submit:

- A completed application for admission
- A non-refundable application fee of \$200.00
- Proof of membership in any state or tribal bar

- Proof of malpractice insurance
- A letter of recommendation from an attorney member in good standing of any state or tribal bar
