# Police & Code Enforcement Report -

Chief Freyhof reported that they have had several calls to the 400 Lincoln Blvd. apartments regarding underage drinking and fighting, three cases have been sent to Children's Services. Officers have had a couple large quantity drug cases. Code enforcement has worked on 56 cases for the year and 49 have been resolved. There have been no responses to the email sent out to villages and cities regarding the handling or removal of large items. He will try to put something together on how he would like the program to work and the charges to be assessed.

C. Ordinance 21-1192; Sale of 184 W. Main St.

AN ORDINANCE AUTHORIZING THE VILLAGE TO SELL CERTAIN REAL PROPERTY KNOWN AS 184 W. MAIN STREET, RUSSELLS POINT, OHIO, DECLARING SAID PROPERTY TO NO LONGER BE NECESSARY FOR PUBLIC USE AND DECLARING AN EMERGENCY IN THE VILLAGE OF RUSSELLS POINT, OHIO. Mayor Reames stated that the council will need to determine what they wish to sell, keep, or lease the newly acquired property. Ms. Hinterschied suggested that the property be sold to recoup expenses. Mr. Iiams agreed that the village does not need another property to maintain. It was determined during discussion that there is a fourth parcel that was not included in the Ordinance and that all four parcels should be included in the sale. Mayor Reames added that there is interest in acquiring the parcels and the solicitor suggests getting a commercial appraisal. Once the property is appraised it will need to be advertised for 5 consecutive weeks prior to the sale.

## **CITIZEN COMMENTS:**

#### A. <u>Mr. Eric Hail</u>

In response to a recent notice Mr. Hail received from Code Enforcement regarding storage of certain vehicles, he reported that he collects historical Jeeps which are all now licensed with historic tags. He also has multiple boats and boat trailers which the trailers are licensed but the boats are not because they are never put on the water. He does not understand why the boats have to be licensed if he is not using them. Mayor Reames and Ms. Gauder explained that per our ordinances all vehicles, including recreational vehicles are to be properly tagged unless they are in a fully enclosed structure. Chief Freyhof added that the code enforcement notice was in part due to complaints from other residents regarding the visual aesthetics of the property and the large number of vehicles on the property. Council suggested that the vehicles, boats and trailers be parked in a more organized manner on the property.

### **OLD BUSINESS:** None

#### **NEW BUSINESS:**

A. Minimum Bid for 149 Clermont

Mr. Weidner reported that when the village attempted to sell the property in 2013 council set a minimum bid of \$3,250. To date the village has paid around \$3,061 for the acquisition and property taxes, but does not include costs associated with upkeep. The LC Auditors shows the assessed value of \$3,740 and the appraised value of \$10,680. Council discussed various minimums based on the information provided, the fact that this is a non-conforming lot, and whether we should get a legal opinion before a final decision is made. The neighboring property which is also a non-conforming lot recently sold at Sheriff's Sale for \$15,000. *Ms. Joan Hinterschied made a motion to sell the property through sealed bid with a minimum of \$7,120 which is 2/3 the appraised value. Ms. Shannon Stinemetz seconded the motion.*

# B. Storm Water Improvement Fund - Advances

Mr. Weidner reported that the Army Corps grant is a reimbursing grant. In order to account for transactions correctly, the General Fund will be required to advance funds to the improvement fund to pay for the Army Corps share of expenditures. Once the funds are reimbursed to the village, the advance will be paid back to the General Fund. A resolution is required to allow the fiscal officer to advance the funds. The resolution will be presented at the next council meeting.

*Ms. Joan Maxwell made a motion to adjourn the meeting and seconded by Ms. Shannon Stinemetz.* The meeting was adjourned at 8:15 p.m.
