### REFUSE NEEDS TO BE SEPARATED

GARBAGE (ONLY!) should be put in pails supplied. Filled buckets should be placed in the white house.

PAPER PRODUCTS and PLASTICS (other than\_# 1 & 2) put in trash cans in plastic liners in the white house.

It is important that garbage and paper be separated. We have to pay by the pound at the recycling center. SODA CANS AND WATER AND

SODA CANS AND WATER AND SODA BOTTLES (remove screw tops) Save for your own recycling or there is a container on the dining room porch and in the dining room.

Metal cans, plastic containers, glass, and foil need to be separated and put in containers in the white house outside the kitchen door. Please be sure to keep door shut to keep unwelcomed "visitors" out.

DUE TO INSURANCE REGULATIONS, ONLY SERVICE ANIMALS WILL BE PERMITTED ON THE GROUNDS. PLEASE LEAVE YOUR PETS AT HOME.

Before you leave, you will need to be sure that all accommodations: the kitchen, dining room, restrooms, dorms, cabins, tabernacle and grounds are in as good condition as when you arrived. There is NO

paid staff. Please arrange to take trash, if possible. If not, please help us make arrangements.

Rather than a set rate for use of the facilities, the suggestion is that a donation be made to help care for utilities and to help with the maintenance projects. In recent times we have been trying to up-grade the facilities and grounds. In order to do this, funds are needed. A donation to the camp to help with this need would be greatly appreciated
