## **South Africa & The U.S. a Comparison. Lesson In History Part 25**

In past lessons in history we have shown that conspiracies have indeed existed down through the centuries. Many people don't believe in the conspiracy theory of history because they view this phenomena as simplistic (several evil men in a smoke-filled room hatching up a plan). Conspiracies are much more complex than that. Individuals, or groups of individuals, with like thoughts and beliefs, strive for a common goal. These individuals may or may not be related to each other by blood but only by beliefs. The written Word of God, the Holy Bible, reflects conspiracies. The story of Jacob and Esau is but one example.

In this lesson in history we will show another example of this complex conspiracy. We will show the astounding similarities between the birth, growth, maturity and death of two great nations, the United States of America and South Africa. As the history of these two brother nations is compared we should readily see the conspiracy. That individual conspiracy is but a part of the greater one and we will show the current efforts in this regard.

The Celto-Saxon people of the western world have one trait in common and it has caused us untold troubles from the time of our beginning, That one trait is being stiffnecked or stubborn. Another secondary trait and it really is a result of being stiffnecked is that of utilizing the non-Adamic peoples of the world as laborers because of the low costs involved. We never seem to learn. We have created civilization after civilization, which became the guiding light to the world. In every case, without exception, these civilizations fell because of that basic trait found in our DNA race memory structure.

Through all of the preceeding centuries, we have had the luxury of moving on to comparatively vacant land known as wilderness areas and starting a new civilization. We would start all over again, only to decay and fall. But now, there are no more habitable wilderness areas. We have nowhere to go. The price for our folly will finally have to be paid.

In [Exodus 33](#) the instructions given to us are so plain. Why can't we see it? Moses and the children of Israel were camped at the foot of Mount Horeb. God told Moses that Israel was to drive out all of the non-Israel people from the land that they were to inherit.

[Exodus 33](#), verse 5. *"For the Lord had said unto Moses, say unto the children of Israel, ye are a stiffnecked people: I will come up into the midst of thee in a moment, and consume thee: therefore now put off thy ornaments from thee, that I may know what to do unto thee. And the children of Israel stripped themselves of their ornaments by the Mount Horeb."*

*Verse nine. And it came to pass, as Moses entered into the tabernacle, the cloudy pillar descended, and stood at the door of the tabernacle, and the Lord talked with Moses. And all the people saw the cloudy pillar stand at the tabernacle door: and all the people rose up*

*and worshipped, every man in his tent door. And the Lord spake unto Moses face to face, as a man speaketh unto his friend. And he turned again into the camp: but his servant Joshua, the son of Nun, a young man, departed not out of the tabernacle."*

*And Moses said unto the Lord, see, thou sayest unto me, bring up this people: and thou hast not let me know whom thou wilt send with me. Yet thou hast said, I know thee by name, and thou hast also found grace in my sight. Now therefore, I pray thee, if I have found grace in thy sight, shew me now thy way, that I may know thee, that I may find grace in thy sight: and consider this nation is thy people.*

*And he said, my presence shall go with thee, and I will give thee rest. And he said unto him, if thy presence go not with me, carry us not up hence. For wherein shall it be known here that I and thy people have found grace in thy sight? Is it not in that thou goest with us? So shall we be separated, I and thy people, from all the people that are upon the face of the earth.*

We don't see how it can be any more clear than the instructions that God gave us. We were to separate ourselves from the other peoples of the world and it was for a reason. God was fully aware of our weakness. God knew that we would not be able to teach other peoples the laws of God if we mixed with them and took their laws instead. He knows us far better than we do.

God has shown mercy on his people and he has been patient and forgiving. If that weren't the case, our people would have been destroyed a long time ago. He has allowed us to figuratively come up again against the Red Sea.

It appears to me that the United States of America and the Republic of South Africa could very well be the last examples of God's patience. We are running out of time and space where we can continue to do it our way instead of God's way.

The comparisons between the United States and South Africa are astounding. We started the same way and at about the same time. We are now in the same position with the same terminal ills.

The first known contact of white man with what is called South Africa was by the peoples from the Mediterranean area. The standard history books show them to be Arabs but more specifically, they were probably Libyans. These will have been the people of Dan who had migrated to the area of Cyrene in Libya. Eratosthenes of Cyrene developed the system of navigation using the compass and conceived the system of the meridian circles of the earth. He knew the earth was round and not flat. these Libyans traded with the natives in the area along the African coast at Sofala in northern Rhodesia. The language spoken will have been Gaelic and Ogam script was the alphabet.

What is now known as the United States was visited by the people from Cyrene in Libya at about the same time. The Libyans in America also traded with the natives. Ogam script was also used here and Gaelic was likewise the language.

The history of these people can be found in much more detail in past history lessons. We have produced that history in booklet form titled *Christians Before Columbus*.

The southernmost part of the African continent was inhabited by a few bush people called the Hottentots. It was in 1652 that Jan Van Riebeeck of the Dutch East Indies Company settled along the very tip of South Africa to provide a rest stop for the ships travelling around the cape.

Virginia was settled by the London Company in 1607 for the purpose of furthering the interests of international commerce. Additional colonies were planted from Maine to Georgia. These colonies were initially settled for the purposes of furthering British commercial interests but the people who came to settle also had religious and personal freedom in mind. They came to make a new life for themselves.

In South Africa, the strict regulations of the Dutch East Indies Company caused the newly arriving settlers to move further inland to obtain personal and religious freedoms. In 1657 the company discharged some of their soldiers and sailors and gave them land along the cape. In 1688 about 300 Huguenots joined the original group of these ex-soldiers and sailors known as "Free Burghers." As our Israel forefathers in South Africa continued in their search for freedom they moved further inland.

In the United States the regulations of the commercial ventures company were likewise restrictive. Our American Israel forefathers also decided to move further inland to obtain their freedom.

Here were two newly founded nations of the same people trying to find peace and freedom to worship and live as their conscience dictated. Because of a common system of international law originated by the Venetian Traders and then perfected by the English Traders in that one-square-mile of London England known as "The City," the colonists in both countries initially decided on flight rather than fight.

The early colonists of South Africa were so depressed by the commercial system of the Dutch East Indies company that they started a mass migration inland. That mass migration has become known as *trekking*. The word *trek*, or to travel on foot or with oxen, originated in South Africa. It simply meant to escape the confines of the Dutch East Indies Company. In the United States we had no similar word. We simply called it the great westward expansion.

But both the people of South Africa and the United States had the God given right to defend themselves. In South Africa, the land was nearly vacant because of the climate. In America, the land was nearly vacant, partly because of climate and partly because of intertribal wars.

As the colonists of South Africa moved inland with the system of trekking, a tribe of black natives from the North moved South, not because they wanted the land but because they wanted to conquer the white man. These black natives were known as the Xhosas. In the present day, the Xhosas are still wanting to conquer the white man and their leader is Nelson Mandela. The colonists developed what became known as "Commandos" to counter the plundering and murdering of the Xhosas. The word *commando* also became well known the world over because of the South African white people.

In the United States the system of Posse Comitatus was developed for the same purpose. As our American forefathers moved West to retain their individual freedoms, the Posse Comitatus was used repeatedly by the local sheriff to quell disturbances. The sheriff was the center of law enforcement and he worked directly for the people, not the government. There were no massive police organizations until late in the 19th century.

A change in sovereignty took place in both the United States and South Africa at about the same time. In South Africa, the Dutch East Indies Company was removed and replaced by the British starting in 1795 and completed in 1814. In the United States, the English were removed and replaced by the United States sovereignty because of the Revolutionary War. But the peoples of both South Africa and the United States were required to retain ties to the international commercial system.

Both the United States and South Africa adopted slavery as an excepted lifestyle. In South Africa, the natives were close at hand and the South Africans used them as slave labor. In the United States they were imported from Africa and used for the same purpose. In both cases the justification and organization controlling this practice was by the leaders of the international commercial system. The Christian people of South Africa and the United States could find no Biblical injunction against using slaves so they continued the practice. However, it was the acceptance of a non-Biblical commercial system that was the root of the problem.

Both the Old and New testaments discuss the use of slaves and instructions are given regarding how other peoples are to be treated if they reside in our land. However, it is of utmost importance to understand that God expects us to remain separate as a people. As we will find, it was the black people of both countries that became the catalyst for the downfall. The black people of both countries have been used in this regard for other, more sinister, reasons.

Strangely enough, it was Christian missionaries from England who went to South Africa along with the English settlers. They became politically active to bring about the first emancipation of black slaves in South Africa in 1834. The farming community in the vicinity of the cape was devastated. The great trek North to the Transvaal took place from 1836 to 1840. There they stayed until the present time.

That was just 25 years before the westward exodus of many of the people of the south following similar circumstances in the United States. Here in the United States we had the great Civil War to bring about the emancipation. The Civil War in South Africa was to begin just a few years later.

Just as it was in South Africa, Christian missionaries originating in England, came to the United States to bring about the emancipation of the black people. One of the more important points that we want to make in this lesson is that Christianity has been used, just as the black people have been used, to bring about a New World Order.

As the Dutch colonists left for the Transvaal, one of their leaders, Piet Retief, made the following public statement, which should haunt each and every one of us, both in the United States and South Africa. I want to quote his public release:

"1. We despair of saving the colony from these evils which threatens by the turbulent and dishonest conduct of vagrants, who are allowed to infest the country in every part; nor do we see any prospect of peace or happiness for our children in a country thus distracted by internal commotions."

"2. We complain of the severe losses, which we have been forced to sustain by the emancipation of our slaves, and the vexatious laws which have been enacted respecting them."

"3. We complain of the continual system of plunder which we have ever endured from the Kafirs and other colored classes, and particularly by the last invasion of the colony, which has desolated the frontier districts and ruined most of the inhabitants."

"4. We complain of the unjustifiable odium, which has been cast upon us by interested and dishonest persons, under the check of religion, whose testimony is believed in England to the exclusion of all evidence in our favour; and we can foresee, as a result of this prejudice, nothing but the total ruin of the country." That is the end of Piet Retief's public release as their trek began."

Just a few years later, in 1899, the Anglo-Boer civil war started which ended in defeat for the White Africaners. This war was basically the same as our civil war. It was to return both countries to a singular federal rule. In South Africa, it was the British government. In the United States it was the Anglo- American Eastern establishment. As Piet Retief stated, "which has been cast upon us by interested and dishonest persons, under the check of religion."

In this time frame phase one of long range planning for a one world government was completed for both countries. What we will call phase two began with the communist revolution in Russia. Communism did not start in 1917 in Russia. The actions in South Africa and the United States that we have just described were during the time of the great turning toward socialism world-wide. It was in this time frame that Christianity was penetrated by socialists and it was during this time frame that Christianity became known as Judeo-Christianity.

Phase one emancipated the black man in both countries. In phase two the intentions are for the black man to take command in both countries and subjugate the white man. The One World Order doesn't care about the black man. He is being used. It is the white man, the true Israel of the Bible, that must be destroyed.

Whenever a number of different groups with similar beliefs but organized separately attempt to remove a government from power they will never succeed because there is no cohesive command. Any government fighting to stay in power knows that and they have developed a technique to penetrate each group to keep them separated.

Communism provided that singular command to a number of different groups, each attempting to change the world but who couldn't individually. It provided more than an ideology. Communism developed into a science of making war without declaring war. It has learned to use other means. Again, we will show the astounding similarities between South Africa and the United States.

Both the governments of the United States and South Africa have had legislators who have responded to the bleeding heart mentality. The bleeding heart mentality responds to the emotions instead of the substance. This is pietism versus the scriptures. The Judeo-Christian Churches have submitted great sums of tithing money to bleeding heart legislation in both countries. Concurrently, still larger sums of money supporting the legislators in both countries have come from big money interests such as the Oppenheimers, Rothschilds and Rockefellers. To continue receiving funds the legislators must vote as they are directed.

One man, perhaps more than any other in South Africa, stood in the way of bringing down the white government. His name was Dr. Verwoerd. He was assassinated by a communist named Dmitrio Tsafendas. Dmitrio was expelled from the United States but then secretly brought back into this country. He then went to South Africa and assassinated Dr. Verwoerd. This is just another example of the secret government within the government that rules our country. There will be more on this later.

Demitrio Tsafendas worked with Henry Kissinger in Germany during W.W. II. It was Kissinger who convinced South Africa to force Rhodesia to the bargaining table, which ended with the destruction of Rhodesia. It was Kissinger who forced South Africa to withdraw from Angola when they were about to destroy Communism in that country. It was Kissinger who set up the bargaining agreements to cause South Africa to fall this last April. This is another example of the secret government within the government.

The United States Embassy in Pretoria has been the meeting place of the subversive elements within South Africa for many years. The United States Air Force bases on the Botswana border were built for the purpose of providing a launching pad for military intervention in South Africa in the event that the White Afrikaners rebelled.

The former United States Ambassador to the UN, the black radical Andrew Young publicly made this statement: "The United States government will make things so difficult for the whites and we will squeeze them till the pigs squeak. They will be glad to surrender power."

The Communist boss in South Africa, the Jew Joe Slovo, openly lived in England. The World Council of Churches gave huge sums of money to the communists of South Africa as well as did other world known organizations in the trade unions, the entertainment field and the oil companies.

Cyrus Vance, past Secretary of State in the United States is now a special envoy to South Africa. He has been involved in many meetings with Communists the world over and all of them have instigated riots and insurrection shortly after each meeting.

The Carnegie Foundation, the Ford Foundation, the Rockefeller Foundation, and many others just like them have provided money and political power to bring down South Africa. They are not doing this because of their compassion for the black people of South Africa. They are doing it to further their effort to rule the world.

Here in the United States, these same men and organizations have been working in exactly the same manner to bring down the white dominance in the United States. Many individuals like Senator Joe McCarthy have been assassinated to make way for the onslaught, just like Dr. Verwoerd in South Africa.

The main tactic that the Communists, as well as all other totalitarian forms of government, have used is that of negotiation. It was Henry Kissinger who provided the major negotiations between the United States and the communists in South Africa. To accomplish the art of negotiation as a weapon, another rule of warfare is used, that of "divide and conquer." Kissinger was placed in a position to negotiate. It was the same in South Africa. Joe Slovo, leader of the Communist Party in South Africa, said this about their efforts of negotiations with the White South Afrikaners: "We engaged in negotiations with a revolutionary purpose. Negotiations are a terrain of struggle."

The people of the world who yearn to be free were looking at the struggle in South Africa and were counting on the Afrikaners to resist in a very meaningful way. Of course we now know that it did not happen. Why didn't it happen? We must look at the short-term history in South Africa. In 1993, the De Klerk government (again, a government selected to negotiate) realized that there was a very strong possibility of a military coup that could topple the entire process of communizing South Africa. De Klerk's government, with the help of the Communists of course, needed a method of blinding the disgruntled ranks of the

military and the Afrikaners. It was determined that if they could find one or two men who were trusted by the military and the Afrikaners and have them advise against insurrection, the battle would be won.

They found their men in Generals Constand Viljoen and Tienie Groenewald. General Viljoen was politically uninitiated, at least publicly, and he was a retired professional soldier who was accustomed to taking orders. General Groenewald was another retired military soldier. He had been the chief of military intelligence and he was known to be very manipulative in his manners and actions. These were the men that De Klerk selected to penetrate the resistance movement.

These two men were readily accepted as "military advisors" to the resistance movement under very questionable circumstances at a meeting held in the Transvaal Agricultural Union building at Silverton, Pretoria. These two generals who served in the military for the most rotten government South Africa had ever had, were strangely selected as leaders over other Afrikaners who were much more qualified. Afrikaners whose families had been proven under fire during the Boer War, and most popular among the Afrikaners and the military, were not even considered. The men had been proven on the battle fields. Their farms had been plundered during the Boer War. They lost members of their families in the concentration camps. They were by far the most qualified to lead any resistance group. But as trusting as the Christian Afrikaners are, they grudgingly accepted Generals Viljoen and Groenewald. When the Afrikaners accepted them, the Christian patriots all over the world accepted them. There is a lesson to be learned for all freedom loving peoples.

The two generals did as they were told. They very cleverly inticed the Christian Afrikaners into negotiations with the African National Congress (ANC) and the South African Communist Party (SACP). They gave the Afrikaners such statements as "It is questionable whether it is desirable to cause the fall of the National Party (De Klerk's party)," "We will win a White election by 50%-60%."

The Conservative Party of South Africa saw the "handwriting on the wall." They said, "the negotiations are the instrument through which the National Party (De Klerk) was committing its act of treason." "The Conservative Party refused to be part of this treason against our nation and will accordingly not join the process of negotiations through which our nation will be betrayed of its right to freedom." General Viljoen continued to negotiate secretly with the African National Congress led by the Communist Nelson Mandella. Even the *Christian Science Monitor* reported this on September 24, 1993.

General Viljoen himself exposed his position in a public meeting on November 17, 1993, "Mr Mandela was talking about Inkatha and he was talking about me. He said every time I speak to them we move closer to them. He even went so far to say that he will start off, giving me and Dr. Hartzenberg seats in the new cabinet. I agree, it is time for the leaders to move closer to each other, because it is the leaders of SA who can sort out the problems of SA. If the leaders of SA refuse to talk to each other, our people will suffer. So therefore Mr. Mandela, if I am moving closer to the ANC, yes I am doing so. I am saying to Mr. Mandela if I am moving closer to the ANC, yes I do so."

The "negotiations" did exactly what the Communists (South Africa and the United States) wanted. The Communist Party boss, Joe Slovo, told his fellow Communists after the negotiated settlement, "What has come out of Kempton Park is only a mountain of paper. The critical question now is implementation...We can expect a rear guard counteraction...non cooperation, subverting...insurgency...we can expect a right wing backlash...we must (as a Sandinistan comrade recently and aptly put it) provide the right

wing with an option short of armed resistance. This involves dialogue and a strategy to divide them."

Those statements are in perfect unison with what Lenin had to say. "Treaties are like pie crusts-made to be broken...To tell the truth is a petty bourgeoisie habit-but to lie convincingly is a sign of superior intelligence."

There are a mountain of lessons in Joe Slovo's statement for us to learn. Negotiations will not work. You do not negotiate with evil. The Communists are not finalized in how to implement any specific gain. This can be a weakness to be exploited. The Communists expect rear guard counteraction and even subversion and insurgency. Should the Afrikaners consider this and plan their actions in such a way to totally leave them off-guard? They admit that they should provide an option to the Afrikaners. That is further negotiation. Again, you do not negotiate with evil. Their strategy is to divide and conquer. This is the very heart of the Afrikaners weakness and ours here in the United States.

The Afrikaners have always been somewhat divided on almost every subject. That is exactly the same problem within the Christian Patriot movement here in the United States. South Africa lost the Boer War greatly because of lack of unity. We here in the United States continue to lose issue after issue because too many of us "take our marbles and go home if you don't play our way." Communists don't do that. Jews don't do that. They may fight like alley cats among themselves but when it comes to their basic social cause and purpose in the world, they march in "lock-step" and on those issues they cannot be divided. We must forgive and forget petty differences among us. We must even realize that most of them are planted divisions to do exactly what Joe Slovo describes in his instructions. We cannot overemphasize the importance of unity. Jesus said in [John 15:12-13](#): *"This is my commandment, That ye love on another, as I have loved you. Greater love hath no man than this, that a man lay down his life for his friends."* The military can obtain that kind of love within the ranks. It is demonstrated continually in every war we have fought. The Communists obtain that kind of relationship with each other. We Christian Patriots must learn that we are heavily infiltrated for the very purpose of creating division. We must overcome it.

We all know the results of the election in South Africa. They turned out just as our government and that of South Africa knew they would. They were prepared, however, to do whatever was necessary in vote fraud to secure that election. That itself tells anyone that the problems in South Africa will not be solved in the ballot box.

Here in the United States we have the identical situation. Men who have proven themselves to be traitors to our country are being used continually as "representatives" and "consultants" to foreign nations in the incessant drive for a one world totalitarian government. Why must we always have men like Cyrus Vance, Andrew Young, Jimmie Carter, Henry Kissinger, and a host of others, represent the United States, even as private citizens after they have served in an official capacity? Why can't we select private citizens who have proven themselves to represent the people of the United States?

Just as was the situation in South Africa, the Christian conservative groups here in this country are deluged with men with credentials similar to those of Generals Viljoen and Groenewald who somehow present themselves for duty to help "return the country to a Christian Republic." Just as it is in South Africa, "negotiations" is the accepted solution. Again, how can a Christian negotiate with antichrist evil?

Both countries are near the day of reckoning. Although the elections are over in South Africa and the communist African National Council under Mandela has won the election, the

white South African is not destroyed. There will be rough days ahead but the white South Afrikaner is one of the toughest fighters in the world. Don't count these people out.

The South African defense force, the military, has been quietly training white civilian forces and arming them with captured weapons. They have been training black Zulus who are the timeless enemies of the Xhosas. There will be a conflict in South Africa and it is a crime against Christianity that the United States will help the Communists.

The schedule in the United States is slightly behind South Africa. That country is a test bed for things to come here in our beloved country. The white man in the United States is still mesmerized with florde in the water and the incessant drum beat of the black man in our so-called music.

But that will change. The violence here is still not as widespread as in South Africa. That silent majority will one day awaken to the plight and it will be a repeat of South Africa. The parallel history of both countries tell us the story.

The Newest Conspiracy. In Zbignew Brzezinski's book *Between Two Ages: America's Role in the Technitronic Era*, he states that we as a nation will become the world's leader in service and information. The book was written in 1976 and in the time since its publication we have already reached the goal he described. That book *Between Two Ages* is a book of instruction, much like an earlier instruction manual titled Philip Drew, Administrator by Colonel E.M. House, who was advisor to President Wilson.

In the time frame since *Between Two Ages* was written, we have greatly dismantled our industrial production industry. Steel mills have closed and many sold to foreign countries. The iron ore mines have been closed. The lumber industry is dried up with very little timber being cut. The copper industry is feeble and moving to places like Chile where ore is plentiful and labor cheap. Even the lighter industries such as making toasters, light bulbs, fans, radios and television, etc., have moved to other countries and their products returned to the United States for distribution and sale. The service industry is growing to sell and maintain the mountain of "things."

It is the information industry that Zbignew Brzezinski describes that is the heart of what the world controllers consider the final conspiracy. Specifically, we want to show one aspect of it that is an integral part of the great conspiracy. The United States has become the world's foremost leader in the field of spying. The politically correct term is intelligence gathering. The intelligence data that is gathered is astronomical in amount and is being used by several groups in their efforts to rule the world. That is the intent of the instruction manual that Zbignew Brzezinski wrote.

In past history lessons we have shown that prior to the turn of the 20th century, England was the leader in international finance and world order. They possessed the most able intelligence organization in the world at that time. The Bank of England in London was the world leader in matters of world order. Industry and banks were owned and controlled by private families, not only in England but all over the world, including here in the United States.

We have shown in past lessons that the control of money and industry has changed hands since 1900. Corporations and banks are now owned by individuals and organizations with literally unlimited sums of money. The headquarters for that group is the United States. Intelligence gathering is of primary importance to them in their drive for world control, as we shall see.

The United States intelligence community has become what could be called the Bureau of Conspiracy. Intelligence gathering when President Truman signed into law the Central Intelligence Agency in 1948 could have been considered a craft. Intelligence gathering has now become a science of Orwellian proportions. Brzezinski must be proud of his "information" assignment for the United States.

There are over 3.5 million federal employees who participate and have access to the information gathered. Another 1.5 million people in universities and industry are a part of this gigantic organization. Money is spent like there is no bottom to the barrel. Just one organization, the National Reconnaissance Office (NRO), has a budget of 3.7 billion dollars to manage the satellite reconnaissance programs, which snoop on all of the people on earth. We would imagine their biggest effort is right here in the United States. The National Photographic Interpretation Center (NPIC) interprets the images received from those satellites.

The innocuous-sounding Federal Research Division of the Library of Congress is perhaps one of most important, and therefore most highly classified, programs in the intelligence community. They do the seemingly mundane work of utilizing one of the world's foremost libraries to prepare very highly classified position papers on nearly every organization in the world along with the natural leaders of the world. The art of divide and conquer could very easily originate in this office.

The National Security Agency has an Orwellian role in the intelligence community. They have the capacity to monitor every telephone call in the United States and signals from much of the world. Other organizations officially listed along with the CIA are: the Bureau of Intelligence and Research (INR), the Defense Intelligence Agency (DIA), the intelligence groups within the Army, Navy, Air Force and Marines and those of the Treasury, Energy and Drug Enforcement Administration.

There is the Intelligence Division of the Office of Export Enforcement. They monitor the export of goods to foreign countries. Export of goods is accomplished solely on the basis of geo-politics. It has no relationship to agreements such as the [General Agreement of Trade and Tariffs GATT](#) and the [North American Free Trade Agreement](#) (NAFTA). Notice that both of these are agreements and not treaties but they will be treated as treaties. The Foreign Broadcast Information Service (FBIS) is assigned to the CIA. The Secret Service is assigned to the Treasury Department.

They have Foreign Instrumentation Signals Intelligence, Radar Intelligence, Radiation Intelligence, Laser Intelligence, Imagery Intelligence, Medical Intelligence, Nuclear Intelligence, Radiation Intelligence, Signature Intelligence, Medical Intelligence, Telemetry Intelligence and even Intelligence on Foreign Materiel. All of the information gathered is encrypted and filed to be used for military advantage. That is not the total extent of "secrets" that are filed but it is enough to get to the point of this.

All of these data are being used to bring about the New World Order. These data were used on behalf of the ANC and the De Klerk government in South Africa. It has been used in every "police action" that we have become embroiled in. The biggest trading partner of course is Israel. It is also of interest to note that the South African Government and Israel is in close liaison. It is also of interest that Roy Bullock of the San Francisco Police Department's scandal with the [Anti-Defamation League](#) (ADL) transmitted information to South Africa.

The brighter side to this in behalf of Christian freedom is that they have no really effective way of retrieving data from this mountain of information they gum-shoe. They

know this and they are working frantically to correct the problem. In the meantime, there is even a more pressing problem that totalitarianism is facing.

**The Warrior Class.** We have written before about what can be called "McWorld" (the one world government) versus "Jihad" (nationalism). The fight between nationalism, which is simply people of like ethnicity, and those who want us all to be a light shade of brown (The Brown UN man in the [UN building in New York](#)). Of course, we must understand that they don't want all of us to be a light shade of brown. The elite or "chosen" reserve for themselves the privilege of remaining as they are.

Well, the United States Military has written a position paper on what is called "*The New Warrior Class*." The paper is written by Major Ralph Peters, who is assigned to the Deputy Chief of Staff for Intelligence.

The document is most obviously written from the position that the United States has been perfectly righteous in all of its dealings in the world. With that in mind, the essence of the article is that, because there is a drive world wide for racial, tribal and national separation, a new class of warrior has been born. Peters denigrates this warrior class in general terms by lumping them all together and states that they are in it for the money and power. He states that generally they are misfits who can't do anything else.

He places this new warrior class as coming from four social pools. He states, "First-pool warriors come, as they always have, from the underclass (although their leaders often have fallen from the upper registers of society). The archetype of the new warrior class is a male who has no stake in peace, a loser with little education, no legal earning power, no abiding attractiveness to women, and no future. With gun in hand and a spittle of nationalist ideology dripping from his mouth, today's warrior murders those who once slighted him, seizes the women who avoided him, and plunders that which he would never otherwise have possessed." This is the picture that he paints for the United States Military to fight in any movement resisting the new world order. It is no wonder that our young soldiers, as well trained as they are, are psychologically prepared to destroy any effort to retain or regain nationalism.

One class of warrior that in all probability he is referring to is the Christian Patriot in the United States. He states: "The third pool of warriorhood consists of the patriots. These may be men who fight out of strong belief, either in ethnic, religious, or national superiority or endangerment, or those who have suffered a personal loss in the course of a conflict that motivates them to take up arms. Although these warriors are the easiest to reintegrate into civil structures- especially if their experience of violence is relatively brief- some of these men, too, will develop a taste for blood and war's profit."

He then provides this: "Worldwide, the new warrior class already numbers in the millions. If the current trend toward national dissolution continues, by the end of the century there may be more of these warriors than soldiers in armies worthy of the name."

He concludes his article with this: "We need to commit more of our training time to warrior threats. But first we need to ask ourselves some difficult questions. Do we have the strength of will, as a military and as a nation, to defeat an enemy who has nothing to lose? Although there are nearly infinite variations, this type of threat generally requires a two-track approach, an active campaign to win over the populace coupled with irresistible violence directed against the warlords and the warriors. You cannot bargain or compromise with warriors."

Is that the reason why there was such irresistible violence directed against the Branch Davidians at Waco and that "warlord" at Ruby Ridge in Idaho?

It is extremely significant to note that Major Peters recognizes that the one world order is on shaky ground because of the great desire for nationalism even in their own ranks and in our people in general. This knowledge should be remembered by the Christian Afrikaners in South Africa as well as the true Christian remnant here in the United States. Wasn't Jesus referring to this type of situation in [Luke 9:62](#) when He said, *"No man, having put his hand to the plough, and looking back, is fit for the kingdom of God."*
