I. Approval of Agenda

DeCaire moved to approve the agenda. Williams seconded. Motion approved 3-0 (DeCaire, Williams, and Herman)

II. Approval of Minutes

Williams moved to approve minutes for November 16, 2015, December 21, 2015 and January 11, 2016. DeCaire seconded. Motion approved 3 - 0

III. New Business

(a) Election of Officers for the 2016 Year

Chairperson – Commissioner DeCaire nominated Sue Herman for Chair. Williams seconded the motion. Herman accepted. Motion passed unanimously 4-0.

Vice Chairperson – Commissioner DeCaire nominated Jerry Williams for Vice Chair. Herman seconded the motion. Williams accepted. Motion passed unanimously 4-0.

Sergeant at Arms – Chairperson Herman nominated Janette DeCaire as Sergeant at Arms; Williams seconded. DeCaire accepted. Motion passed unanimously 4 – 0.

(b) Resolutions

16-002 Award Contract - Envision- for labor to install LED retrofit

DeCaire moved to approve; Williams seconded. Chairperson Herman sought clarification between resolution previously approved for Graybar and current resolution before the Board. Telfer explained Graybar provided the electric materials that would be installed, Envision would provide the labor for installation. A review of the bidding procedure and evaluation was provided to the Board Motion approved 4-0 (Cotto, DeCaire, Herman and Williams)

16-003 To Adopt Act No. 88, Public Act of 1961

Williams moved to approve; Cotto seconded.

A discussion was held regarding the effect of this act which would be to allow vesting in the Michigan Employees Retirement System at an earlier date than might otherwise occur without adoption of the reciprocal act. Adoption of the act would not cost the Melvindale Housing Commission additional funds. Motion approved 4-0 (Cotto, DeCaire, Herman and Williams)

Staff reviewed their reports and Chair Herman directed that they be placed on file.

A subcommittee of Jerry Williams and Janette DeCaire was created to explore cable television services at Telfer's request.
