## Minutes of July 2, 2018

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Robert Holmes. Also present were Walter Rollin, Jed Lamb, Dimitri Szynal, Dennis Finkel, Frances Rollin and Sheila Lanning.

*Motion* by Lamb with a second by Rollin to approve the minutes of the June 18, 2018 regular scheduled meeting as written. Roll call: 3 yeas. Charges and checks (8280-8283) totaling \$32,346.00 were approved for payment. Financial reports showing bank balance of \$345,573.70 were reviewed.

**Holmes reported:** July 16<sup>th</sup> meeting starts with Public Hearing at 6:45 to hear public comments on the 2019 proposed budget. International truck repairs cost \$12,570.34. Asked Finkel to flush the water fountains at the Park. Finkel stated they were flushed but there is little use so they have a plastic taste. Finkel will flush again. Sheriff report for June shows 28 incidents. Walt picked up recycling gift card tickets. Received OPWC application forms, provided to Finkel. **Communications:** Ukrainian Youth Camp 7-15 to 7-28, Historical Society Ice Cream Social 8-12 from 1:00-3:00, LC Public Health Vaccine schedule on Facebook, LC Public Health needs volunteers for mock emergency drill, House Bill 602 for Water and Sewer, House Bill 168 for Cemeteries with dollars back to Townships for repairs, House Bill 415 for carry over to Townships for Roads and Bridges, House Bill 175 livestock, House Bill 500 with various items. NOACA dues and increase discussed. Current dues are \$275.00. Population increases in the county but is down in Huntington.

**Lamb reported:** Meetings are coming up; Finance committee of Rural Water Board met and discussed credit card payment fees. The bank talked to the new General Manager and can mark down the fee to \$2.00 from \$2.50. Reminder to watch out for farmers on the roads.

Rollin reported: Fire District open house last Saturday.

**Fiscal Officer reported:** Received letter from Ohio Secretary of State to submit annual roster on-line.

Road Foreman reported: No further repairs to equipment at this time. Roads coming along, Baker Road patching left to do, headwalls scheduled for 7/10/2018 delivery. Sarver switched to a fiber mix that was going to cost \$70.00 a ton so switched to Medina Material for patching material. Change to previously decided chip and seal roads: swap Stewart Road for Hawley Road behind Findley. *Motion* by Holmes with a second by Rollin to authorize the recommended switch of roads being chip and sealed. Roll call: 3 yeas. Roadside grass cut once and some roads twice. Bergman requested grass cut before roads are chip and sealed. Sent in the application to Lorain County Health District for a change to sewage system. County sprayed guardrails but did not spray Township rails even though they put them in place.

**Public comments:** Frances Rollin confirmed the cost of \$8.00 per plate and approximately 50-55 attendees for the July 21<sup>st</sup> Township Association meeting.

*Motion* by Lamb with a second by Rollin to adjourn. All favorable, meeting adjourned at 7:49 PM.
