Strikers S.C is affiliated with the Clawson Soccer Association. We are an affordable and competitive community based soccer program. The Strikers S.C. is committed to provide an environment where our players develop a true passion for the game. We focus on the individual player development while making sure each player understands the importance to play as a team. We teach valuable lessons through competition and prepare our players for the challenges they will face on and off the field in life. ### **Commitment Level**

- 8 to 10 games in Fall and Spring MYSL or MSPSP Seasons
- 2 practices per week, August-October and April-June
- 2 Indoor Sessions – Note: 4 v 4 teams will only play 1 Indoor Session
- Winter training once a week for 10 to 12 weeks (November to March)
- One Tournament (Fall or Spring)

### **Tryout Process**

Tryouts for the Fall 2017 and Spring 2018 season will be held on June 17<sup>th</sup> and June 18<sup>th</sup> at the Clawson Park Stadium field which is located at the SW corner of Clawson Park (Elmwood and Bywood). An additional tryout may be held the following week for those unable to make it on the weekend but spots are not guaranteed. Please check [www.clawson-soccer.org](http://www.clawson-soccer.org) for updates and specific times for tryouts. A tryout waiver must be filled out prior to on-field participation and pre-register on-line. Players will be selected by club staff based on playing skills, Coachability and athletic ability during the tryouts or during the Open house on June 6<sup>th</sup> or 8<sup>th</sup>. Returning players are not guaranteed a spot for the team they are trying out for. Players may be selected on the 1<sup>st</sup> or 2<sup>nd</sup> day of tryouts. If you did not receive an offer, the Strikers S.C. will notify you and encourage you to come back the following year. After teams have been formed, the teams will meet the following week after tryouts to register, provide 1<sup>st</sup> payment, try on uniforms and complete required documents for MYSL / MSPSP. If you are not available for this meeting, please contact the Director (Denise Lanfear) to make other arrangements to register.

Strikers S.C. encourages players and families to find a club that is a right fit for the player and family. We will not make you sign a contract on tryout day, but when an offer is made and accepted, we trust that your family will abide by the oral commitment as you place your trust in us that we will provide the best atmosphere possible for your child to grow as a player.
