We Need Your Help Saving Floyd Hill Meadow

In the summer of 2023, Mountain Area Land Trust (MALT) received a land donation from Albert Frei & Sons. The land donation consists of an 18-acre parcel that many know as Floyd Hill Meadow and is coined by locals as "Clear Creek's Front Yard". This highly visible parcel is adjacent to Clear Creek High School (west side) and is an entryway into the Floyd Hill and Saddleback Mountain neighborhoods.

In order to ensure the property is permanently conserved, MALT is currently raising funds to place a Conservation Easement on it, which will protect it in perpetuity. MALT intends to maintain ownership and is working to raise \$50,000 to cover the costs of a specialized appraisal, baseline survey, due diligence and legal fees, and long-term stewardship endowment.

"By placing a Conservation Easement on this parcel, we can ensure this area always remains as a beautiful meadow for both wildlife and people to enjoy," MALT Executive Director Lynn Caligiuri shared. "We are seeking support from the community to help us reach our goal, so we can be sure this highly visible area is forever protected. We have \$20,000 left to raise."

- 2. Treasurer's Report (FORTHCOMING)
- Stephen Lochner resigned from the Treasurer's position via email 4/22/24.
- Scott has accessed the accounts and we're in the process of getting everything up to speed.
- We aim to have an updated Treasurer's report sent out via email in 1-2 weeks. The process is as follows.
 - Meet with Stephen at Citywide to have our (The Board) names added to accounts. (PRES) Scott Warren & (SEC) Bridgette Bracker
 - Receive all paperwork, checkbook, etc. from Stephen.
 - Transfer Paypal payments (approx \$1600) to bank account, updating quickbooks.
 - Mail unsent invoices due to glitch in Quickbooks.
 - Find neighborhood volunteer to take over position OR outsource to a bookkeeper.

3. Jon Butcher (neighbor and clear creek employee) brought to our attention the Clear Creek Fire Mitigation Grant. This is \$50,000 program. Each resident can get up to 5K (generally 50% of total mitigation cost. So, if mitigation quote is \$4,000, resident would get \$2000 in grant money.

- The application is now open for the 2024 Wildfire Risk Reduction grants at https://www.clearcreekcounty.us/97/Emergency-Management. Due date is May 10.
