The purpose of CCHA is to support families in the education, nurture and development of their children in a manner that honors Jesus Christ. In accordance with our purpose statement, all CCHA members will conduct themselves in a Christ-like manner. Our actions, speech and clothing will reflect our commitment to follow God's Word as detailed in the Bible.

CCHA welcomes the diversity of beliefs of our members, recognizing that our Statement of Faith is very general in regards to orthodox Christianity, but ask that when dealing with other children in the group that you respect the parental authority. The following is our **Statement of Faith**.

I believe that there is one and only one living and true God. God is the creator, ruler and sustainer of the universe. He eternally exists in three persons: the Father, the Son and the Holy Spirit. Jesus Christ is the eternal Son of God. In His incarnation, Jesus was conceived by the Holy Spirit and born of the virgin Mary. Fully man, yet fully God, He lived a sinless human life and offered Himself as the perfect sacrifice for the sins of all persons by dying on a cross. He arose bodily from the dead thereby demonstrating His power over sin and death. He ascended to Heaven's glory where He sits at the right hand of God the Father, and will return again to earth to reign as King of Kings, and Lord of Lords. Salvation is a free gift from God to people. Only by trusting in Jesus Christ as God's offer of forgiveness can people be saved from the consequences of sin. The Bible was written by individuals who were supernaturally inspired by the Holy Spirit and therefore is the living word of God. The Bible contains the record of God's revelation of Himself to human beings. It is the ultimate source of truth for Christian life and thought, and is the final authority on all matters of faith and practice. I affirm the Biblical definition of marriage as the union of one man and one woman.
