

Missouri close to possible helmet law repeal.

A Senate Bill modifying Missouri's mandatory helmet law to only apply to riders under 21 years of age has reportedly received final approval from the state's House of Representatives. After the Senate resolves changes made by the House, the bill will advance to the Governor's office. According to the Motorcycle Riders Foundation, none of these changes are controversial or related

to motorcycling. Once the bill reaches his desk, the Governor has until July 14, 1999 to sign it into law or veto. If he does neither, the bill will reportedly go into effect automatically August 28, 1999.

You may remember Eller Industries of Niwot, Co, as the company that tried to show an Indian concept bike designed by James Parker, but was prevented from doing so or from using the Indian brand name by a US District Court in Denver.

At the time, a company called IM-COA prevailed in its bid to use the Indian trademark. Currently, IM-COA is producing motorcycles powerd by S&S engines, under the

Indian name and logo in Gilroy, CA. Eller's first bikes will be cruisers powered by a 1,600 cc air-cooled, 50-degree V-twin that has a single pin crankshaft, with counterbalanceing and EFI. there would be one camshaft per cylinder, actuating two intake valves and one exhaust valve per cylinder, via pushrods. A design goal of 100hp and 100lb-ft of torque is set.

Eller currently is trying to obtain financing for these projects. We've got word from top investment people that the funds will be available when we need them.

If successful, Eller plans to be producing its Black and Green cruiser motorcycles soon. Labriola said that production should begin in about 26 months from July 1.

Thanks too for Tina in her formal roll


as Secretary and her unofficial roll of coordinating our meeting location and making sure that everyone knows when and where it is.
