1. Old Business:

- b. It is time again to elect new board members. Elections are in May and an email has gone out to garner interest and nominations. 2. New Business:

- a. The spring sport concession sign ups have been made. Adult volunteers are needed in each shift. Softball has done well at providing last minute volunteers if

needed. Baseball is having a hard time filling their spots. Golf is working the Hillwood Track Meet concessions.

- b. Spring fundraiser ideas were brought up. It was suggested that we do an Easter Bunny pancake breakfast. The hardest part is the planning and it needs to be done months in advance. Some other ideas were a Santa breakfast and a luau idea at the beginning of the sports season. This will be a continuous discussion and Catherine Smith will be working on some ideas and plans.
- c. Open discussion: We need to sell remaining spirit wear. It's time to start thinking about getting more memberships for next year. There was a question about what the booster club needs to do to get ready for the May 16th spring football game. It was also discussed on how we could get sponsorship packages together for more booster money.
