

## Cash 'n Dash Raffle Rules

Educational and Treatment Council, Inc. (ETC), a 501(c)3 organization, is raffling off a Winner's Choice Travel Experience ("Cash 'n Dash!") consisting of the following: \$5,000 cash or up to \$5,000 towards travel of the winner's choice as planned through GlobeTrek Travel, Inc (or the travel agency of the winner's choice). **While the agency hopes that the prize is used towards a fun travel experience, the \$5,000 may be used at the discretion of the winner.**

If the winner chooses to book a trip or trips through a travel agency, ETC can pay the travel agency directly by credit card. If the amount of all travel booked is less than \$5,000, the difference will be paid in cash to the winner by ETC.

If the winner chooses not to book through a travel agency, ETC will pay the \$5,000 directly to the winner. The maximum amount of the prize value shall not exceed \$5,000 in travel or combination of travel and cash. The cash value shall not exceed \$5,000.

The proceeds of the raffle will benefit the programs and services of Educational and Treatment Council, Inc. (ETC) which is located in Lake Charles, Louisiana.

### Official Rules & Regulations

- By purchasing a ticket, purchaser enters this raffle and accepts and agrees to be bound by all the rules, regulations, limitations and restrictions set forth herein. Please contact Educational and Treatment Council, Inc. (ETC) if you have any questions about this raffle. ETC's interpretation and application of the rules and regulations shall be final.
- A ticket represents a chance to win the stated prize subject to all terms and conditions set forth herein and in the "Prize-Winner Affidavit". The winning ticket shall be selected at the ETC Outreach Center, 2400 Merganser St., Building B on Friday, December 13, 2019 at 1:00 p.m. (CST) by a random drawing in which all participants have an equal chance of winning. The winner need not be present to win. The winner will be notified by phone call, email, and/or overnight express mail courier. The winner will have 5 business days from receipt of notification to contact ETC to accept the prize and sign the Prize-Winner Affidavit. In the event the winner fails to accept the prize within the time set forth, and at the option of ETC, the prize will be forfeited and shall remain the property of ETC. Another ticket shall be selected by random drawing.
- Purchaser agrees to release ETC, their directors, officers, employees and agents from any and all liability for injuries, losses or damages of any kind caused by participating in the raffle or winning any prize or resulting from acceptance, possession, use or misuse of any prize and the winner agrees to indemnify and hold ETC harmless from any and all losses, damages, rights, claims and actions of any kind rising in connection with or as a result of participating in the raffle or the winner's acceptance or use of any prize.
- In the event that the winner uses a travel agent to book the rental of a vehicle(s) with the prize money, ETC will not be responsible for damages or other liability related to the rental of said vehicle(s).
- Tickets are one hundred dollars (\$100.00) each. A maximum of 300 tickets will be sold. Tickets are available on a first come, first serve basis. There is no limit to the number of tickets an individual may purchase.
- Raffle tickets will be sold during regular business hours at the ETC Outreach Center, 2400 Merganser St., Building B, beginning on Friday, October 25, 2019 at 3:00 p.m. Cash, checks, and credit card payments accepted. Checks should be made payable to Educational and Treatment Council. Online

raffle tickets go on sale Friday, October 25, 2019 at 3:00 p.m. at [www.etcyouth.org](http://www.etcyouth.org); credit card payments accepted. Individuals who buy raffle tickets online will be emailed their raffle ticket number within two business days of purchase by a designated employee of ETC. A raffle ticket stub will be completed and entered into ETC Cash 'n Dash! Raffle by a designated employee of ETC. No raffle tickets or money for raffle tickets may be sent through public or private mail.

- The ETC Cash 'n Dash! Raffle will be considered closed once the 300 maximum of tickets has been reached. In the case that the maximum number of tickets is not sold, the ETC Cash 'n Dash! Raffle will close on Friday, December 13, 2019 at 11:59 a.m. (CST).
- A raffle participant's sole and exclusive remedy for ETC's breach shall be limited to the return of the purchase price paid for his or her raffle ticket(s).
- The prize will not be awarded and shall be forfeited if winner's ticket was issued in exchange for a check returned for "insufficient funds" or for a credit card charge declined, invalid, stolen or otherwise rejected.
- The prize may not be substituted or exchanged. If the winner chooses to receive the prize as \$5,000 cash, then ETC will pay the winner upon his/her signing of the Prize-Winner Affidavit. If the winner chooses the travel agency option, then travel through the GlobeTrek Travel, Inc. (or the travel agency of the winner's choice) must be booked by December 31, 2020. If travel is not booked by that date, the winner must contact ETC by 12:00 p.m. on January 4, 2021 to receive the designated cash value (\$5,000).
- The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions.
- The prize remains the sole property of ETC until unconditionally accepted "as is, where is" by the winner. The prize shall not be awarded or expended until the "Prize-Winner Affidavit" has been signed by the winner.
- Names and/or likenesses and quotes of winners may be disclosed to and used by the news media and may otherwise be used by ETC for publicity purposes and published in area newspapers and announced on area television and radio stations and the ETC websites and social media.
- All federal, state and/or local tax consequences are the responsibility of the winner of any and all prizes. It is strongly recommended that winners consult a tax advisor.
- Ticket buyers and persons named on a ticket must be at least 18 years old upon purchase. Tickets can only be purchased in the name of individuals (not businesses).
- ETC employees, volunteers and board members and family members of ETC employees, volunteers and board members are eligible to purchase and win the Raffle with the exception of the ETC Executive Committee Members, who themselves are ineligible to enter the contest.
- All ticket purchases are final and non-refundable.
- Purchase of a ticket constitutes full agreement by the purchaser with all terms and conditions set forth herein and in the "Prize-Winner Affidavit".
