

## Goodwell Minutes – February 23, 2022

- 🍏 John T. called meeting to order 7:00 pm:
  - ✂ John T., Rachel B., Paul F., and Jennifer W. present. Bob B. absent. Public: Tim Maxson – planning chair, Jessie Alonzo - BP FD, Donnie Kaiser.
- 🍏 Email was sent out with minutes from January 26, 2022 meeting. Paul motioned to accept the minutes, Rachel 2<sup>nd</sup>, roll call, passed. Minutes will be posted to the township web site.
- 🍏 Public Comment:
  - ✂ Jessie: Department had 14 runs in January, 11 medical. The boat is coming along, looking to pick up next weekend and take it to get graphics. Law enforcement is looking forward to training with the boat. Two persons interested in joining, 1 new medical person. Township would like a current advertisement to post on web site. Working on one key for all businesses, which would help shorten time at getting to trouble spots.
  - ✂ Donnie: Discussed what township is looking to have him do with stumps from clean up by Mr Kauffman’s crew. If neighbor Jerry will allow, push stumps to west, else haul away. Use the dirt pile to level out area. Bulldoze the area so it is relatively flat. Looking at the first of June, maybe sooner.
- 🍏 Paul motioned to approve the 22/23 budget. Rachel approved. Roll call, passed.
- 🍏 Rachel: **Treasurer’s report** as of February 23, 2022:
  - ✂ Have \$430,022.58 total. Most of the monies are taxes to be distributed away from Goodwell.
  - ✂ Payments were \$6,392.65. No large payments.
  - ✂ Revenue was \$307.15.
  - ✂ Paul motioned to accept report and pay bills, Jennifer 2<sup>nd</sup>, roll call, passed.
- 🍏 Bob: **Zoning report**:
  - ✂ Nothing.
- 🍏 **Planning report: Tim**:
  - ✂ Looking into noise ordinance. Consensus is no, main reason is potential for abuse and enforcement would need law enforcement. One member abstained; rest voted not to move forward. Planning chair from Big Prairie asked questions regarding mixed use. Discussion then centered on what planning should look at next. Renewable energy such as solar farms. So far keep as non-conforming use that needs special meeting.
  - ✂ Tim is offering to sit on the Board of Review to fill the vacancy. Rachel motioned to fund the training. He would be certified in time for the March meeting. Paul 2<sup>nd</sup>, roll call, passed.
  - ✂ Next planning meeting is May 3<sup>rd</sup> at 7pm.

  - ✂ Nothing.
- 🍏 Old Business:
  - ✂ Community service lead by Joni Kauffman worked on Saturday. They have accomplished much. John will check with Joni to see when they are returning.
