Sub: EPS-95 Enhanced Pension on Actual Salary

## THIS IS APPLICABLE ONLY TO EPS-95 MEMBERS

As briefed to our members during the 8<sup>th</sup> AGM of HALE held on 29<sup>th</sup> October,2017 it has become imperative now to approach judiciary for redressal of our claim of EPS-95 Enhanced Pension based on the Hon'ble Supreme Court Order of October 2016.

- 2. This is in view of the fact that EPFO has now approached Hon'ble S C in this regard and also EPFO vide its letter dated 7<sup>th</sup> December 2017 have not accepted our appeal to Union Labour Minister for Enhanced Pension.
- 3. It may be noted here that benefits of Enhanced Pension are made only to the petitioners of Exempted Organisations by EPFO based on the judgements of High Courts.
- 4. Hence HALE is initiating the necessary action to approach Judiciary for availing the Enhanced Pension for our EPS-95 members.
- 5. The initial expenses in this regard will be Rs.1000/- (Rupees One Thousand Only) per member of HALE. The basic criteria is, our members must be in receipt of Pension from EPFO at present. (i.e Member of EPS-95).
- 6. If para-5 is acceptable / applicable, then such members may please fill up (Name & Signature only) the enclosed Vakalath Nama, in legal size paper(215x345) Sign and "Personal Details" sheet, (also enclosed) duly filled in, and forward to HALE Office before 27<sup>th</sup> December 2017, positively. All those who sign Vakalath Nama (along with Personal Details Sheet) will be Petitioners for the Writ Petition to be filed by HALE. Printed Vakalat nama and Personal Details sheet available in HALE Office, for Members to fill in and submit there itself. (Please carry the Pension Pay Order (PPO) letter for filling Personal Detail Sheet.
- 7. Mode of Payment will be indicated separately
- 8. Please treat this as **MOST URGENT.**
