

TOWN OF STRATTON INVITATION TO BID Pavement

The Town of Stratton is seeking bids for paving to be completed by August 30, 2016. Measurements given are approximate and not guaranteed. Contact the Road Foreman for locations and additional information at (802) 896-6224.

- 1) SA1 (Stratton-Arlington Rd. section) from the intersection with the West Jamaica Rd. heading east to existing new pavement – approx. 1.0 miles.
- 2) SA2 (Brazers Way section) from the intersection with Gerry West Way to the intersection with Pikes Falls Rd. – approx. 1.0 mile

Hot Mix Overlay

Layer #1 – 3/8" mix X 1" deep

Layer #2 – 3/8" mix X 1" deep

Emulsion RS-1 shall be applied prior to placement of bituminous concrete over existing pavement. The use of a distributor truck at a rate of 0.025 gallons per square yard is required.

Surface and base mixture must conform to the current requirements of the State of Vermont, Agency of Transportation Specifications, Section 406. Bid prices should be per ton and include hauling and placing material, signing and traffic control during placing operation and preparatory compaction.

Gravel Shoulders:

2' wide, 4" deep both sides of road for 2.3 miles in length with four (4) intersections.

- 1) Shoulder mixture must conform to current requirements of the State of Vermont, Agency of Transportation Specifications, Section 704.05A 1" gravel.
- 2) Surface course and shoulder stone aggregate as per State of Vermont, Agency of Transportation Specifications 704.12:

Bid price should be per yard and include hauling, placing material and compaction flush with pavement per State of Vermont Agency of Transportation Specifications 402.10. Signing and traffic control is the responsibility of the Contractor during completion of operation.

Bid price for separate shoulder materials will be reflected in all bids.

Winter sand shall consist of clean, hard, screened sand particles uniformly graded from coarse to fine and shall be reasonably free from silt, loam, or clay. The fundamental requirement is that it will not clog commonly used spreaders when wet.

CORROSION INHIBITED CALCIUM CHLORIDE SPECIFICATION

Under this specification, the successful bidder shall provide Liquid Calcium Chloride for use in dust control, ice control and for other highway related purposes.

The bidder must submit with its bid detailed specifications, circulars and all necessary data on the commodity to be furnished. Failure to submit any of the above data may result in rejection of the bid. The Town, however, reserves the right to request any additional information deemed necessary for the proper evaluation of the bids.

MATERIAL REQUIREMENTS

Liquid Calcium Chloride shall be supplied as a true solution, from the manufacturer and not reconstituted in a liquid form from flake or pelletized calcium chloride which shall show not less than 32% +/- 1% for ice control and 35% +/- 1% for dust control, stabilization and for other highway construction related purposes.
