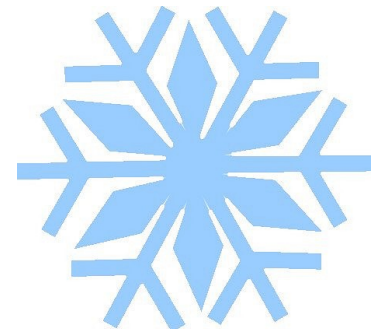
-prepare students to participate in the economic system,

Perkins Reauthorization

Early in 2016, bipartisan discussions occurred about how to proceed with a new law. H.R. 5587 was released in May, supporting many of ACTE's priorities for reauthorization. Strengthening CTE for the 21st Century Act was released in June and approved in September with a 405-5 vote. ACTE provided technical assistance on key issues and organized a collaboration of education, workforce and business-related groups, providing information and analysis for our members and the CTE stakeholder community.

CTE continued to work on the reauthorization of the Higher Education Act, with the introduction of several new bills aligned with our broader reauthorization priorities. Progress on the reauthorizations of the Temporary Assistance for Needy Families program and the Health, Hunger-Free Kids Act was also tracked. We are also working on the correction of an issue relating to a federal law governing military education benefits for students at area CTE centers. Several new advocacy activities began, including a dinner series with policymakers in partnership with Opportunity America, a national business coalition.

- ◆ The student may already be enrolled in any post-secondary school or preparing to attend a post-secondary school during the following year.
- ◆ The student may major or be majoring in any area (please indicate major in your essay and what college you are or will be attending).
- ◆ This scholarship may only be won once by a child of an NSBEA member.
- ◆ The parent must have been a member of NSBEA for the last two years.

Forty NSBEA Members and BMIT teachers attended the 2016 NSBEA Fall Conference on Saturday, October 29. The event was held at the Omaha campus of the University of Nebraska, Mammel Hall Business Building. UNO offered a great facility, at no charge to our members so that they could share in this experience. The 2016 Fall Conference was hosted by Kelly Means, NSBEA President.

Three great rotational breakout sessions were offered to attendees.

Breakout EDU, presented by Shelly Mowinkel from Milford Public Schools, provided participants a hands-on experience with the breakout concept. Shelly brought her Breakout kits and allowed participants an opportunity to problem solve to determine a solution. She presented it in a way where attendees could see ideas about how to use this both with students and adults.

Digital Citizenship, presented by Keegan Korf, Digital Citizenship Lead Teacher for Omaha Public Schools and liaison for Common Sense Media partnerships for the state of Nebraska shared resources that teachers can use for teaching digital citizenship and for vetting technology tools beyond an individualized personal review.

LinkedIn in the Classroom, presented by Kelly Means, NSBEA President and Innovation Facilitator for Omaha Public Schools. This session provided an overview of LinkedIn tools that are appropriate for student use and was filled with ideas and connections for teachers to use with students in building a professional brand and image.

Futuring Panel—November 28, 2016

Eighty senior-level Nebraska business executives met at The Career Academy (TCA), located at Southeast Community College in Lincoln, NE, on November 15, 2016, engaged in three days of discussions focusing on the Nebraska Career Education career clusters within the Business, Marketing and Management career field. Beth Osteen, Rick Mangini and Holly Atha of MBA Research Consortium, based in Columbus, OH, and staff from the Nebraska Department of Education (NDE) facilitated these discussions.

Marketing, Business Management and Administration, and Finance career clusters were represented by executives from agriculture, technology, health, manufacturing, banking, insurance, accounting, corporate finance, investments and securities, nonprofit organizations, small business/entrepreneurs, marketing, higher education, human resources, retail, and transportation and distribution industries.

Designed as ‘futuring panels,’ small groups were tasked to identify, then rank, current and emerging trends impacting the Nebraska business environment. Knowledge and skills needed to meet these trends were defined and will be considered for inclusion in future career education standards for middle and high school students. Participants were also asked, “What is an ethical leader?” Examples were generated of ethical issues encountered in each represented business that were related to specific skill identified.

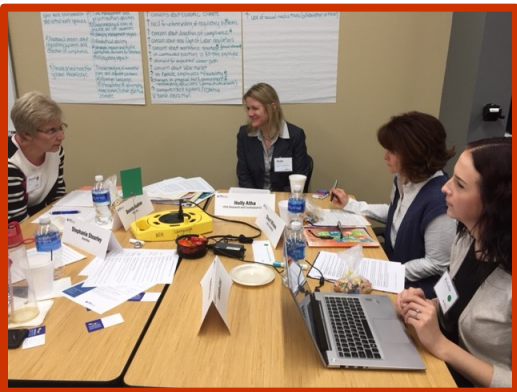
Panel members identified general business skills needed by all business professionals to obtain and advance in all business careers. Existing career pathway descriptions and job titles within each pathway were examined to determine relevance in today’s business world. The need for credentials and certifications were also documented.

As NDE begins the revision process for the Business, Marketing and Management standards later next year, the ‘futuring panels’ work will provide a solid foundation for defining knowledge and skills most impacting our business students.

Special thanks is extended to TCA for hosting this important event and to the 22 facilitators and recorders who made the three-day event possible. The Nebraska Council on Economic Education, UNL’s CBA College and the Alpha Upsilon Chapter of ARBE-DPE donated funds to cover meal expenses. It was a team effort!
