## **RENTAL POLICY UPDATE**

Effective January I, 2024, the Glenn Community Center Board approved updated changes and rate increases on renting the facility. These changes are necessary due to renters not adhering to defined clean up policies, damage to the center, changing times of rentals and amount of payment, and security deposits set forth in the rental agreement signed by all renters.

These changes are:

- $\Rightarrow$  No new back-to-back rentals scheduled unless approved by Board President. Last minute rental requests may not be honored.
- $\Rightarrow$  The fee may also be determined on hours use from start to finish.
- $\Rightarrow$  Rental fees must be paid in full I month before the rental.
- $\Rightarrow$  501 {c}(3) organizations rent for FREE with \$300 security deposit and copy of IRS determination letter.
- $\Rightarrow$  Everyone pays the \$300 security deposit. Security deposits are not refunded if hall is not cleaned per checklist or if there are damages.

We do not have an around-the-clock cleaning crew that most organizations and businesses have; and unfortunately, we have had to ask for volunteers to come and help clean up after renters left the hall in an unacceptable condition for our next renter.

Mutual cooperation and respect by all parties involved is of vital importance. These changes will be included in the revised rental agreement.
