#### Worship & Discipleship: Rose Anne Hoekstra

Trinity's membership is growing. 18 new members were accepted this year. We have been involved with the Grant Township Business Fair. Mission projects includes the Veterans Closet and Rose of Sharon men's recovery home. Being involved at Trinity has been life changing, don't be afraid to say yes.

#### **Communication:** Gayle Harrop

The team is working on better communication between members, members to council and council to members. A Quarterly newsletter goes out to all members along with Trinity Connections emailed to members.

**Refresh & Renew:** All of the communication from members during the conversations held has been given to council. It is being turned into a plan for the future of Trinity. A Thank You to everyone on that committee for their work.

**Vision Team:** This team took the information from the R & R team and developed a long term sustainable path for Trinity. They researched the area and what Trinity has to offer. Three possibilities were discussed as to the future of Trinity. This information is being given to the Call committee.

#### Call Committee: Rose Anne Hoekstra

They are responsible to complete the site profile to be given to Metro Synod of Chicago. From this the synod will help with the call process. The committee will listen to sermons, meet with prospective pastors to determine a possible pastor for Trinity. The congregation will have the final choice to put out the call. A 2/3 vote of the members will be needed to pass this call. A question was asked as to how long this process will take before someone is our pastor? It depends on many factors. It could be a few months to a year.

**Memorial Fund:** As of 12/31/2022 the Memorial Fund has \$14,973.82. The Endowment Fund as of 12/31/2022 has \$2605.00. There are special envelopes available in the narthex for donations to these funds .Motion was made by Robin Adams second by Judy Perryman to accept all the reports. Motion passed.

#### **Financial Report:** Brian Adams

Motion to accept the Financial Report was made by Kristen Stoyer second by Sam Kong Discussion was held. There is an email directly to the treasurer if you have any particular questions. Motion passed

**2023 Budget: Motion** was made by Sam Kong second by Jeff Neely to accept the 2023 Budget. Discussion There is a big jump in the General Giving due to an increase of membership. Therefore, an increase in Executive expenses was included. This will cover the possible salary of a part time pastor. Also, many extra gifts have increased.

Question as to when was an audit held? There has not been an audit in the last few years. A committee will be form to accomplish this task.

Online giving is being adjusted to make easier donations.

## **Special Congregational Meeting Minutes**

#### Sunday, August 13, 2023

The meeting was called to order by President Bob Piepenbrink.

The meeting opened with a prayer from Pastor Dale Ziemer

Teller Tom Morris took roll and verified a quorum of 52 members

Verify Quorum is met and identify requirement for 2/3 majority vote.

Tellers have verified a Quorum and identified the number of voting members present to be 52. The motion required 2/3 of the attending voters to pass and would therefore need 35 votes to be approved.

#### President Piepenbrink stated the rationale for this meeting:

"It is Trinity's mission to "Know Jesus and Share His love" and today we a looking at the end of a long road that has brought us to this place in our journey. With the implementation of this Pastor Sharing Covenant, we are taking the untrodden path to allow both Trinity and Shepherd of the Lakes be able to continue their respective missions. By combining our resources and working together to resolve any and all future issues we are addressing one the financial burdens many congregations in today's times are facing. So, while getting to this point is the end of a long road, more importantly it is the start of a new road to continue our journey to "Know Jesus and Share His Love". Therefore, the Trinity Council has recommended the following motion and presents it to the Congregation for your approval.

#### **Council Secretary Rose Anne Hoekstra read the motion:**

A discussion followed regarding the use of the phrase "a called pastor." Jane Gemein felt the article "a" might be misinterpreted. She offered and amendment changing the article "a" to "the" since technically Pastor Gonyea call is with Shepherd of the Lakes the wording was changed to "To enter into a limited agreement with Shepherd of the Lakes Lutheran Church of Grayslake to share pastoral services as spelled out in the Pastor Sharing Covenant. And, in so doing, afford Rev. Ann Gonyea all of the rights, privileges and responsibilities of the called pastor of Trinity Lutheran Church." Nancy Knapp seconded the motion.

The vote was called and the amendment seconded again by Nancy Knapp. The amendment was approved by voice vote.

**Tellers distributed ballots** Members were asked to place an X in the box by the word YES to approve the motion or place an X in the box by the word NO to reject the motion. Then fold the ballot in half and pass it to the center aisle to be collected and counted.

Tellers counted and presented the results: 51 ballots were marked "YES" and 1 ballot was marked "NO" The motion carried.

President to be announced to the congregation that the Covenant between Shepherd of the Lakes Lutheran Church of Grayslake, IL and Trinity Evangelical Church of Ingleside, IL on Tuesday, August 15, 2023 and that Pastor Ann Gonyea would begin work on August 16, 2023. Her first day to conduct worship will be on September 4, 2023.

To my Siblings in Christ at Trinity Lutheran Church, Ingleside, Illinois:

Hallelujah! I will give thanks to the Lord with my whole heart, in the assembly of the upright, in the congregation.

Majesty and splendor mark your deeds, and your righteousness endures forever.

You cause your wonders to be remembered; you are gracious and full of compassion. (Psalm 111: 1-4)

Psalm 111 is a hymn of praise sung by an ancient congregation as they remember their trust in God's goodness. I feel like this could be the song of Trinity. Kudos to Gayle Harrop for making this program a success.

- Confirmation: Kev Schweitzer and Kylie Farmer were confirmed on November 19 and approved as adult members at the November 20 Council meeting. We currently have four 7<sup>th</sup> graders and two eighth graders enrolled in confirmation class. In the past, Confirmation in the past was a three-year program including grades 6-8. We have decided to convert the program to a two-year program of study. This change was made based on parent preferences and age-based readiness for some abstract concepts. 4-6<sup>th</sup> graders will be offered the opportunity to serve as acolytes. They will have their own Sunday school class.
- Youth: Pastor Ann is planning to form a combined youth group including both Trinity and Shepherd. A possible
  mission project is possible this summer. We are making an intentional commitment to include youth in the life
  of the church. You may have noticed our youth participating in the service. We are happy to see several high
  school students taking part in the service, communion, acting as worship helpers and readers, and helping with
  live streaming.

#### **Member Care**

The Meal Train program has continued to meet the needs of those who need help with meals for a temporary period of time. This provides the opportunity for those delivering food to connect with members, offering companionship and support.

The Prayer Chain continues to be a tremendous support to those in need, letting people know they aren't alone in challenging times. The amount of "Prayer Warriors" continues to grow both in spirit and numbers.

#### Welcome/Hospitality

Each week members are greeted with an opened door, a friendly smile and a reminder to wear a name tag so that we can welcome visitors, get to know new members and better communicate with one another. Refreshments are also served on non-breakfast Sundays with many staying after the service to visit.

There are many pieces of information available at the Welcome Desk including a printed copy of the sermon of the week, opportunities and methods of giving, information about the ELCA and its missions, and Christ in Our Home daily prayer books. Visitors are encouraged to stop by with questions and to complete a "Special Guest" form.

#### **Giving Tree project**

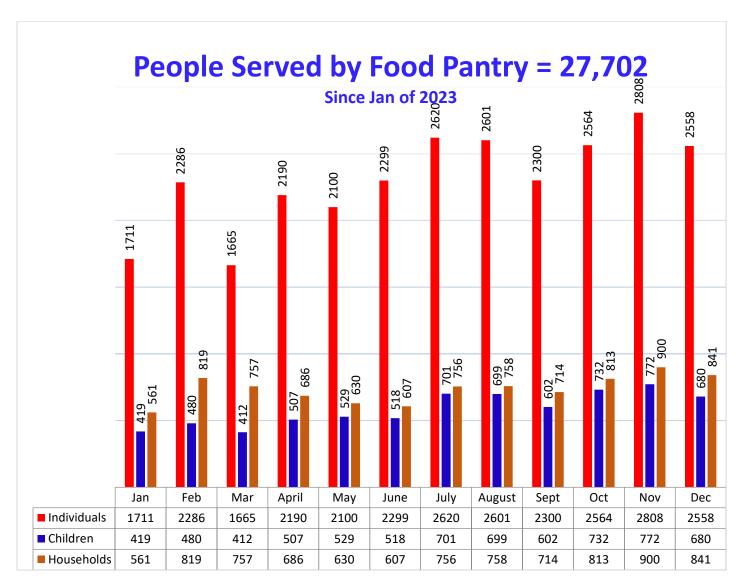

## Fellowship and Service Ministry Team Year End Report

2023 has seen many exciting things happening at Trinity.

In January 7 new members were brought into the church. Since then others have been added and many new people have attended services. They are expressing interest in becoming members. A new group will become members soon. Attendance at services has increased throughout the year.

Also, the First Sunday Breakfast attendance has increased from 55 in January to approximately 70 + in December. These breakfasts allow time to have fellowship with each other and introduce Trinity to people we have not met as a caring and fun place.

In September a group of ladies got together to make appetizers for St. Stephens Lutheran Church in Antioch. The church was closing and serving this to them after one of their last services helped the members through their time of sorrow at the closing. Since then a few of their members have visited Trinity on Sundays. St. Stephens has graciously donated the hand bells and equipment to Trinity. These were used on Christmas Eve. THANK YOU St. Stephens.

During the year 3 funeral luncheons were served for members families and 2 luncheons served for non-members families.

Special Fellowship Dinners were served during the year:

Easter Breakfast served 110 people

Corned Beef Dinner and Auction served 130 people (Donation to Madagascar Mission)

Forth of July Picnic served 75 people

Gratitude Sunday Turkey Dinner served 90 people of which 20 or more were from the Food Pantry

The Craft Fairs in April and October had 24 different crafters with 175 walk-in from outside. Most of the crafters were pleased with what took place and they will return for other fairs. One or two even attended Trinity services. Donations were given for E.L.C.A Disaster Relief as well as Ukraine Relief.

Vacation Bible School added simple dinners to the schedule. This allowed families to easily attend VBS without having to prepare dinner at home. The helpers also enjoyed the chance to eat before things started.

A CPR class was initiated by the Wellness Group. The Fox Lake Fire Department taught the class to approximately 25 – 30 people. The community was invited to attend.

The Christmas Cookie Walk was a great success. The LOV group baked enough cookies to fill and sell 66 boxes of cookies with 2 dz. cookies in each.

The future looks bright thanks to the help and donations of many. The kitchen has been updated and now passes all Lake County Health Dept. regulations. We have obtained a license from them to operate as a fully licensed kitchen in Lake County. This will open up many new opportunities for Trinity in the future. Plans are being made to use the Fellowship Hall not only for members needs but to open it up to the community for many outside events. THANK You all who have helped to make this possible. Much time and effort has been put into the Fellowship and Service Ministry this year. Thank You to all.

## Financial and Facilities Team 2023 Annual Report

4 January, 2023

#### **Mission Statement:**

Goal: To bring about a sustainable financial path with engaged congregation members, equipped leaders, and managed facilities all supporting the Mission, Goals, and Ministries of Trinity.

#### **Project(s) Status:**

#### • Main Building/Grounds Maintenance:

- Open/New/ Projects :
  - In February we had to replace the pressure relief valve three times in the month. Temperature setting was lowered a bit and the last value continues to be operational.
  - Service call was placed with Huemann Water Conditioning to inspect the water softener since it seemed that it was not using as much salt as in the past. Unit check out ok but he found a sticky valve that was replaced and cleaned up the system.
  - We asked the Huemann serviceman if a filter in front of the water softener would make sense. He informed us that for unit the size of ours they usually do not because of the size of the jets and internal components.
  - Dishwasher in the kitchen was repaired to allow it to reach proper temperature to achieve sanitize/rinse. There are still issues with controlling the temperature as the unit is getting old and parts are difficult to find at times. Looking into cost of replacement.
  - Project to improve the areas used by the Avon Cares Food Pantry was completed. It included
    replacing two external doors to the Fellowship Hall, a buildup of the short wall separating the
    two spaces, acquisition of 7-foot-tall room dividers to provide flexible floorspace utilization, and
    installation of a utility sink to give the pantry cleanup facilities without necessarily using the
    kitchen. The entire grant of \$15,800 was completely used.
  - There are two safes that were not being used due damage to the smaller drop-box type and a lost combination for the larger Meilink. Both were repaired and have been put back in service.
  - Strip and Wax of tile floors in the basement was completed in May by Horn Cleaning Services.
     The work occurred over three day and happened without incident.
  - There was an issue with debris collecting the washroom faucet aerators. It seemed to be primarily with the hot water so the hot water tank was flushed aerators cleared and the inline water filter were changed out. Changing filters and flushing the system were added to a list of regular maintenance activities.
  - Ascension Lifts were contacted and their price for a one-story lift range from \$85K to \$95K for a self-contained unit that uses 110/120 AC, requires no pit and would fit in our existing shaft.
     Less expensive installations are available but are limited to home installs only.

•

- While the kitchen has received its certification from the health department there are still several
  items that need to be worked on. The health department wants non-porous material to be used
  around the sink areas and the pantry. This work is still in process. The range hood failed that
  last inspection and we are looking into a new fan. We will likely need someone to engineer and
  install the larger fan.
- The annual spring cleaning was accomplished and included not only mulching the usual areas but also significant trimming of the bushes around the building and cutting back of the weeds. Additionally, some new low maintenance plants were donated and planted near the front entrance to the church.
- New two-sided signage for the church hallways was acquired and used to simplify directions for members and visitors.
- A second AED unit (Automated External Defibrillator) was purchased and installed in the Fellowship Hall. The first AED unit is in the Narthex. In addition, each of the AED units has a Narcan nasal spray stored in it. Narcan is used to reverse the deadly effects of opioid / fentanyl overdose – 911 must still be called.
- The Xerox copier was replaced as it was breaking down frequently and causing our Office
   Manager to need to work extra hours to recover. The new copier is a Kyocera copier/printer
   that will provide a lower cost solution than the old copier. We have also implemented job
   accounting on the new system that will allow us to track and charge back usage if Shepard of the
   Lakes decides that they have a use for printed materials.
- Replaced lock and door knob on exterior door in kitchen after it was vandalized on Oct 13<sup>th</sup>.
   Police report filed and extra drive throughs by Lake County Sheriff department are being done.
- A spreadsheet has been created to enhanced a means to track tasks that need to be complete
  by Routine Maintenance, Immediate Maintenance, and planned Budgeted Projects. The hope is
  that this will allow the Facility Team keep track of various tasks and problems so those items
  don't get missed.
- Roger Ray Heating and Cooling was called in to do the annual inspection/service of the heating and cooling units. It was done in 12/7.

#### TYS Building:

#### Open/New/ Projects :

- A light fixture fell out of the ceiling and shorted the connecting wires (intermittent arcing). The
  police training unit called it in and shut off the power to that room. Tom Atols dropped the
  fixture and capped off the wires.
- Building used bi-weekly for canine training by Lake County Police and Fire services.
- Windows have been opened to provide ventilation and prevent further mold/mildew growth.
- A new water leak was detected in the main chapel area of the building. The roofing contractor did the repair and we have not seen evidence of leaks.
- Scrub trees and bushes were cleared from the east side of TYS building to improve airflow and minimize mold growth on the siding.
- All restoration/repair activities are on hold for TYS until the disposition of the building is determined.
- Signs installed directing mail and package deliveries to the main church. An additional large sign
  was placed in the parking lot in front of TYS to direct people to the church and Food Pantry.
   Mis-deliveries have seemed to decrease.

#### • **Utilities Management:**

- Food Pantry is reimbursing Trinity approximately 1/3 of our total electric bill For the operation of their equipment. Their payments are currently up to date.
- All thermostats set to 'Auto' for the current heating/cooling season.
- MidAmerican Energy (electric) terminated support and we moved back to ComEd. The rate for kWh's was lower from ComEd than MidAmerica at the time of the cutover. Of course, rates in general increased significantly.

#### • Telecom/Network

- Remote access has been set up for the office PC to allow our Office Manager to work from home.
- There were several issues with the new office PC which caused it to overheat and lock up making remote access unreliable. A new PC has been donated and is planned to be installed by January 2024.
- The ProcessMetric system was implemented to improve the manual processing of the old manual Purchase Order system. Requests for payment for various services has been improved significantly and our Office Manager had a significant workload lifted allowing her to do other more important tasks.
- Project plan for the restoration and resynchronization of the Carillon system is to move it to the
  upper level of the TYS building where it's dry and the system can be cleaned and repaired
  outside of the damp basement environment. This is not currently scheduled.

#### To reach the community:

- Facebook posts had a paid "boost" for numerous events throughout the year, including craft shows, Easter worship times, Christmas worship times, and Vacation Bible School. Ash Wednesday Ashes-to-go information, and Corned Beef & Cabbage Dinner.
- Many thanks to the volunteers who change the outside sign on a weekly basis. Especially Pastor Dan!
- Outside vinyl banners for Christmas, Easter, VBS, Craft Shows, Corned Beef
- Did an Easter Advertisement in the Daily Herald

#### **Metrics:**

MailChimp (weekly Connections newsletter)

• We have 231 subscribers, averaging a 55% open rate

#### **Facebook**

- Did Christmas "ad" which had 3,528 impressions (the number of times it was seen), 1,641 reach (the number of unique people who saw the post), and 101 engagements (the number of people who engaged through reactions, comments, shares, and clicks).
- We now have 420 followers. 23.5% men, 76.50% women. 28% are over the age of 65, 15% between 55-64, 13% between 45-54, 11% between 35-44, 5% between 25-34, 2% 18-24, with the balance 26% unknown.
- Livestream we typically have 8-10 people on Facebook. This past Sunday was very cold and we had a perhaps all-time high of 16 people on livestream. Remember that many people watch the service at times other than the live timing. This number doesn't account for those who watch, for example, on Sunday evening.

#### YouTube

- 50 subscribers
- We average 14.4 views per week We had 20 views on Christmas Eve Service. As a reminder, we livestream to 3 locations: youtube, facebook, and our website. This metric is for youtube only.

#### Website

- 40 subscribers
- 2877 total visits last year graph below shows recent increase in visitors
- We average 240 visits per month
- The livestream portion of the website shows about 87 views per month, 25 unique visitors. Also, 21% watch live whereas 79% watch recorded.

But, if you "share" it, then it goes into your Facebook feed which greatly increases its visibility.

There was one proposal submitted by the Outreach Committee requesting funds for purchasing gifts from the remaining Giving Tree ornaments. It was approved and reimbursement made from the Undesignated Funds category.

Committee meetings will resume early in 2024.

Although Trinity has encouraged the focus of donations be limited to four (4) categories: Christian Education; Facility Needs, Worship & Music, Outreach & Care, as well as the Endowment Fund, it is in Trinity's best interest, to also accept memorial gifts to the General Fund and the Emergency Fund.

Gifts to the Endowment Fund can be made in memory/recognition/honor of, just as they can be made to the Memorial Fund. The difference is that the Endowment Fund is an investment in Trinity's future, providing for our long-term mission and ministry needs, and we can only spend the earnings on an annual basis. Gifts to the Memorial Fund can be made to the four designated areas mentioned above. Both the principal and interest can be spent on approved projects.

### **2023 Financial Highlights**

- \*\*\* June 2023 Financial audit was completed by Don Day and Mary Williams
  - A detailed report was made available to the congregation for review and a list of suggested actions was presented to the council.
  - As a direct result of the audit, the following process improvements have been implemented:
    - A process was put in place to track all approvals on expenditures using the new Payment Authorization process.
    - The office safe was repaired and all monetary amounts being held overnight are now locked in the safe.
    - The church records safe was repaired and documents are now stored per synod guidelines.
    - Several other suggestions (mostly process changes) were beyond our current scope or our abilities at this time but are still on the plate for the new 2024 council to pursue.
- \*\*\* We entered into a pastor-sharing agreement with Shepherd of the Lakes church! First of its kind in this area!
- \*\*\* We were running over \$30,000 behind budget in 'Giving' income for the year ... prayers were answered, and we were able to access approximately \$39,000 sitting in a PayPal business account that we didn't know we had access to leaving our net income in the black for 2023.
- \*\*\* Our mortgage balance is currently \$889,047.60

We paid \$51,876.62 in interest this year at an interest rate of 5.95% and our loan should mature in December of 2037.

## **Availability of Audit Report**

An audit committee was appointed consisting of three members of the Congregation. Trinity Council would like to express their extreme gratitude to Don Day, Mary Williams and Sam Kong for the effort and time they spent on doing an extensive audit of Trinity procedures, processes and bookkeeping. There were several areas of concern identified by the audit and we will begin addressing them as resources are available.
