Novice A/B Open Certificate of Gameness Certificate of Gameness Advanced

Novice A: Open to dogs & bitches under 12 mo of age that have not earned 100% in the Novice Class.

Novice B: Open to dogs & bitches 12 mo of age & over that have not earned 100% in the Novice class.

Open: For dogs and bitches that have not yet earned a pass in Open (ie have not earned the Certificate of Gameness) a pass in Open gives you a "bonus run" in Certificate of Gameness!

Certificate of Gameness: For dogs and bitches that have passed the OPEN class and received the Certificate of Gameness Award. This class is provided for dogs that live in areas where natural quarry is limited or nonexistent or have participated in other Earthdog events. When a dog scores 100% in the Open Class, he earns the Certificate of Gameness. The AWTA keeps a record of every dog that earns a Certificate of Gameness. After being issued the Certificate of Gameness a dog is eligible for the Certificate Class only and cannot be entered in any other class.

Certificate of Gameness Advanced: Open to dogs and bitches that have earned the Certificate of Gameness. This class is provided for dogs that live in areas where natural quarry is limited or nonexistent. The dogs will compete for High Scoring in Breed against each other in a miscellaneous category. Dogs entered are working for qualifying scores in 5 Certificate Classes. Handlers should keep track of the classes entered trial name, location and date of trial, to be submitted to AWTA Trial Secretary for verification upon receiving a passing score in 5 Certificate classes/

Novice Tunnels are 10' with one 90 degree turn. The Open Tunnel is 30' long with three 90 degree turn. The Certificate Class Tunnel can be any configuration that the judge deems challenging including addition of materials and other challenges.

Fees:

AWTA Membership: \$20.00 Single \$25.00 couple (membership not required to compete) however, upon dog qualifying 100% score in the OPEN class, handler has 30 days to become a member to receive the Certificate of Gameness Award.

Pre-Entry: Novice A & B: \$22.00 Open & Certificate: \$25.00

Day of Trial Entries: Novice A & B \$25.00 Open & Certificate: \$30.00

Eligibility:

The AWTA recognizes these breeds for competition in den trials: Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Fell, Fox, Glen of Imaal, Jack Russell, PRT, Russell, Lakeland, Norwich, Norfolk, Patterdale, Scottish, Sealyham, Skye, Welsh, and West Highland White terriers, Jagd terrier and Dachshunds. Any individual Feist, Rat terrier, terrier cross, dachshund cross or terrier of a breed not mentioned above who is of suitable size to fit in a nine inch artificial earth may also be entered in den trials.

Any entry received after 5 PM October 23rd will be considered "day of trial entries" No entries or move ups will be accepted once Orientation begins. Times listed are approximations. Awards

Novice: A ribbon is to be given to each dog that qualifies in either Novice A or Novice B

Open: A ribbon and a flask are given to each dog earning a qualifying score

Certificate: Ribbons may be given to the top qualifiers by breed or category, in the Certificate Classes

Top Performance in Division: Ribbon to the dog the Judge would take hunting today.

Additional Information:

Dogs in all classes will be run in the order in which the entries are received.

Multiple entries by the same owner will be separated to expedite a smooth running of the tests.

Running Order will be posted.

Dogs not ready to run when called will be moved to the end of the running order.

Orientation prior to judging of each class will be given by the Judge.

Bitches in season shall not be eligible to enter test. If the bitch comes in season after entries are received, entry will be refunded.

If the dog qualifies of the Certificate of Gameness Award, owner needs to be a member of AWTA within 30 days of the trial date in order to receive the award.

Membership form will be available at the trial desk.

Tests will be held rain or shine. Bring protection from the elements.

Water and snacks will be provided for workers. The event will break for a pot luck lunch at the discretion of the judge and based on entries. Bring your best dish!
