 - Drainage issues in the neighborhood was discussed. New Castle County Conservation District should be contacted.
 - Deborah Heffernan is a member of the finance committee
 - The legislature passed a bill allowing for e-prescribe for controlled medications effective January, 2021. Medicare will require this soon. This will help control the issue of controlled substances that contribute to the opioid crisis.
