

## Village of Hay Lakes BYLAW NUMBER 03-2020 2020 TAX RATE BYLAW

A BYLAW OF THE VILLAGE OF HAY LAKES IN THE PROVINCE OF ALBERTA TO authorize the rates of taxation to be levied against assessable property within the Village of Hay Lakes for the 2020 Taxation Year.

WHEREAS the Village of Hay Lakes has prepared and adopted detailed estimates of municipal revenue and expenditures as required, at the Special Council Meeting held on May 28, 2020;

AND WHEREAS the estimated municipal expenditures and transfers set out in the budget for the Village of Hay Lakes for 2020 total \$2,285,552.00;

AND WHEREAS the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$1,893,902 and the balance of \$391,650.00 is to be raised by general municipal taxation;

## AND WHEREAS the requisitions are:

Alberta School Foundation Fund (ASFF)

Residential \$119,930.00

Non-Residential \$7,655.00

Designated Industrial Properties & Linear \$ 45.39

AND WHEREAS the Council of the Village of Hay Lakes is required each year to levy on the assessed value of all property tax rates sufficient to meet the estimated expenditures and the requisitions;

AND WHEREAS the Council of Hay Lakes has established a minimum tax levy of \$750.00 on any property within the Village of Hay Lakes;

AND WHEREAS the assessed value of all property in the Village of hay lakes as shown on the assessment roll is:

NOW THEREFORE the Council of the Village of Hay Lakes duly assembled enacts as follows:

1. That the Municipal Administrator, or designate, is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Hay Lakes:
