Greg Brown called the meeting to order at 7:05 pm.

### 1. Election of Officers

Janet Cypra moved for the election of Greg Brown as President; Nadia Wendt seconded; all ayes.

#### 2. Meetings for the Year

# 3. Payment for Drexwood Stairs

The Board approved the payment for the Drexwood stairs project and release of the check.

#### 4. New Business

# Beverly Shores Park Board July 8, 2014 Administration Building

President Greg Brown called the meeting to order at 7:07pm.

# 1. Approval of May 13, 2014 minutes.

Janet Cypra has the minutes but could not make the meeting so the issue was tabled until the August 2014 meeting.

# 2. Public Applications or Requests.

- A. A charity bike ride that will run from Grand Rapids to Chicago has request the use of half of Rebora Plaza on Tuesday September 9. They have been asked to fill out the Use Form and then the board will officially discuss. They will be asked to pay the \$100 use fee.
- B. A wedding party would like to use Rebora Plaza on Saturday September 6 for their ceremony. They have been asked to fill out the Use Form and then the board will officially discuss. The party has the approval of the town Marshall.

#### 3. Old Business

- **A. Handicapped accessible deck at Rebora Plaza.** The board will move forward with obtaining an estimate and then three quotes.
- **B. Tennis Courts.** Greg reported that the cost of power washing, grinding and filling in the cracks, painting and striping would be \$3,500 \$5,000. It was agreed to try to find funding sources such as Capital Planning and make this happen early next spring.
- **C. Chimney Cap.** A protective chimney cap was installed on the warming hut.
- **D. Drexwood Kayak Rack.** A kayak rack was installed at Drexwood Beach.
- **E. Boat Audit.** A boat sticker audit will be conducted to check for sticker and storage compliance.

#### 4. New Business

- **A. Use Forms.** Discussion was had that there are many versions of Use Forms for both Rebora Plaza, Lituanica Park and for watercraft. It was agreed that three new forms be created that merge the previous forms. Two new forms will cover all park properties with one being for residents and one for non-residents. The third form will be for watercraft permits.
- **B. Maintenance Issues.** The following issues were brought to the board's attention. Greg agreed to take the lead in resolving each issue.
  - **i. Rebora Plaza Drinking Fountain.** The Fountain will not shut off and needs a new valve.
  - **ii. Rebora Plaza Drains.** Both stormwater drains in the parking lot are clogged with sand and need to be cleaned out.
  - **iii. Drexwood Boat Signs.** The boat signs from Shore Avenue Beach need to be moved to Drexwood Beach.
- **C. Reimbursement Request.** Greg Brown asked that he be reimbursed for expenses incurred for the chimney cap and Drexwood Avenue Beach kayak rack. Both projects had been previously approved and the work was done within budget. Nadia made a motion to approve reimbursement and Rafi seconded. Approved unanimously. Thanks Greg for all your work!
- **D. Fires on the Beach.** Cynthia brought up a situation that recently occurred where a National Park Service officer told a group of Beverly Shores residents that fires were not allows on the beach. Discussion was had and it was agreed that Greg would have a meeting to discuss the situation with the head of security at the National Park Service. He will research town documents as well. As park of the meeting, he will also suggest that the beach boundaries be remarked for clarification for all.

The rack will be removed for the winter to prevent damage caused by winter storms. The rack will be reinstalled in the spring of 2015. The board will also request in the same email that all boats in the marram grass at Shore Beach be removed by October 31 as Shore Beach is currently closed to all boats not stored in the kayak rack.
