

Synopsis of July Board Meeting

The July Board meeting convened in the Home Office in Gahanna on July 19 and 20. Mr. Ed Mertz of Hosack, Specht, Muetzel and Wood LLP presented the 2009 Audit Report to the Board. Being his first report, Mr. Mertz complimented the office staff on the ease of working together. A plan of action was discussed to reduce the lien that was placed on all policies in 2009.

Loni Perkins, Vice President of Operations, reported that the Ohio Department of Insurance recently completed their audit. These audits are done every 3 to 5 years by the ODI. CLC received the Management letter and the Board discussed at length our response to their requests. One of the things we need to do is form an Audit Committee. It was decided to utilize the current Financial Status Committee named for the previous convention. They will be our new Audit Committee and Board member Alice Teynor will serve as the chairman of the committee. Formal policies and procedures need to be established for a couple of different areas of concern and Loni will be working on them for the ODI.

It was reported that life insurance sales are down slightly and annuity sales were down in number but the face values have increased.

Sharon Calvelage and Loni recently met with Ed and Nick De-

Persis and discussed several different things regarding our annuities. The Board decided to keep our annuity rates as is for the time being. Because the best rates for investment are now in the taxable municipal bonds, the Investment Policy Guidelines were reviewed and updated.

Fraternal reports included: CLC has given out 7 matching funds thus far this year; 11 councils have asked for a charitable contribution of \$250 each; over \$1,100 has been raised for the Epileptic Foundation for our Join Hands Day Project; a letter will be going out with our plans for the Make A Difference Day project on October 23 and the Fall Retreat on October 14; coloring contest and fraternalist of the year winners were announced and our total donation to the Right to Life was \$3,761.

An agent newsletter has been created and will be sent to all agents. It is the intention to send electronically when possible to save on postage. The newsletter will highlight products CLC offers and is a way of staying in touch with our agents.

The meeting schedule for the rest of 2010 and 2011 was set. The Board will next meet in Upper Sandusky on Saturday, October 30.
