AN ORDINANCE

Adopting and Amending ordinance No. 2018-64 (Permanent 2019 Appropriations) by appropriating from unappropriated funds in the General Fund, Beautification Fund, Water Fund, and Sewer Fund and declaring an emergency.

BE IT ORDAINED by the Council of the City of Fostoria, Seneca, Hancock, and Wood Counties, Ohio:

SECTION 1: That ordinance No. 2018-64 (Permanent 2019 Appropriations) passed December 18, 2018, be, and the same is hereby amended as delineated in the following sections:

SECTION 2: That Four Thousand Dollars (\$4,000) be appropriated from unappropriated funds to 101-150-500110 General Fund/Security of Persons and Property-Traffic/Personal Services-Full Time Salaries.

SECTION 3: That Three Thousand Dollars (\$3,000) be appropriated from unappropriated funds to 101-400-500110 General Fund/Community Environment-Zoning/Personal Services-Full Time Salaries.

SECTION 4: That Five Hundred Dollars (\$500) be appropriated from unappropriated funds to 241-499-500130 Beautification Fund/Community Environment-Community Development/Personal Services-Part Time Salaries.

SECTION 5: That Thirty Thousand Dollars (\$30,000) be appropriated from unappropriated funds to 241-499-561860 Beautification Fund/Community Environment-Community Development/Other-Refunds.

SECTION 6: That Seventeen Thousand Five Hundred Dollars (\$17,500) be appropriated from unappropriated funds to 501-510-531700 Water Fund/Basic Utility-Water Plant/Contractual Services-Other Contractual Services.

SECTION 7: That Twenty Thousand Dollars (\$20,000) be appropriated from unappropriated funds to 501-515-541310 Water Fund/Basic Utility-Water Distribution/Materials and Supplies-Meters.

SECTION 8: That Nine Thousand Five Hundred Dollars (\$9,500) be appropriated from unappropriated funds to 501-515-561870 Water Fund/Basic Utility-Water Distribution/Other-Water Deposit Refunds.

SECTION 9: That Forty-Five Thousand Dollars (\$45,000) be appropriated from unappropriated funds to 520.520.531700 Sewer Fund/Basic Utility-Wastewater Treatment Plant/Contractual Services-Other Contractual Services.

SECTION 10: That this ordinance shall be published in accordance with applicable Ohio Law.

SECTION 11: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 12: That in order to preserve the public peace, health, safety and welfare of the City of Fostoria and its inhabitants, and in order to make the appropriation adjustments in the Permanent 2019 appropriations without delay to meet pending obligations, this measure is determined to be an emergency ordinance and shall take effect at the earliest time allowed by law after its passage.




