Minutes of July 19, 2021

The Huntington Township Trustees met in special scheduled session at 6:45 PM at the Township Hall. Meeting purpose was for a Public Hearing on the proposed 2022 budget. The meeting was called to order with the pledge of Allegiance by Robert Holmes. Also present were Walter Rollin, Jed Lamb, Dennis Finkel, Frances Rollin, Mathew Combs, Dimitri Szynal and Sheila Lanning. The 2022 proposed budget was presented, hearing no questions on the budget the public hearing was closed on a *Motion* by Holmes with a second by Lamb at 6:52 PM. Roll call: three yeas.

The regular scheduled meeting was called to order at 7:00 PM by Robert Holmes with the pledge of allegiance. *Motion* by Rollin with a second by Lamb to approve the minutes of the regular scheduled July 5, 2021 meeting as written. Roll call: three yeas. Checks 9586-9605 and payments totaling \$76,810.89 approved for payment. *Motion* by Holmes with a second by Lamb approve *Resolution 2021-42* authorizing the 2022 Budget as presented. Roll call: three yeas. *Motion* by Lamb with a second by Rollin to authorize the MOU for the Storm Water Mini Grant award of \$4,850.00 for culvert #656 repair/replacement. Roll call: three yeas.

COMMITTEE REPORTS:

WATER BOARD- Lamb: Attended the quarterly meeting at Put-N-Bay. Presenters included a new social media person with another district. Some things changed with COVID and some are back to normal. Low flow devices decrease quantity of water needed. Board meeting had the most [people in attendance. Asked about paperless option. You can pay now with credit card and doesn't cost anything.

LORCO- Lamb: missed the meeting but believe it went ok.

AMBULANCE- Holmes: June responses in Huntington = 18 with 7 of those coming from the satellite office, 63 total year to date responses in Huntington with 39 coming from satellite office.

SHERIFF- none

FIRE- Rollin: Chief Wetherbee in Columbus for State wide Fire Chief Conference last week. Grant for tables and chairs in conference room. Room also painted. The open house will be in September.

SWAC- MOU mini grant signed.

ZONING BUSINESS/NEWS- Finkel: Zachary Seastorm questions on solar questions, Zoning Commission should take a look at solar.

THRIVE & OFFICE ON AGING- Rollin: They have money to deal with and the meeting 7/26 is in person.

ROADS and EQUIPMENT: Finkel: roads not too bad, a little bleeding. Did not have to put up any high-water signs with recent rainfall. Rollin: Emergency Management sent notice: let them know if anyone needs help due to flooding. Finkel: old Gradall is ready, new Gradall needs center pin replaced. Worked on it today but need new center pin top, going to Cambridge tomorrow for used part. *Motion* by Holmes with a second by Lamb to approve up to \$750.00 for a center pin top for the new Gradall. Roll call: three yeas. Finkel: the old pressure washer broken, will need new burner that costs \$1,998.00 plus shipping. Discussion on fixing the old pressure washer or purchasing a new one. *Motion* by Rollin with a second by Holmes to authorize purchasing a new pressure washer from 3R Sales & Services for \$6,292.00. Roll call: three yeas. Holmes: find out the warranty on the pressure washer.
