# The Junior Doubles Tournament-FORMAT 

Separate U20 boys, U20 girls, U15 boys, \& U15 girls divisions

## Qualifying Round

1. Each individual on a team will bowl 5 games of regular, 10-pin bowling.
2. The 5 -game series scores of each team member will be added together to determine the team score.
3. Based on the team score, the top 16 U20 boys teams, top $8-12$ U20 girls teams (depending team entries) and top 4-8 U15 boys and U15 girls teams (depending on entries) will advance to the Championship Round. Qualifying Round scores will be dropped.

## Championship Round

Championship Round teams will compete in a Baker-format head-to-head, best 2 of 3 game single elimination bracket until the winner is determined.

## Baker game procedure

1. All Baker games will be bowled on a single lane by each team.
2. In each head-to-head match, the higher seeded team may select their starting lane.
3. Teams will bowl 1 entire game on a lane and then switch to the other lane on the same pair for each subsequent game.
4. One team member will bowl frames $1,3,5,7,9$. The other team member will bowl frames 2,4,6,8,10 in each Baker game.
5. In all Baker games, a team may change their order of bowling at will prior to the start of any game.

A tie in any Baker game will be broken by a $9^{\text {th }} / 10^{\text {th }}$ frame roll-off bowled on the same lane as the tied game using the $9^{\text {th }}$ and $10^{\text {th }}$ frame bowlers in the same order as used in the tied game. This process will be repeated, if necessary, until the tie is broken.
