1. I certify that the above-described Labradoodle is of sound health at the time of sale. Said puppy comes with a 2-year genetic health guarantee for PRA (eyes), EIC (exercise induced collapse), Elbow Dysplasia, vWD and Hip Dysplasia. We will replace the dog if any of the above mentioned occurs with a dog from another litter of equal value, when available at no charge other than shipping or 50% of the purchase price will be refunded. 2. We must receive written proof from a licensed DVM. We also retain the right to have a 2nd opinion at our expense. The buyer must have puppy examined by a competent veterinarian of their choice within 3 days of the date and time of delivery for a well puppy exam. If there are any concerns buyer must notify seller within 48 hours of Veterinary appointment. Initial \_\_\_\_\_

3. Current age appropriate vaccinations, worming, microchipping, spay/ or neuter (or spay/neuter contract), medical records, Registration from the Australian Labradoodle Association of America, a sample bag of puppy food and a leash and collar. Initial \_\_\_\_\_

4. Buyer understands and agrees that Puppy is sold as a companion pet only, **NOT FOR BREEDING PURPOSES** if he/she was not spayed prior to pick up. Buyer agrees this Puppy/Dog will be spayed, neutered or surgically sterilized under the following terms and conditions, including liquidated damages:

- a. Buyer agrees to spay/neuter or surgically sterilize Puppy by six (6) months of age and to provide proof of spay/neuter/sterilization to Seller within thirty(30) days of the surgery.
- b. Documentation must be in writing from a certified Veterinary Hospital and contain puppy's description, breed, microchip number, date and the surgery performed.
- c. If Buyer fails to spay/neuter/sterilize Puppy by 7 months of age and furnish proof of same to Seller within thirty (30) days, then Buyer shall pay Seller damages in the amount of Ten Thousand Dollars (\$10,000).
- d. In the event that Buyer intentionally or negligently breeds Puppy/Dog (or allows Puppy/Dog to be bred, then Buyer shall be in breach of this Contract and be liable to Seller for costs and fees required to legally enforce the terms herein.
- e. Jurisdiction will be the State of California , County of Kern.

5. If within 3 days of this date, the puppy should become ill, you may return the dog and get a full refund or a new dog. However if buyer takes the puppy to the vet, during this period or incur any expense, the seller will not be responsible for any vet bills unless prior consent is given in writing. 6. Your new puppy will have been seen by a veterinarian, have a health check up with a clean bill of health, appropriate shots and be wormed prior to your receiving the puppy. Initial\_\_\_\_\_

7. We ship the dog (if required) at the buyer's expense. That includes brand new crate (Help with crate training in puppy stage), transportation to the airport, airline ticket, and a health certificate. Initial\_\_\_\_\_

8. If said puppy needs to stay later than the pickup date of 8 weeks of age, a \$35.00 per day charge will apply for the proper food and care needed for the puppy. Initial\_\_\_\_\_

9. Acceptable payment methods are cash, cashiers checks, bank transfer from Quickbooks invoice or money orders. Please add 7.50% to your final payment for California Sales Tax. 10. We make every possible attempt to provide you with a healthy puppy to be your forever companion. We go over and above on health testing our breeding dogs, and take great pride in utilizing the latest health testing that is available to us as screening tools for a variety of genetic diseases and conditions. Despite extensive health testing and careful breeding selections, there are medical issues which cannot be tested for and cannot be foreseen and therefore are **not** covered. Congenital Conditions (conditions that are **not** genetic or hereditary) are not covered under your health guarantee. We do not cover cosmetic issues such as, underbite, overbite, base narrow canines, as well as other slight dental defects. Most will self correct as the dog grows and the baby teeth fall out and the adult teeth come in. Same goes for umbilical hernia, or an retained or undescended testicle. A pup many have a minor hernia but close over time on its own or it might not and would need to be closed at the spay/neuter appointment, same for the undescended testicle. We do everything within our control to provide you with we can to have the healthiest and happiest Pampered Pooches here at Hale's Australian Labradoodles.
