Fire Chief's Report

Statistics. For the month of January 2012, Rye Fire responded to 27 (2 fires and 25 EMS) calls for service. In comparison with previous years this is a 37% decrease from 2011 (43) and a 44% decrease from a five year average of 48.

Becker Road Fire. On February 2, fire units responded to a structure fire at 5425 Becker Road. A portion of the stovepipe from a wood stove had failed causing an ignition on the rafters in the attic. Fire was contained to a 10' x 10' area in the ceiling / attic.

Old Business

East Hatchet Ranch Inclusion Update

This update also included West Hatchet Ranch Inclusion. Ms. Eiland noted that both inclusions are going forward at the same time. The plans will be filed by March 14th. The District will be mailing ballots to the addresses on file with the County Assessor's Office. Ms. Eiland noted that the election date is May 8, 2012 and not May 1 as previously noted.
