Dr. Hayes currently operates a single doctor private practice limited to orthodontics, is a Clinical Instructor in the St. Louis University Department of Orthodontics, and has presented lectures pertaining to Class II correction on 4 continents. He has authored multiple articles pertaining to this subject and serves on the Editorial Advisory Board of Orthotown Magazine.

#### **The Empowered Orthodontist: Harnessing Technology from Scanners to Social Media to Self-Ligation**

We are practicing during an amazing time in the history of orthodontics. New technologies are emerging daily. Some of these innovations are merely hype, while others are incredibly powerful tools to improve the quality of our clinical care as well as our practice management efficiencies and effectiveness. In addition, patients have more choices available to straighten their teeth. Some patients are choosing to have orthodontics done by the large corporate office down the road, others by their primary care dentist, and some are even getting aligners by mail! With all of these available choices, why should they come to you for their orthodontic care?

This lecture will dive deep into the use of technology to get patients into your office, optimize the overall patient experience, improve clinical outcomes and efficiencies, and simplify the day-to-day management of the orthodontic practice. Most importantly, this lecture will empower you to implement proven, technology-based strategies to differentiate your practice and to help patients and potential patients realize that you are the obvious choice for their orthodontic care. #### **Simplified and Evidence Based Class II Correction in the 21<sup>st</sup> Century**

Class II correction appliances have been utilized in orthodontics for well over 100 years. Class II fads, theories, and protocols seem to come and go and then come back again. This lecture will take a brief historical look at Class II correction appliances through the years up to the current day. It seems that the only thing that is certain when it comes to Class II correction with fixed or removable appliances is that it is and has always been highly controversial. This lecture will provide an evidence based look at Class II correction focusing on the biomechanics of Class II treatment with the PowerScope Class II Corrector. Dr. Hayes will demonstrate a wide variety of Class II correction cases from straightforward Class II and asymmetry cases as well as unconventional uses such as the use of Class Correctors as mini screw alternatives, space closure for dental substitution and space opening aids prior to dental implants.

#### **Palatally Impacted Canines: Open Your Eyes to Open Eruption**

Unfortunately, open eruption for the treatment of palatally displaced canines is the best kept secret in all of orthodontics. In this lecture, Dr. Hayes will provide insight into this commonly misunderstood method for quickly, easily, and almost painlessly bringing in those tough palatal canines. If you have ever had a bad experience with open eruption, have been hesitant to try it, or just don't understand what the excitement is about, this lecture is for you! This will address the conventional open eruption procedure and treatment mechanics and also introduce a new flapless surgical treatment protocol that patients (and surgeons) are loving!
