Pakistan inflation rockets to record 37.97 percent

Pakistan's year-on-year inflation hit a record 37.97 percent in May, official data revealed, with the nation on the brink of economic collapse and crucial bailout talks stalled.

Non-perishable foods and transport costs climbed more than 50 percent over May 2022, while average inflation for the past 12 months was 29.16 percent, the latest Pakistan Bureau of Statistics data showed.

"This level of inflation badly affects poor and middle-class families of the country, whose income is evaporating with each percentage point," said Mohammad Sohail, a financier in Karachi.

Years of financial mismanagement have pushed Pakistan's economy to the limit, exacerbated by a global energy crisis and devastating floods that submerged a third of the country in 2022.

A political crisis has added another layer of uncertainty -- with opposition leader Imran Khan's brief arrest last month sparking deadly street violence and a days-long state-ordered mobile internet blackout.

In the background, negotiations to unlock a crucial tranche of a \$6.5 billion loan deal agreed with the International Monetary Fund have been deadlocked for months.

Pakistan needs billions of dollars in financing to service staggering levels of external debt, and foreign exchange reserves have dwindled to just \$4.2 billion, barely enough for a month of imports.

Elections are due no later than October, and the government has already bowed to IMF demands to end popular subsidies on gas and electricity which cushioned the cost-of-living crisis.

As per the press release, the weapon is of exceptional quality. It was created by Mughal swordsmiths using a German blade design that

was brought to India in the 16th century. Five qualities of God are inscribed in masterfully crafted gold lettering on the hilt, along with two invocations that specifically address God. The sword also has an inscription that reads, "Sword of the ruler."

Turkish President Recep Tayyip Erdogan has stretched his rule into a third decade

Turkish President Recep Tayyip Erdogan has stretched his rule into a third decade after Sunday's presidential election victory. His achievement, however, fell short of the city of Istanbul – a strategic and personal crown jewel the leader is determined to take back in 10 months' time.

Speaking on top of a campaign bus outside his Istanbul residence on Sunday, Erdogan sang to a crowd of cheering supporters and declared his next step – to take back the city in the March 2024 municipal elections.

"Now we have 2024 ahead of us," Erdogan said. "You understand what I am saying, don't you? Are you ready to win both Uskudar (a large district in Istanbul) and Istanbul in the local elections in 2024? Then let's not stop."

By winning back Istanbul, Erdogan means having it governed by a mayor from his Justice and Development (AK) Party.

Once the capital of the Ottoman Empire, Istanbul is today Turkey's largest and most populous city. It is the country's economic powerhouse and home to nearly 16 million people, a quarter of the Turkish electorate.

The city was for 25 years run by an Islamist -party – first by the Welfare Party, of which Erdogan was a member, and then by the AK Party – until the secular Republican People's Party (CHP) won its mayorship in 2019 under Ekrem Imamoglu. Before beginning his term as prime minister in 2003, Erdogan was himself mayor of Istanbul between 1994 and 1998.

A 52-year-old savvy businessman, Imamoglu is the city's 32nd mayor and ran as a prospective vice president to opposition candidate Kemal Kilicdaroglu in this year's presidential election.

Erdogan in 2019 quickly saw that he was up against a potential winner, said Berk Esen, an assistant professor of political science at Sabanci University in Istanbul.

"Imamoglu was the most formidable politician that the opposition camp has generated over the past two decades," Esen told CNN, "And him being very charismatic, very young, very energetic, was only a matter of time Imamoglu would defeat Erdogan."

Speaking Monday, amid celebrations for the 570th anniversary of the city's Ottoman conquest, Imamoglu was keen to remind Erdogan that even though he won the presidential election, he still fell short of victory in his beloved Istanbul.

The opposition beat Erdogan by nearly three points in both Istanbul and Ankara in Sunday's presidential runoff.

"If you've won an election and you're still saying Istanbul's name in your sleep, that's okay. It's fine to dream. But it won't be a reality," Imamoglu said in a speech during celebrations.

"Neither you nor your fabricated judicial decisions will ever take Istanbul over," he said, adding that the city "has become an exemplary world capital where all faiths and cultures live together" and it is also the "center of justice, tolerance and respect for the law."

Analysts said that Erdogan has taken a number of steps since 2019 to sideline Imamoglu, knowing that he would be the opposition's strongest candidate.

A 2021 survey by MetroPoll showed that, if there was a presidential election in which Erdogan and Imamoglu both ran, the latter would win nearly 50% of the votes whereas Erdogan would win close to 39%.

Last year, however, Imamoglu was sentenced to two years, seven months and 15 days in prison and banned from political activity for insulting Turkey's Supreme Electoral Council (YSK). Human Rights Watch had called the sentence "an unjustified and politically calculated assault on Turkey's political opposition in the run up to 2023 elections."

Imamoglu's lawyers have said they intend to appeal the verdict, but if the decision is upheld then the mayor would not be allowed to participate in public office.

Erdogan "sidelined the one figure who might have been able to beat him, Istanbul Mayor Ekrem Imamoglu," wrote Soner Cagaptay, senior fellow at the Washington Institute for Near East Policy, in Foreign Affairs magazine.

"As a result, Imamoglu had little choice but to stay out of the [presidential] race to avoid triggering a blanket ban that would also oust him from the mayor's office," Cagaptay said.

It was not the first time Erdogan had cracked down on CHP members.

Last year, Turkey's top court upheld a jail term against Canan Kaftancioglu, who heads CHP's Istanbul branch, on charges of insulting the president.

Esen says that "there is no question" that Erdogan wants to get rid of Imamoglu, but that it remains unclear whether he will do so by trying to appeal to the electorate in the 2024 municipal election, or whether he will "engage in an extra-legal operation to purge Imamoglu, to basically replace him with a state appointee."

It remains to be seen how Erdogan will take back Turkey's commercial and electoral center. From bringing back the country's quake-stricken south to revitalizing a plummeting economy, the leader still faces substantial challenges.

But the opposition, too, is in a poor shape.

"Following this election defeat, if the opposition parties do not get their house in order and continue to cooperate but in a very rational and a very strategic way, some opposition voters may get disillusioned and turn away from electoral politics completely," Esen said.

Speaking Tuesday at the Union of Chambers and Commodity Exchanges, Erdogan criticized the opposition's campaign promises, saying they were only made to "get through the elections."

"You have more than 10 metropolitan mayors, what have they accomplished in Istanbul? In Ankara? In Izmir? Go ahead and prove what they have done,"

Erdogan said. "I live in Istanbul and Ankara. I follow Izmir closely."

Apart from its strategic importance, Istanbul also holds personal value for Erdogan. It is where he was born and where he began his political career and continues to maintain a residence.

Erdogan's Istanbul mayorship "really springboarded him into national prominence." Esen said. "The statement of 'whoever wins Istanbul wins Turkey' is not an exaggeration."

Indian woman wrestler Hamida Banu rose to stardom in the 1940s and 50s, when the sport was still a male bastion. Her spectacular feats and larger-thanlife persona brought her global fame - but then she disappeared from the scene. BBC Urdu's Neyaz Farooquee traced Banu's story to find out what happened to the woman whom many call India's first professional woman wrestler.

"Beat me in a bout and I'll marry

That was the unusual challenge that Banu - then in her early 30s - issued to male wrestlers in February 1954, according to news reports from the time.

Soon after the announcement, Banu defeated two male wrestling champions - one from Patiala in northern Punjab state and the other from Kolkata (then Calcutta) in the eastern West Bengal

In May, she reached Vadodara (then Baroda) in the western state of Gujarat for her third fight of the year.

Banu's visit had the city in a frenzy, recalls Vadodara resident Sudhir Parab, who was a child at the time. Her arrival was advertised through banners and posters on lorries and other vehicles, recalls Mr Parab, who later became a feted kho-kho player.

Mr Parab says Banu was supposed to fight Chhote Gama Pahalwan, a wrestler patronised by the Maharajah of Baroda (wrestlers are often called Pahalwan in Hindi). But he withdrew from the fight at the last minute, saying that he wouldn't fight a woman.

So Banu fought her next challenger, Baba Pahalwan.

"The bout lasted one minute and 34 seconds, when the woman won a fall," the Associated Press reported on 3 May 1954. "And the referee declared Pahalwan out of her wedding range."

A newspaper clip showing a report on Banu's challenge to male wrestlers Hamida Banu presented a challenge: Beat her in a wrestling match and you could marry her Banu's reputation had been in the making for more than a decade by then. In 1944, Bombay Chronicle newspaper reported

that about 20,000 people came to a stadium in the city to watch a match between Banu and wrestler Goonga Pahalwan.

The fight was cancelled at the last minute after "impossible" demands by Goonga Pahalwan, which included more money and time to prepare for the match. The enraged crowd vandalised the stadium after the fight was cancelled.

By the time Banu arrived in Baroda, she claimed to have won more than 300 matches.

Newspapers called her the "Amazon of Aligarh", after the town in Uttar Pradesh state where she lived. A columnist wrote that one look at Banu was enough to send shivers down one's spine.

Her weight, height, diet all made news. She reportedly weighed 17 stone (108kg) and was 5ft 3in (1.6m) tall. Her daily diet included 5.6 litres of milk, 2.8 litres of soup, 1.8 litres of fruit juice, a fowl, nearly 1kg of mutton and almonds, half a kilo of butter, 6 eggs, two big loaves of bread, and two plates of biryani.

"She sleeps nine hours a day and trains another six," Reuters noted.

Accounts from Banu's surviving family members suggest that her strength, combined with the conservative attitudes of the time, made her leave her hometown of Mirzapur in Uttar Pradesh for Aligarh. There, she trained under a local wrestler named Salam

In a 1987 book, author Maheshwar Dayal wrote that Banu's fame attracted people from far and wide as she fought several bouts in Uttar Pradesh and Punjab.

"She used to fight exactly like a male wrestler," he wrote. "However, a few said that Hamida Pahalwan and male wrestlers would make a secret pact, and the opponent would deliberately

Banu also faced challenges from people who were infuriated by her public performances.

In Maharashtra's Pune city, a bout with male wrestler Ramchandra



Salunke had to be cancelled because the local wrestling federation objected, The Times of India reported.

Another time, Banu was booed and stoned by fans after she defeated a male opponent. The police had to step in and control the crowds, according to the newspaper.

In his book Nation At Play: A History of Sport in India, academic Ronojoy Sen examined how Banu's presence complicated the sport.

"The blurring of sports and entertainment in these events is illustrated by the fact that Banu's bout was to be followed by a bout between two wrestlers, one lame and the other blind," he wrote.

Mr Sen writes that Banu complained to Morarii Desai, then chief minister of Maharashtra state, about an unofficial "ban" on her wrestling bouts. Desai responded that the bouts had not been banned on grounds of her gender "but because of several complaints about the promoters, who were apparently putting up 'dummies' to challenge Banu".

Even as men mocked her accomplishments and questioned her credentials, Urdu feminist writer Qurratulain Hyder paints a different picture of Banu. In her short story Daalan Wala, Hyder writes of her domestic helper Faqira going to watch a wrestling

match in Mumbai and returning to say no one had been able to defeat "the lioness".

According to reports, in 1954, Banu defeated Vera Chistilin, known as Russia's "female bear," in less than a minute in a bout in Mumbai. The same year, she announced she would go to Europe to fight wrestlers there.

But not long after these heavily promoted fights, Banu appeared to vanish from the wrestling

By then, Banu and Salam Pahalwan had begun travelling regularly between Aligarh, Mumbai, and Kalyan, a town on the outskirts of Mumbai, where they had a dairy business.

Banu's grandson, Feroz Shaikh, says Salam Pahalwan, Banu's coach, did not like the idea of her going to Europe (Mr Shaikh's father was Banu's adopted son).

Sahara, Salam Pahalwan's daughter, says that he had married Banu, whom she considered her stepmother.

But Mr Shaikh, who lived with Banu until her death in 1986, disagrees. "She indeed stayed with

him, but never married him," he says.

"To stop her [from going to Europe], he beat her with sticks, breaking her hands," says Mr

This account is supported by her neighbour Rahil Khan, who says her legs were also fractured in the attack.

"I remember it well," he says. "She was unable to stand. It healed later, but she could not walk properly for years without a lathi [stick]."

Sahara, however, maintains that the relationship was cordial.

Eventually, Salam Pahalwan returned to Aligarh while Banu stayed on in Kalyan. Ms Sahara says Banu visited him once in Aligarh when he was on his deathbed.

Banu made a living from selling milk and renting out some buildings. When she ran out of money, she would sell homemade snacks by the roadside.

"Her last days were difficult," says Mr Shaikh, about the little-known athlete who fought fiercely against the norms of her

IPL 2023: Who are India's next cricketing stars?

The Indian Premier League (IPL), apart from being lucrative, has been an excellent platform for uncapped players to fast-track their careers into the international arena. Like past editions, this year too uncapped players have dazzled in the IPL, putting forward their case for a selection in Team India. Sports writer Sattwik Biswal takes a look at five such promising players.

Rinku Singh

Kolkata Knight Riders (KKR) finished seventh in IPL 2023 but their campaign was all about Rinku Singh. Each time he walked out to the crease, his team and fans expected him to finish games. He delivered that in some close run chases.



One such memorable game was against the Gujarat Titans. Leg spinner Rashid Khan had dented Kolkata's run-chase with a hat-trick. A win from that position looked far-fetched. But Singh had other plans.

When Kolkata needed 29 from the last over off Yash Dayal, a single off the first ball got Singh back on strike. The left-handed batter then hit five consecutive sixes to pull off a stunning win for Kolkata.

The KKR made the right call by retaining the 25-year-old for 5.5m rupees (\$66,521; £53,709) this season, however, his stocks are bound to rise when the next auction comes around.

In IPL 2022, Singh scored 174 runs from seven matches at an average of 34.8 and his strike-rate was 148.71.

This season, he played every match at the group stage and scored 474 runs at an average of 59.25 with a strike-rate of nearly 150.

He cut his teeth in domestic cricket by playing some 100 matches for Uttar Pradesh. With his stupendous show this season, Singh has definitely made a statement and his claim for a spot in the national side looks promising.

Tilak Varma

Left-handed batter Tilak Varma, who plays for Hyderabad in domestic cricket, looks good for an India call up The batting exploits of Tilak Varma this IPL have forced people to take note of his talent.

His reading of the situation and ability to take off from the word go has given solidity to Mumbai Indians' (MI) middle-order.

Despite missing out on the second half of Mumbai's campaign due an injury, Varma scored 274 runs from nine matches at an average of 45.67 and a strike-rate of 158.38.

Bought by the MI for 17m rupees, the left-handed batter, who plays for Hyderabad in domestic cricket, is a strong contender for an India call up.

"I would be very surprised if he does not play T20 cricket for India in the next six to eight months," former player and India coach Ravi Shastri told Star Sports.

"He's got the maturity, he's got the flair. He will make a world of difference to the Indian middle-order."

His Mumbai Indians captain Rohit Sharma also praised the 20-year-old's fearless cricket. "What I like about his game is his approach, he is not afraid," Sharma said.

"He is not playing the bowler, he is playing the ball, which is quite important for someone of his age coming out and playing the way he is."

Yashasvi Jaiswal

Yashasvi Jaiswal moved from Uttar Pradesh to Mumbai at the age of 12 to play cricket. He slept in tents and sold street snacks to earn money. He started at the famous Azad Maidan, a sports ground in the city that is often packed with children playing cricket.

His journey to the top began when he was spotted by a local coach at the grounds. Yashasvi Jaiswal celebrates after winning the IPL match between Kolkata Knight Riders and Rajasthan Royals on May 11

Yashasvi Jaiswal holds the record for most runs by an uncapped player in an IPL season



This year, the 21-year-old left-hander has taken this IPL by storm as an opening batsman for the Rajasthan Royals. The team failed to make the playoffs but Jaiswal finished with 625 runs from 14 matches, an average of 48.08 and a strike-rate of 163.61. He struck five 50s and one 100.

Jaiswal now holds the record for most runs by an uncapped player in an IPL season. He's also hit the fastest halfcentury in IPL history off 13 balls.

Jitesh Sharma

Jitesh Sharma, the wicketkeeper-batsman of Punjab Kings, had an impressive season in 2022. He played 12 matches for the team, scored 234 runs



at an average of 29.25 and a strike-rate of 163.63.

This year, Sharma created excitement with his batting ability while playing down the order. He finished IPL 2023 as the third-highest run-scorer (309 runs) for his team, while playing some crucial knocks.

Before the IPL, Sharma was part of

India's T20 side but didn't get a chance to make his debut.

His consistency and fearless batting has made former cricketers back his inclusion in the Indian team.

Having played more than 60 firstclass matches in domestic cricket, the 29-year-old is the only player from the Vidarbha team to score a century in the Syed Mushtaq Ali Trophy, India's domestic T20 cricket championship.

He has the right credentials for a national call-up.

Tushar Deshpande

der the astute captaincy of MS Dhoni The right-arm seamer has come a long way after last year's IPL where he got to play only two matches for Chennai Super Kings (CSK). This edition, Tushar Deshpande formed an effective partnership with Sri Lankan bowler Matheesha Pathirana. Having played all games for the CSK this season, Deshpande has flourished under the astute captaincy of MS Dhoni.

As a bowler he doesn't come across as intimidating or has express pace, but he sticks to his ability and plan. Deshpande didn't have a great start in first few matches - erring in his line and length. But backed by the team management and Dhoni, he bounced back to become CSK's highest wickettaker.

The 28-year-old is among the top-five wicket-takers in IPL 2023. With the experience of playing domestic cricket and for the Indian team, Deshpande could be an ideal option for the World Cup a few months away.

How to Pay Zakah on Real Estate

How to Pay Zakah on Real Estate

Praise be to Allaah, blessings and peace be upon Prophet Muhammad the noblest of Allaah's creation and upon his family and companions and those who follow him.

It is well-known that real estate nowadays is different from what it was previously, with regard to its popularity and people's interest in it, and there are different situations in which the ruling on zakah differs accordingly.

What is meant by real estate is that which a person may own of land and the structures that may be built on it such as houses, palaces, high-rise buildings, apartments, shops, gas stations, leisure facilities and so on.

To discuss the matter of zakah on real estate in more detail, we may note the following:

Is real estate wealth?

The general principle concerning this matter is that real estate is not wealth that is subject to zakah; therefore, the basic guideline is that zakah is not due on it unless it is for trade.

When is zakah on real estate due? With regard to real estate that a person acquires for his accommodation or for any personal use, such as storage and the like, no zakah is due on it, according to scholarly consensus.

That is because in this case real estate is regarded as personal property, and no zakah is due on personal property, according to consensus.

Regardless of whether the intention of keeping it as personal property was present at the time of purchase, or it came about after that, merely having the intention to keep the real estate for personal use puts it under the heading of wealth that is not subject to zakah, even if it is kept for many years, so long as the owner's intention does not change.

Is agricultural land subject to zakah? Agricultural land is not subject to zakah; rather zakah is to be paid on the crops and fruits only.

But if a person buys land in order to trade it, and he cultivates it until he sells it, so the palm trees bear fruit and crops grow and ripen, then he must pay zakah on the fruit and grains, at a rate of one tenth, and he must pay zakah on the value of the land, because they are two different types of dues, which differ in the reasons why they are obligatory; one of them does not cause the other to be waived.

Zakariyya al-Ansari said:

"If he grows crops for personal use on land that is bought for the purpose of trade, then each of them is subject to its own ruling. Zakah on specific crops must be given on the crops that he grows, and zakah on trade goods must be given for the land." (Asna al-Matalib, 1/385)

Is there zakah on real estate acquired for renting?

With regard to real estate that a person acquires for the purpose of making use of it – i.e., by renting it out and benefitting from the income generated thereby – there is no zakah on its value; rather zakah is due on the rent that is collected from it, when one full year has passed.

So with regard to dwellings, storage places, furnished apartments, hotels and high-rise buildings, if they are prepared to be rented out, no zakah is due on these types of real estate according to the majority of scholars, so the owner does not have to work out the value of this real estate every year and pay zakah on it.

Zakah on real estate acquired for trading

With regard to real estate that a person acquires with the intention of trading or selling it, zakah is due on it according to the majority of scholars.

What is meant by having the intention of trading or selling it is that one intends, by taking possession of this real estate, to make money thereby and make a profit on it.

Al-Mirdawi said: "The intention of trading or selling it" means that he aims to make money from it by selling it." (Al-Insaf, 3/154)

However simply wanting to sell does not necessarily make it trade goods, because items may be sold for many purposes or reasons, such as to get rid of the item, or because one no longer has any interest in it, or because of financial difficulty and so on. As for trading, this refers to selling with the aim of making money and making a profit from it.

Shaykh Ibn 'Uthaymin said:

"If a man has land that he bought intending to build on it, then he changes his mind and decides to sell it because he does not need it, or because he has several pieces of land, then he needs money so he decides to sell one of them in order to meet his needs, then he does not have to give zakah for this

or for the others, because his intention is not to sell it for trade in this case. Rather his intention in the first scenario is because he no longer needs it, and in the second scenario he decided to sell it because he needed its value. This is unlike the one who owns trade goods and expects to make a profit on them, so from the outset he only wanted the item to be for trade." (Fath Dhi'l-Jalal, 6/173)

Is there zaka on real estate that is not for trade?

If he buys real estate but does not have any firm intention of wanting it for trade, or he has no specific intention, then it is not subject to zakah.

Al-Qarrafi said: "If he buys it with no particular intention, then it is regarded as being for personal use, because that is what is usually the case." (Adh-Dhakhirah, 3/18)

Shaykh Ibn 'Uthaymin (may Allah have mercy on him) was asked: There is a man who has a piece of land and is not quite sure what to do with it (i.e., his intention is not clear). He does not know whether he is going to sell it, develop it, rent it out, or live on it. Should he pay zakah when one year has passed?

He replied:

"This land is not subject to zakah at all, so long as he has no firm resolve that he bought it for trade. So no zakah is due on it, because he is hesitant, and when there is hesitation, even if it is only one percent, no zakah is due."

(Majmu' Fatawa al-'Uthaymin, 18/232)

If he takes possession of the real estate for his personal use and to live there, then he decides to trade it after that, then there is a difference of scholarly opinion as to whether zakah is due in this case. We have previously noted that the view that zakah is due on it is more likely to be correct.

If he acquires the real estate with the intention of trading, then he changes his mind and decides to keep it for personal use or to rent it out, then no zakah is due on it, because the condition of intention is that one should have that intention until one full year has passed. So if he changes his intention before the end of the year, zakah is waived. An-Nawawi said: If he decides to keep for personal use trade goods that are in his possession, they become personal property (and therefore not subject to zakah), according to scholarly consensus." (Al-Majmu', 6/49)

Is there zakah on real estate for personal trade and trading?

If he acquires the real estate for personal use plus trading, or for trading plus personal use, then what matters is what his intention was when he bought that property. Whoever buys any item with the intention of using it himself, and also intends that if he could make a profit on it he will sell it, then no zakah is due on it. But whoever buys an item with the intention of trading it, and uses it for personal benefit whilst he is waiting until he can sell it, then zakah is due on it every year, until it is sold.

Similarly, if he decides to use it and benefit from it for a certain length of time before selling it, then it is subject to the zakah on trade goods, because his initial intention to make use of it is not contrary to its being prepared for trade.

Ruling on zakah on real estate still at the construction stage

If the real estate is still at the construction stage – and it is for trade – then zakah is due on it whether it is offered for sale or will not be sold until after construction is complete. Zakah must be paid on it according to its value in the current situation at the time when zakah becomes due.

In the case of real estate when the owner is waiting for prices to go up, zakah must be paid on it every year according to its value, even if that continues for years.

Buying real estate with the intention of making money on it in the distant future does not mean that zakah on it is waived.

That includes buying land far from the city, waiting for such time as people show interest in it and prices begin to rise. This intention of selling the land in the future makes zakah obligatory, and the fact that the intention is to sell it at a later date has no impact, so long as the land is kept for trade and the aim is to increase one's wealth thereby.

The scholars call such a person "the trader who is biding his time". The most correct scholarly view concerning this case is that of the majority of scholars, which is that zakah due every year.

Ruling on real estate bought for protecting one's wealth

In the case of real estate that is bought with the intention of protecting one's wealth, no zakah is due on it, unless the owner is trying to evade zakah.

Ruling on real estate not taken possession of

If a person buys real estate for the purpose of trade, but he does not take possession of it until one year has passed since his acquisition of the wealth with which he bought it, then zakah is due on it, because ownership of real estate passes to the purchaser once the contract is done and he is able to take possession of it.

Shaykh Ibn 'Uthaymin (may Allah have mercy on him) was asked: A man bought some land that was prepared for trade; please note that this man has not taken possession of the land until now, and he has not even taken possession of the title deed. Does he have to pay zakah on it?

He replied:

"Yes, he has to pay zakah on this land, even if he has not taken possession of the title deed, so long as the sale has been concluded and become binding. So, he must give the zakah on trade goods for it, and he should work out its value at the time when zakah becomes due, and give one quarter of one tenth (i.e., 2.5%) of its value." (Majmu' Fatawa wa Rasail al-'Uthaymin, 18/234)

Is there zakah on mortgage property? With regard to mortgaged property, zakah must be paid on it if it is prepared for trade.

Shaykh Ibn Baz said:

"If you have prepared it for trade, but it is mortgaged, then you must pay zakah on it. But if it is mortgaged and not prepared for trade; rather it is mortgaged until you pay off what is due to the person with whom it is mortgaged, and once you pay them off you either live in it or rent it out, then it is not subject to zakah." (Fatawa Nur 'ala ad-Darb, 15/43)

Zakah on real estate owned by multiple partners In the case of partners in ownership of real estate, each partner must pay his share of zakah, if it reaches the minimum threshold (nisab), according to the majority of scholars.

Shaykh Bakr Abu Zayd said:

"In order for zakah to be obligatory upon each partner in ownership of real estate, the value of his share of the property must reach the minimum threshold by itself or when added to other wealth of his that is subject to zakah, such as cash or trade goods." (Fatwa Jami'ah fi Zakat al-'Iqar, p. 12)

In the answer to question no. 147855, we explained that the view of the Shafi'is is that what matters is the total value of the property, not the minimum threshold of each individual. So, if the value of the real estate reaches the minimum threshold, each of them must give zakah, even if his own share does not reach

that threshold.

This was the view adopted by the Islamic Fiqh Council, and Shaykh Ibn 'Uthaymin was also inclined towards this view.

Is there zakah on real estate endowed for charitable causes?

With regard to real estate that is endowed for charitable causes (i.e., a waqf), such as to benefit the poor, there is no zakah on it, because it is no longer the property of any individual.

Is there zakah on real estate that is not selling? With regard to zakah being obligatory, there is no differentiation between real estate that sells easily and that for which a buyer cannot be found, so long as it still has value for which it may be sold.

This is the view of the majority of scholars, because the basic reasoning on which the obligation of giving zakah on trade goods is based is the fact that they constitute wealth that is expected to increase, like currency, regardless of whether it actually does increase or not, and regardless of whether a profit is made or a loss is incurred.

The fact that the trade goods are not selling makes no difference with regard to zakah, so long as the items still have a real market value and can be bought and sold.

In Fatawa al-Lajnah ad-Daimah (8/102), it says:

"In the case of land that is offered for sale, zakah is due on it every time one full year passes, because it comes under the heading of trade goods. Its value is to be worked out at the beginning of each new year, and one quarter of one tenth is to be given, regardless of whether it is selling easily or not selling, because of the general meaning of the evidence for zakah being due on anything that has been prepared for sale or trade." [Ibn Baz, Al ash-Shaykh, al-Fawzan, al-Ghadyyan]

Shaykh 'Abd ar-Rahman al-Barrak said:

"The fact that real estate is not selling (because of a slump in the market) has no impact and does not mean that zakah is waived; rather the amount of zakah may be reduced, because land that is not selling should be evaluated based on the price that it could be sold for, no matter how little it may be."

But if the real estate is not selling, to the extent that the owner is offering it for sale but cannot find anyone to buy it from him, then some of the scholars said that he should pay zakah on it for one year when he does sell it.

Ruling on shares in real estate

With regard to shares in real estate, zakah should be paid on them at the same rate as zakah on trade goods, because these real-estate companies buy land for the purpose of trading in it.

When one year has passed since the shareholder bought his shares, he must work out the value of his shares in this company, and pay zakah on them at a rate of one quarter of one tenth.

Ruling on property on which there is a lien With regard to property on which there is a lien, or real-estate companies that are in turmoil, in which one has shares, no zakah is due on them; they come under the ruling on wealth that is beyond one's control.

"With regard to land that is designated for public facilities, schools and so on, where the owner is prevented from disposing of it unless the authorities decide that they no longer need it, no zakah is due on it until after the owner becomes able to dispose of it, in which case he should wait to pay zakah on it until one year has passed since he became able to dispose of it." (al-Masail al-Mustajiddah fi'z-Zakah, p. 87)

The same applies to shares in real-estate companies that are in turmoil, where the reason for turmoil may be because of corruption and cheating on the part of the management of the company, or the reason may be impediments in the rules and regulations laid down by the state, or disputes or liens against that property. Whatever the case, if there are shares in real estate that the owner cannot dispose of, no zakah is due on them.

When should the value of the real estate be worked

The value of the real estate should be worked out at the end of the year, based on the market value at year's end, which may be lower or higher than the original purchase price.

The working out of the year does not begin from the time of purchasing the real estate; rather the year in question is one year from acquisition of the wealth with which the real estate is purchased.

Practice safe driving techniques related to defensive driving and Smith System 5 Keys. By using these tools, drivers can remain vigilant in their efforts to arrive safely.

USE SAFE DRIVING TOOLS

Drive with lights on and use warning devices to effectively communicate with other drivers. When pavement is wet, you should decrease speed, turn off cruise control, and increase following distance.

SEEK COVER

With a threat of excessive wind gusts, hail, or even tornadoes, limit driving to an as needed basis. Secure loads, protect vehicles and equipment, and seek shelter when severe weather is near.

STAY FOCUSED

MAINTAIN AWARENESS

Situational awareness will be essential during inclement weather. Pay careful attention to weather, roadway, and traffic conditions as they may change abruptly.

BE PROACTIVE

Remember to Stop. Speak. Act! It is important to stay engaged with the environment around you and make good decisions to ensure the safety of yourself and your teammates.

COMMUNICATE

Keep constant communication with team members about conditions. Radios will be an essential resource in the event that cell towers or electricity are impacted by storms.

HIGH WATER ON THE ROAD & AVOIDING HAZARDS

BE PREPARED

VERIFY CONDITIONS

In high water operations, it is important to remain aware of locations that may become impacted by flooding. All employees should be briefed and updated regularly regarding this information.

ENSURE ESSENTIAL SUPPLIES

Equip vehicles with necessary supplies to respond to flooded roadways. This includes PPE, signage, tools, and water/snacks, especially if employees will be stationed for long hours at these locations.

PLAN FOR MORE

Flooding creates hazardous conditions for workers. Verify that first aid kits are stocked, and fire extinguishers are charged before response.

SLOW DOWN

TURN AROUND

When roadways are covered in water, turn around and never attempt to drive through. It may be worse than what it initially appears. Vehicles are not equipped to handle high water, which may cause the engine to flood or be carried away.

BE CAUTIOUS

In the event of rain or wet pavement. drive carefully to the current conditions to avoid loss of traction on the roadway. Operators should turn off cruise control, slow down, and increase following distance.

HAVE A WAY TO ESCAPE

Avoid areas that would require backing. If backing becomes necessary, use a spotter, when available. Perform 360 walkaround to confirm surroundings are free of hazards.

STAY FOCUSED

OBSERVE SURROUNDINGS

Identify unsafe travel paths and avoid driving through these areas. Debris, fixed objects, downed powerlines, or other items may be hidden. If you don't know, don't go!

CALL A TIME-OUT

When faced with situations that may become unsafe, workers should utilize stop work authority and communicate hazards with others. When conditions improve, a new plan of action may be taken.

REMAIN ALERT

Long hours in this type of emergency response may affect workers ability to remain vigilant. It is essential to communicate with supervision about this to ensure operational readiness.

Why India's New Parliament Building Is So Controversial

Why is there backlash to India's new parliament building?

Construction of the new, four-story parliament building began in January 2021 as part of the Central Vista project. The government has stated that the new building, which costs nearly \$120 million, is a necessary parliamentary upgrade to allow for increased seating capacity and better facilities like air conditioning, lighting, and restrooms. The government has said that the original building, which dates back to 1927, has shown signs of distress and overuse. While the old building had 543 seats in the Lok Sabha (the Lower House, which has 545 members) and 250 seats in the Rajya Sabha (the Upper House, which has 250 members), the new building will accommodate 770 and 530 seats respectively, allowing for the opportunity to increase the number of representatives in Parliament given India's growing population.


Since the construction began, however, politicians, environmentalists, and civil society groups have criticized the new building over the cost and lack of consultation. Many have questioned why the government chose not to upgrade the old building instead.

The ruling Bharatiya Janata Party (BJP) is also facing backlash for sidelining the President, Draupadi Murmu, by asking the Prime Minister to inaugurate the building instead. India's president is a non-elected and non-executive position, but they are considered a ceremonial figurehead as the country's first citizen and highest constitutional authority. (Notably, Murmu is also the country's first ever tribal head of state.)

A joint statement issued by 19 national and regional opposition parties stated that Modi's decision to "inaugurate the new parliament building by himself" was "not only a grave insult but a direct assault on our democracy which demands a commensurate response." The parties plan to collectively boycott the event, adding that "the soul of democracy has been sucked out from the parliament."

A lawyer also petitioned the Supreme Court to invite the Indian President, rather than the Prime Minister, to preside over the ceremony. This controversy comes after years of growing concern over the state of Indian democracy: the U.S.-based non-profit Freedom House downgraded India's democracy from "free" to "partially free," while the Sweden-based V-Dem Institute has called India an "electoral autocracy." India's position has also slipped on the Democracy Index published by The Economist Intelligence Unit.

The opposition leaders have also criticized the inauguration date, which coincides with the anniversary of the birth of VD Savarkar, a divisive figure for his connection to the 1948 assassina-



tion of the freedom fighter, Mahatma Gandhi. The BJP hails Savarkar as a hero for birthing the nationalist idea of Hindutva, or 'Hindu-ness'.

The BJP has defended its decision by saying the new building is a matter of pride for all Indians and accused the opposition of "politicizing" the inauguration. India's Home Minister Amit Shah said that all political parties had been invited to the ceremony, but that "everyone will act according to their own feelings," at a press conference on Wednesday. The tussle is yet another reminder of the strained relationship between the governing BJP and the opposition parties, who most recently protested the parliamentary disqualification of Rahul Gandhi, the de facto leader of the Congress Party, India's main opposition party after he was charged and convicted

of defamation in March. A Congress spokesper-

son previously told TIME that the charges were

"flimsy and cooked up."

The "Central Vista Project" is the larger architectural project to revamp the 46 hectares in the political heart of New Delhi, which encompasses British colonial-era monuments and government buildings, including Sansad Bhavan (Parliament House), the Rashtrapati Bhavan (formerly the Viceroy's House), and the Secretariat Buildings. The project's name refers to the central administrative area, also informally known as 'Lutyens Delhi,' named after the British architect, Edward Lutyens, who designed many of the boulevards, sandstone buildings, and gardens for the British Raj between 1911 and 1931.

The project intends to give the buildings a face-lift and cement Modi's vision for a new, "self-reliant" India emerging out of the long shadow of its colonial past. One of the most notable renovations is the Kartavya Path or "Path of Duty," also formerly known as Rajpath or "King's Way," which was originally designed as a ceremonial axis for the British capital and continues to be a popular thoroughfare for the public, especially when hosting the annual Republic Day Parade in January.

But the whole project—which began in the middle of a brutal second wave of the CO-VID-19 pandemic in 2021—has been met with widespread criticism for its cost, environmental damage, and disregard for heritage buildings.

Hawa Mahal: How India's stunning 'palace of winds' was ahead of its time

In 2015, India launched an ambitious plan dubbed the National Smart Cities Mission, aimed at making 100 urban centers more livable and sustainable through innovative and inclusive solutions.

Among the 100 cities selected was Jaipur, the northwestern desert capital of Rajasthan.

But while the Smart City project concept was aimed at modernizing India, historians argue that Jaipur's "smart" credentials have been ahead of the game for centuries.

Now famed for its historic pink buildings, it was the first "planned city" of King Sawai Jai Singh, an astronomer who used planetary positions as his guide when deciding on the orientation and positions of the structures. He moved his kingdom's capital from the nearby village of Amer to Jaipur in 1727.

In the years to follow, Rajasthan's kings continued their patronage of art and architecture – including descendant King Sawai Pratap Singh.

He was a builder with an artistic side – Jaipur's old palatial city walls feature numerous examples of his love for art. But nowhere showcases that passion quite like Hawa Mahal, which is not only architecturally stunning but offers lessons in sustainable building.

Completed in 1799, it's today one of India's most recognizable icons and a popular tourist attraction. Indian authorities in charge of the monument say roughly 1 million people visit each year.

A building famed for its back Past the city's fractal pink walls and the frenzy of the old city market, the Hawa Mahal is an imposing structure, its recurring pyramids rising five floors above the chaos.

With a staggering height of 87 feet, dotted with 953 ornate louvered windows, it's a feast for the eyes. But few realize that what you see from the street is essentially the rear of the building.

"It is very unusual for a building to be not known for its front, but its back," says Sanjay Sharma, who has been guiding visitors through Hawa Mahal for more than two decades.

"(Travelers) marvel at what they see from the



main road, pose in front of it for a quintessential Jaipur photograph and move on. Few come inside; the interiors are simple, only curious minds would understand that behind the blushing façade there is much more to it than what meets the eye."

According to Dr. Mahendra Khadgawat, director of Rajasthan's State Museum and Archaeology Department, King Sawai Pratap Singh was an ardent devotee of Hindu deity Krishna and commissioned architect Lal Chand Usta to construct a crown-shaped pavilion that resembled Krishna's crown. Hawa Mahal was the result.

"The primary purpose of the building was to allow the royal ladies to enjoy everyday street scenes and processions without being seen owing to the purdah system," he says, referring to a social practice in medieval India in which women, particularly from the upper classes, were required to cover themselves and remain secluded from public view.

A clever feat of engineering Architect Kavita Jain, a conservation and heritage specialist, says Hawa Mahal served additional purposes as well.

"For the city folks, the rear elevation on the east side facing the roadside is a visual treat; for the king himself, a legendary structure that generations will remember him for; for the royal ladies, a way to be connected to the common people and their celebrations without appearing in public," she says.

"But for a keen eye, it is a clever feat of engineering, where aesthetically appealing elements were used to create a microclimate comfortable enough for the queens to enjoy their outing."

Today, the building is a prime example of the role climate played in India's historic designs and provides evidence of an advanced understanding of the laws of thermodynamics.

In Hindi, "hawa" means wind, and "mahal" means palace – and the name couldn't be more fitting.

"The orientation of the building is on the east-west axis, aligned with the direction of the natural flow of the wind in this region," says Jaipur-based architect Shyam Thakkar.

"The wind enters the palace from the west (through a series of open grounds). It picks up moisture from the water body thoughtfully placed in the courtyard using the principle of convection currents; the hot air rises, and the cool air descends."

It doesn't end there. Thakkar says the moistureladen wind then moves towards the 953 windows (jharokha) and cools the air down thanks to the Venturi effect – air flows through a constricted passage, increasing the wind velocity while dropping the pressure.

"Intricate lattices (jaalis) on the windows break up and distribute the air flow evenly to ensure no hotspots; it also controls the direct glare of sunlight," he adds.

"Using lime (chuna) as a lattice material is a final flourish. Chuna can regulate temperature inherently."

According to guide Sharma, the floors have also been segregated according to the seasons.

"The number and the size of the openings vary accordingly on each floor," he says. "Some floors have windows covered with stained glass, and some just open jaalis. The proportion of the open spaces left on each floor is governed by its season of use, namely prewinter, spring, summer and winter, making the Hawa Mahal a very climate-responsive building."

Inspired by the past Jaipur is hot and dry for most of the year. During the peak summer months, it can climb to over 43 degrees Celsius (110 degrees Fahrenheit.)

Now that India is the world's most populous country, with a proliferating middle class, amenities that were once a luxury have become a necessity. And that includes air conditioning.

According to data by the IEA updated in October of 2022, the world will add an estimated 1 billion air conditioners before the end of the decade.

This will eventually lead to more carbon emissions. With India accounting for 17.7% of the world's total population, a global impact is inevitable.

Aziz Mian Qawwal

Aziz Mian Qawwal (17 April 1942 – 6 December 2000) was one of Pakistan's leading traditional qawwals and also famous for singing ghazals in his own unique style of qawwali. Aziz is still one of the most popular qawwals of South Asia, and he has given us many Qawwali hits.He holds the record for singing the longest commercially released qawwali, Hashr Ke Roz Yeh Poochhunga, which runs slightly over 115 minutes

Early life and background Aziz Mian was born as Abdul Aziz in Delhi, British India. The exclamation Mian, which he often used in his qawwalis, became part of his stage name. He began to introduce himself as Aziz Mian Meeruthi. The word Meerut refers to Meerut, a city in northern India, from which he migrated to Pakistan in 1947.

At the age of ten, he began learning the art of Qawwali under the tutelage of Ustad Abdul Wahid Khan of Lahore. He received sixteen years of training at the Data Ganj Baksh School of Lahore, and earned degrees in Urdu literature, Arabic and Persian from the University of Punjab, Lahore.

Career

Aziz Mian was one of the non-traditional Pakistani Qawwals. His voice was raspy and powerful. Aziz Mian was the only prominent qawwal to write his own lyrics (though, like others, he also performed songs written by other poets). Aziz Mian was a contemporary, and often a competitor, of The Sabri Brothers.



His break-out performance was in 1966, when he performed before the Shah of Iran, Mohammad Reza Pahlavi. He won first prize and a gold medal from the Shah of Iran.In the early days of his career, he was nicknamed Fauji Qawwal (meaning "Military Qawwal") because most of his early stage-performances were in military barracks for the army personnel. He was known for a "more recitative, more dramatic diction" and was inclined toward qawwali's religious rather than entertainment qualities, though he also enjoyed success in more romantic qawwalis.

He was fond of discussing religious and

Sufi paradoxes in his qawwalis. He directly addressed Allah and complained about the misery of man (the greatest creation of the Almighty). In addition to his own poetry, Aziz Mian performed poetry by Allama Iqbal, and a number of contemporary Urdu poets, including Sadiq, Saifuddin Saif and Qateel Shifai. Awards an recognition

For his service in music, the Government of Pakistan awarded him the Pride of Performance medal in 1989.

Death

Aziz Mian died from complications of hepatitis in Tehran, Iran on 6 December 2000(10 Ramadan Mubarak). He was in

Iran at the invitation of the Government of Iran, to perform on the occasion of Imam Ali's death anniversary. He is buried in Multan, on the brink of Nau Bahar Nehar[Canal] His death anniversary (Urs) is celebrated every year on the first Thursday of May, the Urs celebrations commence with the 'Ghusal' ceremony conducted by Mian Saheb's son Shibli Aziz and Rasm e Sandal of Baba Nadir Hussain famously known as 'Tootan Wali Sarkar' who is a murid of Aziz Mian. The Urs celebrations continue for three days, starting with 'Ghusal' followed by 'Chadar Poshi' and 'Mehfil e Samaa' (Urdu: Mehfil-e-Samaa of Qawwali ('samaa' means the listening audience in Urdu and Arabic). Around seven to eight qawal groups perform. The Celebration terminates after the last ritual of 'Qul'. The Urs (death anniversary) celebration are organized by Shibli Aziz Mian, who is more interested in mysticism and Sufi traditions. He is promoting and propagating these spiritual heritage of his father and have a quite a number of disciples[Mureed's] and followers.

Family

Aziz Mian had four sons Junaid, Tabreiz, Imran and Faran who all followed in his footsteps. They are very similar in style to Aziz Mian himself and like other sons of famous qawwals (Amjad Sabri for example, or Waheed and Naveed Chishti), they perform many of their father's hits. Tabrez is however considered to be the closest to his father's style. His looks and his style are a mirror image of his father. Tabrez also toured North America for a tribute to Aziz

The better thing to do when you are exhausted is to stop and take a break, drink a glass of water, sit under a nice cool fan, and rest instead of being unsafe.

2. Be careful moving large pieces of furniture and appliances.

Use proper lifting technique, keeping you back straight and lifting with your legs.

Also, wear shoes when moving heavy items so you don't hurt your toes.

Finally, if you feel it is just too heavy and you can't find someone else to do it for you, just don't move it. It won't be the end of the world to just clean around it.

Always have spring cleaning safety in mind.

3. Be safe while on ladders and step stools. When doing a task, such as washing windows, where you need to be on a ladder use extreme caution.

Follow instructions and warning labels on chemical and lawn and garden equipment. (As a reminder, if workers will be using consumer chemical products in amounts and/or frequencies that exceed typical consumer use, employers must obtain a safety data sheet (SDS) for the product, ensure that it is properly labeled, and train workers in its hazards and safe work practices.)

Reduce the risk of sunburn and skin cancer by wearing long sleeves, a widebrimmed hat, and sunshades. Use sunscreen with an SPF of 15 or higher. Keep an eye on the thermometer and take precautions in the heat.

When working in hot weather, remind workers to drink plenty of liquids, but not those that contain alcohol or large amounts of sugar, as they can cause you to lose body fluid.

Pay attention to signs of heat-related illness, including high body temperature,



headache, dizziness, rapid pulse, nausea, confusion, or unconsciousness.

And remember—if you hire a contractor for landscaping or other outdoor maintenance, it's important to inquire about the company's safety record and make sure

Mukesh Dhirubhai Ambani (born 19 April 1957) is an Indian business magnate who is the chairman, managing director and largest shareholder of Reliance Industries Limited (RIL), a Fortune Global 500 company and India's most valuable company by market value. He holds a 44.7% stake in the company RIL deals mainly in refining, petrochemicals, and in the oil and gas sectors. Reliance Retail Ltd., another subsidiary, is the largest retailer in IndiaHe is the elder son of the late Dhirubhai Ambani and Kokilaben Ambani and the brother of Anil Ambani. As of January 2018, Mukesh Ambani was ranked by Forbes as 18thwealthiest person in the world, with a net worth of \$43.2 billion. In 2016, he was ranked 38, and is the only Indian businessman, on Forbes' list of the world's most powerful people. As of 2016, Ambani has consistently held the title of India's richest person on the magazine's list for ten years. Through Reliance, he also owns the Indian Premier League franchise Mumbai Indians. In 2012, Forbes named him one of the richest sports owners in the world.He resides at the Antilia Building, one of the world's most expensive private residences. Its value is close to \$1 billionAs of 2015, Ambani ranked fifth among India's philanthropists, according to China's

Early life

Mukesh Dhirubhai Ambani was born on 19 April 1957 to Dhirubhai Ambani and Kokilaben Ambani. He has a younger brother, Anil Ambani, and two sisters, Dipti Salgaoncar and Nina Kothari. The Ambani family lived in a modest two-bedroom apartment in Bhuleshwar, Mumbai until the 1970s. Dhirubhai later purchased a 14-floor apartment block called 'Sea Wind' in Colaba, where, until recently, Mukesh and Anil lived with their families on different floors.

He attended the Hill Grange High School at Peddar Road, Mumbai, along with his brother and where Anand Jain, his close associate, was his classmate. He received his BE degree in Chemical Engineering from the Institute of Chemical Technology(UDCT), Matunga.Mukesh later enrolled for an MBA at Stanford University but withdrew to help his father build Reliance, which at the time was still a small but fast growing enterprise.

Business career

In 1980, the Indian government under Indira Gandhi opened PFY (polyester filament yarn) manufacturing to the private sector. Dhirubhai Ambani applied for a license to set up a PFY manufacturing plant. In spite of stiff competition from Tatas, Birlas and 43 others, Dhirubhai was awarded the licence. To help him build the PFY plant, Dhirubhai pulled his eldest son Mukesh out of Stanford where he was studying for his MBA. Mukesh Ambani then continued to work for Reliance and did not return to his university program after that. He led Reliance's backward

textiles into polyester fibres and further into petrochemicals, beginning in 1981. Mukesh Ambani set up Reliance Infocomm Limited (now Reliance Communications Limited), which was focused on information and

integrationfrom

communications technology initiatives.

Ambani directed and led the creation of the world's largest grassroots petrefinery at Jamnagar, India, which had the capacity to produce 660,000 barrels per day (33 million tonnes per year) in 2010, integrated with petrochemicals, power

generation, port and related infrastructure. In December 2013 Ambani announced, at the Progressive Punjab Summit in Mohali, the possibility of a "collaborative venture" with Bharti Airtel in setting up digital infrastructure for the 4G network in India. In February 2014, a First Information Report (FIR) alleging criminal offences was filed against Mukesh Ambani for alleged irregularities in the pricing of natural gas from the KG basin. Arvind Kejriwal, who had a short stint as Delhi's chief minister and had ordered the FIR, has accused various political parties of being silent on the gas price issue. Kejriwal has asked both Rahul Gandhi and Narendra Modi to clear their stand on the gas pricing issue. Kejriwal has alleged that the Centre allowed the price of gas to be inflated to eight dollars a unit though Mukesh Ambani's company spends only one dollar to produce a unit, which meant a loss of Rs. 540 billion to the country annually.

On 18 June 2014, Mukesh Ambani, addressing the 40th AGM of Reliance Industries, said it will invest Rs 1.8 trillion (short scale) across businesses in the next three years and launch 4G broadband services in 2015.

In February 2016, Mukesh Ambani-led Jio launched its own 4G smartphone brand named LYF.In June 2016, it was India's third-largest-selling mobile phone brand.. During the 40th annual general meeting



of RIL, he announced bonus shares in the ratio of 1:1 which is the country's largest bonus issue in India, and announced the Jio Phone at an effective price of As of February, 2018, Bloomberg's "Robin Hood Index" estimated that Ambani's personal wealth was enough to fund the operations of the Indian federal government for 20 day

Perhaps ,in return, one day he brought me a yellow





plastic card with my

Although dairy products may be the richest sources of calcium, a growing number of foods, such as orange juice, are calcium-fortified. Fruits, vegetables, and grains provide other minerals crucial to bone health, such as magnesium and phosphorus.

Maintain a reasonable weight. This is particularly important for women. Menstrual periods often stop in women who are underweight — due to a poor diet or excessive exercise — and that usually means that estrogen levels are too low to support bone growth.

Don't smoke and limit alcohol intake. Smoking and too much alcohol both decrease bone mass.

Make sure your workouts include weight-bearing exercises. Regular weightbearing exercise like walking, dancing, or step aerobics can protect your bones. Also include strength training as part of your exercise routine. Talk with your doctor about your risk factors. Certain medical conditions (like celiac disease) and some medications (steroids and others) can increase the chances that

you will develop osteoporosis. It's important to talk with your doctor to develop a prevention strategy that accounts for these factors.

What's your t-score? Bone density scans for osteoporosis

Several technologies can assess bone density, but the most common is known as dual energy x-ray absorptiometry (DEXA). For this procedure, a machine sends x-rays through bones in order to calculate bone density. The process is quick, taking only five minutes. And it's simple: you lie on a table while a scanner passes over your body. While this technology can measure bone density at any spot in the body, it is usually used to measure it at the lumbar spine (in the lower back), hip (a specific site in the hip near the hip joint), and femoral neck (the top of the thighbone, or femur). DEXA accomplishes this with only one-tenth of the radiation

exposure of a standard chest x-ray and is considered the gold standard for osteo-porosis screening—though ultrasound, which uses sound waves to measure bone mineral density at the heel, shin, or finger, is also used at health fairs and in some


medical offices.

The DEXA scan or ultrasound will give you a number called a T-score, which represents how close you are to average peak bone density. The World Health Organization has established the following classification system for bone density:

If your T-score is -1 or greater: your bone density is considered normal.

If your T-score is between -1 and -2.5: you have low bone density, known as osteopenia, but not osteoporosis.

If your T-score is -2.5 or less: you have osteoporosis, even if you haven't yet broken a bone.

We all have moments of forgetfulness about where we put the keys, why we walked into a room, or what an object is called. Most likely, this reflects age-related changes in thinking skills. "In terms of brain function, everyone has a decline over time in all areas, with the exception of vocabulary," says Dr. Joel Salinas, a neurolo-

gist specializing

How memory works

Memory involves three processes: encoding, recording, and retrieval. The brain receives and encodes (takes in) new information; the brain then records (stores) the information; finally, the brain retrieves information when you need it.

Many brain regions are involved in this process. For example, the cerebral cortex—the large outer layer of the brain—acquires new information as input from our senses. The amygdala tags information as being worthy of storage. Nearby, the

hippocampus stores memories. And the

frontal lobes help us consciously retrieve

related chemical and structural changes can begin in brain regions involved with memory processing, such as the hippocampus or the frontal lobes. These changes may slow processing speed, making it hard to recall familiar names or words.

Other factors may be at play as well. "Working memory — a mental scratch pad that allows us to use important information throughout the day — is susceptible to depression, anxiety, and stress," explains Dr. Salinas, "and a lack of sleep can affect the brain's retention and use of information."

A medication side effect may also affect memory. For example, if you use an antianxiety drug like clonazepam (Klonopin), its sedating side effects can make your brain less alert and more sluggish. This in turn makes it more challenging for your brain to carry out the essential encoding, recording, and retrieval steps of memory. Dr. Salinas says addressing these problems first often helps improve memory.

Memory tricks

Another way to boost memory is to make the most of the way it works. The following strategies may help.

1. Repeat what you hear out loud, such as someone's name, or an address, or a new idea. Repetition increases the likelihood you'll record the information and be able to retrieve it later. "With each repetition,

your brain has another opportunity to encode the information," explains Dr. Salinas. "The connections between brain cells are reinforced, much like blazing a trail in the woods. The more you walk the same trail,

2. Make a note of people you need to call, errands to run, and appointments. "We are much better at recognition than recall," Dr. Salinas explains. "With recognition, such as reading a list, you have additional hooks or hints that help you find the information you're looking for."



- 3. Make associations between old and new information. Connect a person's first name to something familiar. For example, if the person's name is Sandy, imagine that person on a beach. Or create a story around a shopping list. "Our brain is good at sequences, and putting things into a story helps. The more ridiculous, the more memorable it is. For example, if your list is milk, eggs, and bread, the story could be that you are having milk with Elvis over an egg sandwich," Dr. Salinas suggests.
- 4. Divide information into chunks, such as taking a long number and remembering it more like a phone number. "It's hard to store a long number," says Dr. Salinas, "but easier to store little bits through working memory." If you're trying to

memorize a speech for a wedding toast, focus on getting only one sentence or idea down at a time, not the whole speech in one take.

When tricks don't help

Forgetting something minor from time to time is probably normal. It's not normal when memory changes interfere with day-to-day functioning. Dr. Salinas recommends that you talk to your doctor if you're making more mistakes than usual at work; having difficulty paying the bills; or having trouble completing tasks, cooking, emailing, or doing chores. But don't panic. "More often than not, there's a temporary or reversible cause behind your memory slips. Once that's taken care of, you can get back to your more usual remembering self," says Dr. Salinas.

Jogira Sara Ra Ra Movie Review

Review: A small town, an independent and brash girl and a family full of quirky characters. 'Jogira Sara Ra Ra' has all the elements stuffed in to create situational comedy from everyday life. And it all begins when Jogi (Nawazuddin Siddiqui) - a street smart marriage planner meets a feisty and brattish Dimple (Neha Sharma). She has just gate-crashed a wedding party organised by Jogi and after a few pegs, she takes to the mic to give a very critical yet honest review of the pathetic catering at the wedding. Of course, it culminates in a big song and dance, but unlike a regular Bollywood film, there's no love at first sight here. In fact, director Kushan Nandy and writer Ghalib Asad Bhopali ensure there's nothing conven-



tional about the lead pair, as they are both flawed yet real characters. They use this to create conflict, confusion and chaos that works really well throughout the first half. Add to that Jogi's eccentric and outspoken family for whom nothing he does or gets is good enough. From his mother (Zarina Wahab) to his younger sisters - they're all a bunch of ungrateful pricks but you can tell there's an underlying thread of love that basically binds them as family. Their love-hate equation makes for an entertaining watch. Dimple's family is a little less dramatic except her dadi, who hasn't let age dim her wit or charm of doling out unwanted advice or butting in when least required. All of this generates good comedic moments and organic humour. But as the second half rolls, the screenplay becomes slightly repetitive and unnecessarily convoluted. It feels like the makers have run out of new ideas before a predictable climax.

Nawazuddin is good as always but we're so used to seeing him in powerful and completely out-of-the-box characters that watching him play a regular guy-next-door takes some getting used to. Neha Sharma looks good and carries off her role confidently. Although, some more depth in the way her character is written would have helped. Mahaakshay Chakraborty is a surprise package as the demure groom-to-be Lallu, who is a total pushover.

There's no dearth of talented character artists here. Sanjay Mishra does his best to deliver in a small and insignificant role. Zarina Wahab and the rest of the ladies are a hoot as strong opinionated women in deeply patriarchal families. The setting of a small town as explored in many films no longer feels novel but is still endearing to watch. While there are all kinds of cliches, there is an inherent goodness in the simplicity and harmlessness of these characters. The soundtrack of the film is easily forgettable.

Overall, 'Jogira Sara Ra Ra' doesn't offer great novelty to its audience but manages to keep you entertained with quite a few moments of unadulterated fun.

Chidiakhana Movie Review

Review: Almost a decade after Dil Dosti Etc (2007) and Issaq (2013), director Manish Tiwary's latest offering Chidiakhana is a coming-of-age story of an underdog who makes a mark by following his passion and tenacity for football. The tone of this 114-minute film is lighthearted, and the dialogues are pedestrian but funny in parts. The story follows Sooraj (Ritvik Sahore), a Bihari boy who addresses the camera

a Bihari boy who addresses the camera directly and shares his life adventures. Sooraj's migration to Mumbai with his mother, Bibha (Rajeshwari Sachdev), exposes him to school gangs that restrict him from pursuing his passion, football. Further, his world turns topsy-turvy when he discovers he cannot play football since the ground lease has expired



and the government has given it to the builders. Predictably, he snatches a win by taking up a challenge to save the ground for children.

While the first hour of this film is timepass, the second half loses steam because of its repetitive narrative style. Also, you know from the beginning that this new boy in town would initially have obstacles but will soon be welcomed by everyone in his school and chawl. The section of the story about getting sports intermingled with other subplots concerning Bibha's past, Sooraj's competition in the gang, especially Babu (Jayesh Kardak), a football player-turned-local goon, Pratap (Prashant Narayanan), who assists and even trains Sooraj—feels banal and adds a little dimension to the film.

Ritvik Sahore perfectly adapts the demeanour of his character Sooraj, who is naive and quite centre-forward in both life and football. Avneet Kaur brings a breath of fresh air to the film as Sooraj's crush, Mili. Rajeshwari Sachdev delivers a decent performance as Sooraj's mother, although her character's past could have been explored more effectively. Prashant Narayanan's positive role as Pratap Bhai is a surprising and welcome change. The rest of the cast also contributes to pushing the narrative forward.

Director Manish Tiwary, who shares writing credits, too, presents a simple tale with a twisted angle of protagonists perceiving animals in humans, possibly to justify the film's title, Chidiakhana. However, this twist doesn't bring anything fresh or compelling to the screen for viewers.




