**Rolex Grab & Run in Westchester
August 29, 2013**

The Mount Kisco New York Police Department is investigating the theft of a Rolex Watch from a retail jeweler in Mount Kisco. The subject in the attached bulletin met with the store manager, and requested to see and try on a Rolex valued at \$37,550. After trying the watch on, the subject fled the store on foot with the watch and entered a waiting vehicle. Vehicle described as possibly a red, 2 door, Nissan or Honda.

Suspect Description:

Black male, 6'2"-6'3" approx. 190-210 lbs., with a tattoo of unknown writing on right forearm.
Female subject pictured in bulletin is believed to have entered the store minutes prior to the male subject, and conducted counter surveillance.
