19 Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as  
20 follows:

21 1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which  
appointed Peter S. Davis as Receiver of DenSco Investment Corporation (“Receivership  
Order”).

2. Pursuant to *Order Re: Petition No. 1*, the Court approved the Receiver’s  
compensation at the rate of \$250.00 per hour together with all reasonable costs and expenses

1 incurred relating to these services as Receiver. These services are billed by and paid to the  
2 Receiver's firm, Simon Consulting, LLC.

3         3. Pursuant to this Court's *Order Re: Petition No. 1*, the Receiver has engaged the  
4 services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the  
5 Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services  
6 of the firm together with all reasonable costs and expenses incurred on behalf of the Receiver.

7         4. Pursuant to this Court's *Order Re: Petition No. 10*, the Receiver has engaged  
8 the services of the law firm of Frazer Ryan Goldberg & Arnold, LLP of Phoenix, Arizona and  
9 the Receiver has agreed to pay the law firm compensation at agreed hourly rates for the  
10 service of the firm together with all reasonable costs and expenses incurred on behalf of the  
11 Receiver.

12         5. Pursuant to the Court's *Order Re: Petition No. 2*, the Receiver is authorized to  
13 file this fee petition without including as exhibits the itemization of services rendered to, and  
14 costs incurred or expended on behalf of, the Receivership, provided that the fee petition  
15 includes a statement that anyone desiring additional information concerning the services and  
16 costs to be paid under the fee petition may obtain redacted information from the Receiver by  
17 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a  
18 written request specifying the additional information requested at least three (3) days prior to  
19 the date set for any hearing on the fee petition. The Court's *Order Re: Petition No. 2* further  
20 provides that upon request of the Court, the Receiver shall make available for in camera  
21

1 review by the Court the itemized statements and supporting documentation for the services  
2 and costs to be paid under the fee petition.

3         6.       The Receiver has submitted an itemized statement for services rendered to this  
4 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable  
5 costs incurred or paid during the period December 1, 2017 through December 31, 2017. The  
6 total amount requested for payment by the Receiver is \$18,689.00. The Receiver believes  
7 that the professional fees and expenses of \$18,689.00 are reasonable and should be paid from  
8 the Receivership Assets.

9         7.       The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized  
10 statement for services rendered to this Receivership and for reimbursable costs incurred or  
11 paid during the period from December 1, 2017 through December 31, 2017. The total  
12 amount requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is  
13 \$30,032.46. The Receiver believes that this amount is reasonable and should be paid from  
14 the Receivership Assets and has therefore approved this statement for payment.

15         8.       The law firm of Frazer Ryan Goldberg & Arnold, LLP, has submitted an  
16 itemized statement for services rendered to this Receivership during the period December 1,  
17 2017 through December 31, 2017. The total amount requested for payment by the law firm  
18 of Frazer Ryan Goldberg & Arnold, LLP is \$7,840.29. The Receiver believes that this  
19 amount is reasonable and should be paid from the Receivership Assets and has therefore  
20 approved this statement for payment.

1. The amount of \$18,689.00 for Simon Consulting, LLC, for services rendered to the Receivership during the period from December 1, 2017 through December 31, 2017;

2. The amount of \$30,032.46 to Guttilla Murphy Anderson, P.C., for services rendered to the Receivership during the period from December 1, 2017 through December 31, 2017; and

8           3.       The amount of \$7,840.29 to Frazer Ryan Goldberg & Arnold, LLP, for services  
9 rendered to the Receivership during the period from December 1, 2017 through December 31,  
10 2017.
