You will need to be registered in advance and provide proof of identification. You may make application for an absentee ballot by mail, in person, e-mail or through MyVote.wi.gov. The deadline to make application by mail is 5 p.m. on Thursday, March 31, 2022. You may also request and vote an absentee ballot in person in the clerk's office staring Tuesday, March 22, 2022 by appointment during the hours of 10 a.m. to 4:30 p.m., Monday through Friday and weekends by appointment, with the last day being Sunday, April 3, 2022. You can conduct an Open Book session by phone or email with the assessor during regular business hours (Monday – Friday, 8:00 AM to 4:30 PM). You may call anytime but no later than 3 days prior to the Board of Review to conduct your Open Book meeting. If the assessor is not available at the time of your call, they will make every effort to return your call within 24 hours. • Board of Review, Thursday, May 19th, 5:00 p.m. – 7:00 p.m., Town Hall

The Board of Review is a local, quasi-judicial body that has duties relating to the valuation of real and personal property for purposes of taxation. The board will hear and determine objections to property assessments, among other duties. The board consists of the Chairperson, the two supervisors and the clerk. After speaking with the assessor, if you still believe your tax assessment for your property is incorrect, you can appear before the board and make your case. You would obtain the objection form from, and file it with, the clerk. Appointments are required. Please note; the assessor's valuation of your property is considered accurate unless you can PROVE otherwise.

REVALUATION 2023

The Town Board is in the process of renewing our 2022-2026 Maintenance Assessment Contract with Associated Appraisal Consultants, Inc. Along with this contract is the Revaluation Services Contract. This year will be the 5th year that the town will be out of compliance with the State's equalized value. If the town doesn't do the revaluation in 2023 the State will step in and do it for us and that would be much more expensive. The board is considering either an "Exterior" contract or an "Interior" contract. The name is also its description. The Exterior contract would utilize an evaluation form that the resident would complete to describe/rate the condition of the interior of their home along with an external evaluation. With the Interior Contract, assessment personnel would evaluate the interior of the home, by appointment, along with an external evaluation. The difference in price is: Exterior=\$27,000 and runs simultaneous with the 2022-2026 contract for maintenance services which is an additional \$4,800; Interior=\$30,000 plus \$4,800 for the simultaneous maintenance contract. We currently have \$35,000 budgeted for this expense.

POSSIBLE SOLAR FARM IN MAPLE CREEK???

The board was approached by/has been in contact with Derek Buss, Senior Business Developer with Avangrid Renewables, Chicago Illinois, regarding the construction of a possible solar farm in Maple Creek. There is <u>not</u> a whole lot of information right now and is still in the <u>planning/inquiry</u> stage. Here's what we do know:

- They are looking at a 200 +/- megawatt farm. This would require approximately 1500 acres of land and the acres don't have to be contiguous, but preferred. They are contacting land owners for interest.
- According to County Zoning, solar facilities 100 megawatt or larger are exempt from local zoning (town or county) and are regulated by the Public Service Commission. The PSC would conduct any public hearings, etc. This is exactly what happened with the ATC lines that went in years ago. Basically, the town cannot stop this project if 100mw or over. The State regulates them.
- Avangrid, Inc.is a US utility that is 81.5% owned by the Spanish Company, Iberdrola, S.A. They provide energy services in 27 states from New England to the West Coast and employs 6800.
- The acreage MAY be too far from the power station off of Hintzke Road and would require a small transmission station. The company cannot confirm whether the ATC lines could/would utilize their power, though. Therefore, the logistics of transmitting the power is a factor.
- They have/offer a "Good Neighbor" agreement which compensates any adjacent home owners to the project which includes a large upfront payment and annual payments throughout the life of the project. Some of you may have already been contacted by someone from the company.
- Mr. Bus stated that the State of Wisconsin requires a tax of \$400,000 for every 100mw farm. If this is 200mw, the tax would be \$800,000 of which the town would receive 1/3 or approximately \$266,666. I have not confirmed this with the State however.

Mr. Bus recommended that we put his information in the newsletter, so here it is; <u>Derek.Bus@avangrid.com</u> or 971-346-0090. Call him for more information. The Town Board wanted to set up a public hearing this month but Mr. Bus stated that he doesn't have enough information to report. Again, this project is in <u>very early stages</u>

and may never come to fruition. Meanwhile, you can do your own research. The largest solar farm in the Midwest is called the "Badger Hollow" solar farm down in Iowa County in the Southwestern part of the State. There's a lot of information on the web regarding solar farms; pro and con.

DEPUTY CLERK HIRED!

The Board hired Amiee Stracy as Deputy Clerk last November. She has been working closely with the clerk, learning the ropes, so to speak. Amiee is interested in running for the Clerk's position next April, 2023. She and her husband Tom and daughter Evelyn have lived in Maple Creek on Hintz Road for 3 years. She has prior experience in insurance and, currently, in addition to the Town, is working for DHS as an RN at an acute psychiatric facility.

CEMETERY

Then next cemetery commission meeting is being proposed for Monday, April 4th starting at 6:30 p.m. Please watch the website for the official date. A new zero turn riding lawnmower is being purchased this year. <u>Reminder</u>....Winter decorations must be taken down by April 15th. Spring decorations can be put up after that date.

RAFT PERMITS

It's that time of year when the rafts will go out. Maple Creek has a raft permitting ordinance which states; "Any person mooring, placing, or maintaining a fishing raft on the Wolf River and its tributaries, within the Town of Maple Creek shall register <u>each</u> fishing raft annually with the municipality in which the fishing raft will be most frequently moored." All registrations expire on December 31st of each year. Please contact the clerk for your raft permit, and Joe Close, for inspection at 920-572-2943. The total cost of the permit is \$30.

DOG LICENSES

All dogs 5 months of age in 2022 and older, need to be registered by April 1, 2022. You can license your dog at tax time. Proof of a current rabies vaccination is required. Licenses are \$8, but are reduced to \$3 for a spayed or neutered animal. Fines will be tacked on starting April 1st. If you have further dog licensing questions, please contact the treasurer.

TOWN HALL RENTAL

The Town Hall is once again available to be rented. The fee is \$100, with \$50 refunded if the hall is cleaned up and put back in its original condition. Contact the clerk for the form.

MISCELLANEOUS INFORMATION

• Effective January 1st, 2022 Outagamie County will be changing how they process and issue Shoreland Grading & Filling permits, converting (in most cases) permit issuance from a Conditional Use Permit (CUP) to an administrative permit. This change is being made after reviewing what typical operating procedures are for counties throughout the state, and based on feedback from internal departments, town public works/community development departments, the County Zoning Committee and other stakeholders.

The procedures for submitting Shoreland–Grading/Filling permits as of January 1, 2022 are as follows:

- Apply for a Shoreland Grading/Filling Permit on our applicant portal: https://cityview.outagamie.org/
- Select "Apply for a Zoning Permit"; log-in and select "Shoreland Grading/Filling"
- Complete all steps & upload required documents
- Pay Fee: \$450.00
- The Wisconsin Help for Homeowners (WHH) program provides housing grants to owner-occupied households who have experienced a COVID-19 related financial hardship, based on income level. Financial hardship is defined as: A material reduction in income or material increase in living expenses associated with the coronavirus pandemic that has created or increased a risk of mortgage delinquency, mortgage default, foreclosure, loss of utilities or home energy services, or displacement for a homeowner. Eligible types of expenses under this program may include but *are not* limited to: mortgage and interest payments, real estate taxes, condominium and association fees. The property must be the owner's primary residence. Vacation homes, rentals, cabins, and second homes are ineligible for assistance through WHH. A working draft of the state plan is <u>available for review</u>. Two public hearings were held on August 31. <u>Watch the recording here</u>. To get notified when the WHH program goes

live, fill out a contact form through Take Root Wisconsin or sign up for the Badger Bounceback enewsletter.

• WIS 76 Project Notice—The WisDOT is in the process of developing plans for proposed improvements on WIS 76 from the WIS 54 to US 45 in the towns of Bovina, Liberty, Maple Creek and Deer Creek and within the Villages of Bear Creek and Shiocton. WisDOT has updated the WIS 76 design project website that outlines all the project improvements and possible impacts. The website includes a project handout, maps, exhibit and the ability to provide comments.
