Page 13 ARTICLE VIII – TEAM ROPING G. State Finals:

Option 1

ARTICLE VIII –TEAM ROPING G. State Finals

1. A member must compete in at least four (4) M.R.A. Approved jackpots in the current year to be eligible (qualified) for State Finals. A member must compete in that division on that side (Header or Heeler) to be eligible (qualified) for State Finals. Positions cannot be moved from one side (Header or Heeler) to the other.
2. The amount of added money the M.R.A. adds per division to the State Finals will be based on the amount of run money collected throughout the year. A minimum of 25% of the total run money collected in that division will be added to the State Finals roping.
3. The State Finals roping format will be determined by the divisions Year End Championships are awarded in.

Option 2

ARTICLE VIII- TEAM ROPING G. State Finals:

1. The top fifteen (15) headers and the top fifteen (15) heelers in each division will rope with each other at the State Finals roping. Ropers can only enter once unless they are in the top fifteen (15) of the year end standings on each side (Heading & Heeling) after the final regular season roping prior to the State Finals roping. Finals positions cannot be moved from one side (Header or Heeler) to the other. If a member in the top fifteen (15) does not enter the State Finals roping by the close of entries or is not qualified (competed in four (4) or more M.R.A. - 14 - roping's for the current year) for the State Finals these positions will be filled by qualified members starting with position sixteen (16) and going down until fifteen (15) positions are filled for the finals.

2. A member must compete in at least four (4) M.R.A. Approved jackpots in the current year to be eligible (qualified) for State Finals.
3. The Board of Directors will determine the specific format of the State Finals Roping.
4. The amount of added money the M.R.A. adds per division to the State Finals will be based on the amount of run money collected throughout the year in that division. A minimum of 25% of the total run money collected in that division will be added to the State Finals roping.
5. To obtain a State Finals position at any jackpot there must be two (2) or more teams entered.
6. The State Finals roping format will be determined by the divisions Year End Championships are awarded in.

Page 4 Article II -

D. Annual dues of members will be payable as of the first Wednesday following Labor Day. No points or State Finals positions will be awarded unless dues are paid. (New membership and annual dues are published on each bulletin issued.).

Page 14. Article VIII Section H. #4

- 1) Championship divisions shall be as follows
 - A) Open
 - B) 10pt or 11pt (either of these would be fine to be determined by vote of membership)
 - C) 8pt
 - D) Novice (Heading and Heeling)

This would make our ropings consistent, in that all would offer the same divisions. It would also keep the points within that division there by eliminating carry over from one division to another. Lastly what other roping associations award their champions like our current system?

Page 14. Article VIII Section H. #4

- 1) Championship points will be determined as follows
 - 1st Place 6X No. of teams in that round.
 - 2nd Place 5X No. of teams in that round.
 - 3rd Place 4X No. of teams in that round.
 - 4th Place 3X No. of teams in that round.
 - 5th Place 2X No. of teams in that round.
 - 6th Place 1X No. of teams in that round.

The average would be doubled.

- 1st Place 12x No. of teams.
- 2nd Place 10X No. of teams.
- 3rd Place 8X No. of teams.
- 4th Place 6X No. of teams.
- 5th Place 4X No. of teams.
- 6th Place 2X No. of teams.

This would take the IRS out of our affairs. This would allow contractors to set entries and payoff as they see fit without affecting the points awarded. All rounds matter. I realize this would add to secretary duties, I apologize.
