**POWER OF ATTORNEY Department of the Treasury U.S. Customs Service 141.32 CFR 19**

hereby appoint HEDLEY'S INC AND GLENN WITKIN DBA QUALITY INTERNATIONAL CUSTOMS BROKER THROUGH ANY OF ITS LICENSED OFFICERS AND ANY EMPLOYEES SPECIFICALLY AUTHORIZED TO ACT FOR SUCH CORPORATION BY POWER OF ATTORNEY FILED BY THE CORPORATION WITH THE DISTRICT DIRECTOR OF CUSTOMS, as a true and lawful agent and attorney of the grantor named above for and in the name, place, and stead of said grantor from this date and in all Customs District(s) and in no other name to make, endorse, sign, declare, or swear to any entry withdrawal, declaration, certificate, bill of lading, or other document required by law or regulation in connection with the importation, transportation, or exportation of any merchandise shipped or consigned by or to said grantor; to perform any act or condition which may be required by law or regulation in connection with such merchandise; to receive any merchandise deliverable to said grantor.

To make endorsements on bills of lading, conferring authority to make entry and collect drawback, and to make, sign, declare, or swear to any statement, supplemental statement, schedule, supplemental schedule, certificate of delivery, certificate of manufacture, certificate of manufacture and delivery, abstract of manufacturing records, declaration of proprietor or drawback entry, declaration of exporter on drawback entry, or any other affidavit or document which may be required by law or regulation for drawback purposes, regardless of whether such bill of lading, sworn statement, schedule, certificate, abstract, declaration, or other affidavit or document is intended for filing in said district or in any other customs district.

To sign, seal, and deliver for and as the act of said grantor any bond required by law or regulation in connection with the entry or withdrawal of imported merchandise or merchandise exported with or without benefit of drawback, or in connection with the entry, clearance, lading, unloading or navigation of any vessel or other means of conveyance owned or operated by said grantor, and any and all bonds which may be voluntarily given and accepted under applicable laws and regulations, consignee's and owner's declarations provided for in section 485, Tariff Act of 1930, as amended or affidavits in connection with the entry of merchandise.

To sign and swear to any document and to perform any act that may be necessary or required by law or regulation in connection with the entering, clearing, lading, unloading, or operation of any vessel or other means of conveyance owned or operated by said grantor.

Authorize other Customs Brokers duly licensed within the territory to act as grantor's agent: to receive, endorse and collect checks issued for Customs duty refunds in grantor's name drawn on the Treasurer of the United States: If the grantor is a non-resident of the United States, to accept service of process on behalf of the grantor.

And generally to transact at the customhouses in said district(s) any and all customs business, including marking, signing, and filing of protests under section 514 of the Tariff Act of 1930, in which said grantor is or may be concerned or interested and which may properly be transacted or performed by an agent and attorney, giving to said agent and attorney full power and authority to do anything whatever requisite and necessary to be done in the premises as fully as said grantor could do if present and acting, hereby ratifying and confirming all that the said agent and attorney shall lawfully do by virtue of these presents; the foregoing power of attorney to remain in full force and effect until the (7) until revoked day of \_ or until notice of revocation in writing is duly given to and received by the District Director of Customs of the said district(s).

We hereby, waive the right to receive direct billing of all customs brokerage from GLENN WITKIN dba QUALITY INTL FRT FWDRS & CUSTOMS BROKERS. as per 19 CFR 111.36©(2)(i): and contrary to 19 CFR 111.24, we authorize GLENN WITKIN dba QUALITY INTL FRT FWDRS & CUSTOMS BROKERS to share all customs related information with HEDLEY'S, INC, our freight forwarders and freight agents. However, if required, we will retain the right to contact GLENN WITKIN dba QUALITY INTL FRT FWDRS & CUSTOMS BROKERS QUALITY INTL FRT FWDRS & CUSTOMS BROKERS directly regarding any customs related matter as per 19CFR 111.36©(3).

**Section 111.29(b)(I) CFR 19**

If you are the importer of record, payment to the broker will not relieve you of liability for customs charges (duties, taxes, or other debts owed U.S. Customs) in the event charges are not paid by the broker. Therefore, if you pay by check, Customs charges may be paid with a separate check payable to the "U.S. Customs Service" which can be delivered to Customs by the broker.
