District 7 Meeting Minutes
December 6, 2018 - 6:30 p.m.
Dudley-Gendron American Legion Post, Sutton

Call to Order – 19:00 by Chairman Belsito Pledge of Allegiance 36 in attendance from 14 Towns/Cities and 1 Organization and Chaplains

CHIEF UPDATES: Chairman Belsito gave updates on the chief changes in the district, including Dudley Asst. Chief Paul Konieczny and Charlton Deputy Chief Jason Cantara.

Treasurer and Secretary Report

MEMA: Kristen Jerome: They have boxes of sandbags at Headquarters if anyone wants some let her know.

DCR: D7 Warden Roy Liard is not home, he will e-mail a DCR update.

GUEST PRESENTATION: Dr. Miller and Dr. Sabato gave a presentation on their initiative, through UMass, *Prescription CPR Collaborative Project*. They are trying to save lives with the project which utilizes bystander CPR and Dispatcher assisted CPR. The MA survival rate now is 4% and the national average is 8%. Less than 1% get CPR before EMS arrives. They found people remember as much with a 2-minute program or a 2-hour program. They are working on speeding up State 9-1-1 protocols. They are also working on getting a high-risk patient's family to learn CPR. The doctors would like to partner with District 7 communities to get the message out about Hands Only CPR. They would like Massachusetts to rival Seattle with results. Just a "handshake" with UMass is needed to start the program.

Chief Adam Lavoie: Comm. Team met to review the new FC-1, it was well attended, it's a huge asset to the District. The Comm. Committee met with the Team Leaders yesterday. The team is requesting safety vests, they would like 12 (6 on each truck). They also requested to purchase frequency identifiers, two at \$70 each. They would like Identification cards for all members.

Chief Coleman thought we should have capital plan for district equipment, maybe every 2 or 3 years a capital fee for each town, to support things each town couldn't do on their own.
