### Registration:

All Suters must stop at the registration table and sign the waiver and receive other information relative to the event before setting up their tents.

The registration table will be open on Friday from 2:30 pm to 9 pm, on Saturday from 7 am to 9 am & Sunday from 8 am to 9 am. If you arrive after that time, please find a staff member at the mansion to register you.

### Parking:

All vehicles should be out of the Sutler area before 9 am on Saturday and Sunday. We will tow vehicles left in the paved lot after 9 am if they are not identified as handicapped. Vehicles must be parked in the Visitor Parking Lot near the Information Tent.

### Prohibited Items for Sale:

No selling of gunpowder-loose or in pre-rolled cartridges.

Children should not purchase arrows or weapons without their parent's permission.

### Site Responsibilities:

All quiet at 11 pm. We will not allow noise to disturb the nearby community. Please be considerate (This includes music).

Please be responsible for your own area, and dispose of garbage properly in the dumpster.

**No pets.** This is not only a site rule, but a courtesy to all the participants.

**Do not bring firewood to the site.** Pennypacker Mills offers plenty of free firewood.

No alcoholic beverages are permitted on county property. Anyone not conducting themselves in a proper manner will be asked to leave.
